SUBJECT: Assessment of Agency Expenses for Public Utility Commission Section 248 Proceedings SFY2022

The Vermont Agency of Agriculture, Food and Markets must participate in proceedings for an electric generation facility that will have a capacity greater than 500 kilowatts and will be sited on a tract containing primary agricultural soils. It also has the right to appear and participate in other proceedings before the Public Utilities Commission.

The Agency's participation in Public Utilities Commission proceedings is solely funded through allocating expenses to an applicant. In accordance with 30 V.S.A. § 21 *Particular proceedings and activities; assessment of costs*; the Agency is required annually, on or before January 15, to report the total expenses due to its participation in a Public Utilities Commission proceeding allocated to an applicant during the previous fiscal year. The report must include the name of each applicant or company to whom expenses were allocated and the amount allocated to each applicant or company. This report fulfills those requirements and provides the assessment of Agency Section 248 expenses for State Fiscal Year 2022.
