

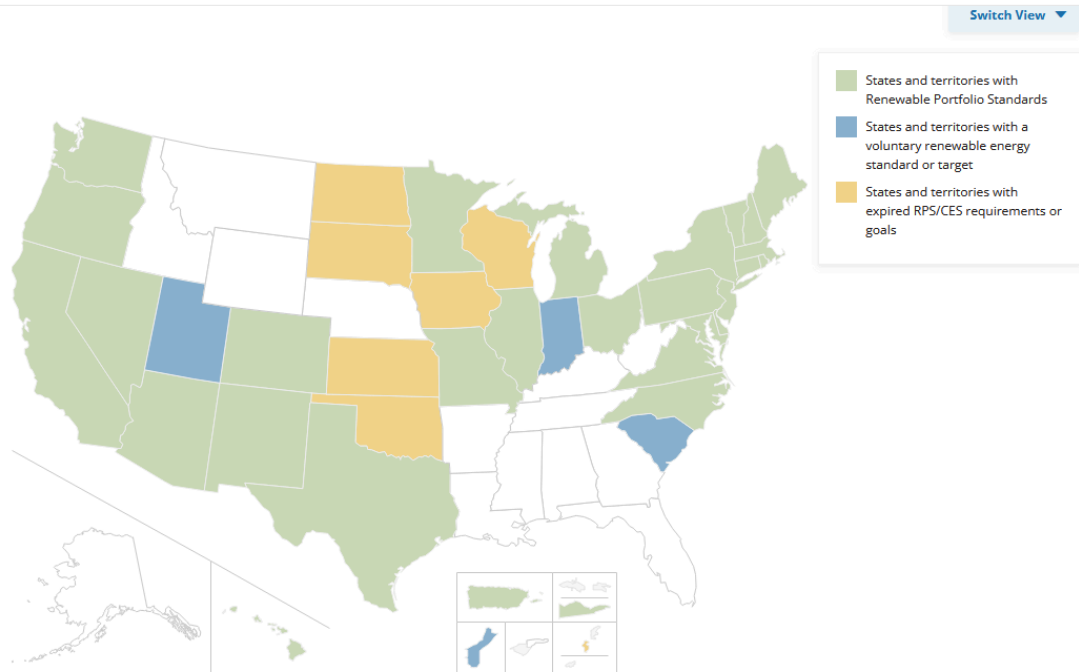
Rep. Laura Sibia - H.289 testimony for Ways and Means

Legislative Working Group: Act 33 of 2023 creates the Legislative Working Group on Renewable Energy Standard Reform is created to draft legislation to be considered by the General Assembly during the 2024 Legislative session.

“On or before July 15, 2023, the Joint Fiscal Office may retain the services of one or more independent third parties **to provide facilitation and mediation services** to the Working Group, and **data analysis recommendations** at the direction of the legislative members.”

“The Department of Public Service **shall** be invited to advise the Working Group on the **results of its ongoing public process to review the Renewable Energy Standard** and any other items as needed.”

Coming out of this work and leading into the session this group developed a consensus position that builds off the existing RES - a standard which has encouraged our regulated utilities towards long term power purchasing contracts by our regulated utilities rather than the dependence on volatile fossil fuel spot markets that has driven costs in many other states. Vermont has the second lowest electric rates in New England.

This consensus proposal is:

- An agreement between utilities, environmental advocates and renewable industry which takes into account the DPS work which members participated in. This bill respects the priorities that Vermonters identified affordability, reliability, and reducing carbon emissions. It does this by:
 - Tailored to each utility
 - Increases resilience by increasing distributed renewable generation
 - Specifically provides new offsets for old net metering renewables (except for our investor owned utility) which is especially beneficial to our most rural utilities as they work to harden the grid
 - Keeps existing renewable generation definitions in place and requires new load growth to be met with new renewables and storage
 - Eliminates offsite group net metering. And requires DPS, Utilities and Affordable Housing Community to report back on how to ensure a replacement renewable energy program for affordable housers
 - Includes reporting language on meeting the goals of the RES that was requested by DPS
