Disaster Unemployment Assistance (DUA)

• DUA is a federal program designed to help people who lost their jobs because of a natural disaster. This program gives temporary benefits to those who don't qualify for regular unemployment benefits.



DUA Eligibility

- Individual has a week of unemployment following the date of the major disaster.
- The individual is unable to reach his/her place of employment.
- The individual was scheduled to start work and the job no longer exists.
- The individual became the major support because the head of household died as a direct result of the disaster.
- The individual cannot work because of an injury caused as a direct result of the disaster.







Disaster Unemployment Assistance (DUA) Step by Step Process:



YOU ARE LAID OFF OR UNABLE TO WORK DUE TO THE FLOOD

If you are unable to access work or your employer has laid you off, you can apply for unemployment insurance benefits.

APPLY FOR REGUALR UNEMPLOYMENT INSURANCE (UI)

Apply for regular UI to determine eligibility first. Visit the online initial claim portal at labor.vermont.gov.


You MUST submit your DUA application within 30 days from the date indicated on www.labor.vermont.gov

FILE YOUR WEEKLY CLAIM


You must file weekly for DUA benefits to continue receiving payment.


Individual Assistance and Public Assistance (Categories A - G

DUA Timelines

- Application Deadlines:
 - First 6 Counties = August 21, 2023
 - Caledonia & Orange = August 25, 2023

- Eligible for UP TO 27 Weeks
 - First Week of Eligibility = Week Ending July 15, 2023
 - Last Week of Eligibility = Week Ending January 13, 2024




UI Stats – As of July 25
