6 Statement of purpose of bill as introduced: This bill proposes to adopt

7 miscellaneous proposals to enhance workforce and economic development

9 An act relating to enhancing workforce and economic development  
10 opportunities

11 It is hereby enacted by the General Assembly of the State of Vermont:

12 \* \* \* Education Workforce; Forgivable Loan Incentive Program \* \* \*

13 Sec. 1. 16 V.S.A. chapter 87, subchapter 6 is added to read:

14 Subchapter 6. Forgivable Loan Incentive Programs

15 § 2871. VERMONT TEACHER FORGIVABLE LOAN INCENTIVE

16 PROGRAM

17 (a) As used in this section:

18 (1) “Corporation” means the Vermont Student Assistance Corporation

19 established in section 2821 of this title.

1           (2) “Eligible individual” means an individual who satisfies the eligibility  
2           requirements under this section for a forgivable loan.

3           (3) “Eligible school” means an approved postsecondary education  
4           institution as defined under section 2822 of this title.

5           (4) “Forgivable loan” means a loan awarded under this section covering  
6           tuition, which may also include room, board, and the cost of required books  
7           and supplies for up to full-time attendance at an eligible school.

8           (5) “Program” means the Vermont Teacher Forgivable Loan Incentive  
9           Program created under this section.

10          (b) The Vermont Teacher Forgivable Loan Incentive Program is created  
11          and shall be administered by the Corporation. The Program provides  
12          forgivable loans to students enrolled in an eligible school who commit to  
13          working as a teacher in a Vermont public school and who meet the eligibility  
14          requirements in subsection (d) of this section.

15          (c) The Corporation shall disburse forgivable loan funds under the Program  
16          on behalf of eligible individuals, subject to the appropriation of funds by the  
17          General Assembly for this purpose.

18          (d) To be eligible for a forgivable loan under the Program, an individual,  
19          whether a resident or nonresident of Vermont, shall satisfy all of the following  
20          requirements:

21               (1) be enrolled in teaching program at an eligible school;

1           (2) maintain good standing at the eligible school at which the individual  
2           is enrolled;

3           (3) agree to work as a teacher in Vermont employed directly by a public  
4           school located in Vermont for a minimum of one year following licensure for  
5           each year of forgivable loan awarded;

6           (4) have executed a credit agreement or promissory note that will reduce  
7           the individual’s forgivable loan benefit, in whole or in part, pursuant to  
8           subsection (f) of this section, if the individual fails to complete the period of  
9           service required in this subsection;

10           (5) have completed the Program’s application form, the Free  
11           Application for Federal Student Aid (FAFSA), and for Vermont residents, the  
12           Vermont grant application each academic year of enrollment in accordance  
13           with a schedule determined by the Corporation; and

14           (6) have provided such other documentation as the Corporation may  
15           require.

16           (e) Students attending an eligible school in Vermont shall receive first  
17           priority for forgivable loans.

18           (f) If an eligible individual fails to serve as a teacher in a Vermont public  
19           school for a period that would entitle the individual to the full forgivable loan  
20           benefit received by the individual, other than for good cause as determined by  
21           the Corporation, then the individual shall receive only partial loan forgiveness

1 for a pro rata portion of the loan pursuant to the terms of the interest-free credit  
2 agreement or promissory note signed by the individual at the time of entering  
3 the Program.

4 (g) There shall be no deadline to apply for a forgivable loan under this  
5 section. Forgivable loans shall be awarded on a rolling basis as long as funds  
6 are available, and any funds remaining at the end of a fiscal year shall roll over  
7 and shall be available to the Corporation in the following fiscal year to award  
8 additional forgivable loans as set forth in this section.

9 (h) The Corporation shall adopt policies, procedures, and guidelines  
10 necessary to implement the provisions of this section, including maximum  
11 forgivable loan amounts. The Corporation shall not use more than seven  
12 percent of the funds appropriated for the Program for its costs of  
13 administration and may recoup its reasonable costs of collecting the forgivable  
14 loans in repayment.

15 Sec. 2. VERMONT TEACHER FORGIVABLE LOAN INCENTIVE

16 PROGRAM; APPROPRIATION

17 In fiscal year 2024 the amount of \$2,500,000.00 is appropriated from the  
18 General Fund to the Vermont Student Assistance Corporation for forgivable

1 loans through the Vermont Teacher Forgivable Loan Incentive Program  
2 created in 16 V.S.A. § 2871.

3 Sec. 3. PEER REVIEW SUPPORT GRANT PROGRAM; REPORT

4 (a) Purpose. The purpose of this section is to encourage and support the  
5 development and retention of qualified and effective Vermont educators. To  
6 combat the growing educator shortage throughout the State and meet the needs  
7 of Vermont students, it is necessary to invest in nontraditional educator  
8 training programs.

9 (b) Grant program.

10 (1) Program creation. In fiscal year 2024, there is established the Peer  
11 Review Support Grant Program, to be administered by the Agency of  
12 Education, to provide grants to expand support, mentoring, and professional  
13 development to prospective educators seeking licensure through the Agency of  
14 Education’s peer review process, with the goal of increased program  
15 completion rates.

16 (2) Program administration. The Agency shall adopt policies,  
17 procedures, and guidelines necessary for implementation of the Program  
18 described in subdivision (1) of this subsection.

19 (3) Eligibility criteria. The Agency shall issue grants to organizations or  
20 school districts with programs designed to provide prospective educators in the

1 peer review program the support necessary for successful completion of the  
2 peer review process by providing:

3 (A) support through the Praxis exam process;

4 (B) local, educator-led seminars designed around the Vermont  
5 licensure portfolio themes;

6 (C) local educator mentors;

7 (D) support in completing the peer review portfolio and licensing  
8 process; and

9 (E) continued professional development support within the first year  
10 of licensure.

11 (4) Report. On or before January 15, 2024, the Agency of Education  
12 shall report to the Senate and House Committees on Education on the status of  
13 the implementation of the Peer Review Support Grant Program and a summary  
14 and performance review of the programs to which grants were awarded. The  
15 report shall include any metrics used in the performance review, the number of  
16 program participants, endorsement areas of participants, feedback from  
17 participants and mentors, and any recommendation for legislative action.

18 Sec. 4. TEACHER LICENSING FEES; SUSPENSION

19 (a) Notwithstanding any provision of law to the contrary, teacher licensure  
20 fee requirements under 16 V.S.A. § 1697(a) are suspended during fiscal years  
21 2024–2029.

1        (b) In fiscal year 2024, the estimated fees that would have been collected  
2        under 16 V.S.A. § 1697(a) shall be accounted for through an appropriation to  
3        the Agency of Education from the General Fund.

4        Sec. 5. TEACHER LICENSING PORTABILITY

5        In order to address demand for qualified teachers and a declining educator  
6        workforce, on or before January 1, 2024, the Agency of Education shall issue a  
7        written report to the House and Senate Committees on Education, the House  
8        Committee on Commerce and Economic Development, and the Senate  
9        Committee on Economic Development, Housing and General Affairs assessing  
10       the costs and benefits of participation in licensure reciprocity agreements and  
11       licensure compacts for teachers. In writing the report, the Agency shall consult  
12       the Standards Board for Professional Educators and other interested  
13       stakeholders.

14       Sec. 6. PEER REVIEW SUPPORT GRANT PROGRAM; APPROPRIATION

15       Notwithstanding 16 V.S.A. § 4025(d), the sum of \$712,500.00 is  
16       appropriated from the Education Fund to the Agency of Education in fiscal  
17       year 2024 for the purpose of funding the Peer Review Support Grant Program  
18       established by Sec. 2 of this act.

20       Sec. 7. 16 V.S.A. § 2181 is added to read:

21       § 2181. VERMONT CAREER TECHNICAL EDUCATION STUDENTS

1       The Colleges shall give preference in admissions to eligible students who  
2       are residents of the State and who have completed a career technical education  
3       program in a subject matter or industry that the Colleges offer programming in.

6       Sec. 9. VERMONT SERVE, LEARN, AND EARN PROGRAM;

7                       APPROPRIATION

8       In fiscal year 2024, the amount of \$2,400,000.00 is appropriated from the  
9       General Fund to the Department of Forests, Parks and Recreation to continue  
10       funding through the pilot project the Vermont Serve, Learn, and Earn Program,  
11       which supports workforce development goals through creating meaningful  
12       paid service and learning opportunities for young adults, through the Serve,  
13       Learn, and Earn Partnership made up of the Vermont Youth Conservation  
14       Corps, Vermont Audubon, Vermont Works for Women, and Resource VT.  
15       The Department shall enter into a grant agreement with the Partnership that  
16       specifies the required services and outcomes for the Program.

17       Sec. 10. ADULT EDUCATION AND LITERACY; APPROPRIATION

18       In fiscal year 2024 the amount of \$1,500,000.00 is appropriated from the  
19       General Fund to the Agency of Education for adult learning services.

21       Sec. 11. CLIMATE WORKFORCE EDUCATION CAMPAIGN;



1                   ADVANCE VERMONT: APPROPRIATION

2                   (a) Advance Vermont shall create a three-year climate workforce-focused  
3                   public education campaign that engages current and prospective employees,  
4                   Vermont youth, adults interested in changing careers, and individuals yet to  
5                   earn a postsecondary credential, or those who are looking to upskill.

6                   (b) The campaign shall include:

7                   (1) targeted external communications to support awareness of climate  
8                   pathways in Vermont, including partnership and collaboration with direct  
9                   service organizations;

10                  (2) engagement through workshops, webinars, and trainings;

11                  (3) information about climate sector career and education pathways  
12                  through centralized and easy to access resources, such as MyFutureVT.org and  
13                  other websites and applications; and

14                  (4) video series and other media featuring opportunities with employers

1       (a) In fiscal year 2024 the amount of \$180,000.00 is appropriated from the  
2       General Fund to the Vermont Sustainable Jobs Fund for a three-year period to  
3       expand its Business Coaching program to focus on working with a group of  
4       existing energy services businesses interested in adopting a climate-centered  
5       mission and working with a group of younger trades people looking to start  
6       their own climate-centered business.

7       (b) The Fund shall recruit a cohort of up to twelve existing companies and  
8       a cohort of up to twelve trained tradespeople to receive advanced business  
9       assistance to enable them to either pivot their existing business or start a new  
10       business that will expand the State’s ability to deploy renewable energy and  
11       efficiency technologies to more homes and businesses across the State.

17       General Fund to the University of Vermont to increase the number of  
18       Psychiatric Mental Health Nurse Practitioners and expand access to mental  
19       health and substance abuse providers in this State.

5 In fiscal year 2024 the amount of \$1,500,000.00 is appropriated from the  
6 General Fund to the Vermont State University to establish a Certificate in 3-D  
7 Technology program offered as a full-time, six-week, intensive residential  
8 summer program at the Randolph and Castleton campuses, which will:

9 (1) offer knowledge and hands-on experience that appeals to a wide  
10 range of interests from science and engineering to the arts and humanities;

11 (2) position students for greater success in college and with an  
12 employable edge upon completion;

13 (3) attract diverse types of learners from high schools and CTE centers;

5       need, including early childhood occupation, clinical mental health counseling,

1        (b) Outreach. The contractor may use funds awarded by the State to:

2            (1) create and distribute public-facing communications and resources  
3 related to the duties described in this section; and

4            (2) offer support to career and education counselors, employment and  
5 training counselors, jobseekers and their families, and other stakeholders,  
6 consistent with best practice and State policy and programs, to help them better  
7 understand the postsecondary education and training landscape.

8        (c) Reports. The contractor shall provide written reports to:

9            (1) the Vermont Department of Labor and Agency of Education about  
10 anticipated work and activities using a simplified reporting template jointly  
11 developed by the contractor and the State entities on a quarterly basis; and

12            (2) on or before December 15, 2023, the House and Senate committees  
13 of jurisdiction regarding the use of funds, activities performed, and outcomes

13           § 2. RURAL BUSINESS TECHNICAL ASSISTANCE EXCHANGE

14           (a) There is created the Rural Business Technical Assistance Exchange, a  
15           business assistance program through which the regional development  
16           corporations shall provide small- and mid-sized businesses with professional  
17           and technical assistance:

18                            (1) through in-house Business Navigators;

19                            (2) through partnerships with organizations specializing in outreach to  
20           historically underserved populations; and

1           (3) through grants to private providers for professional services,

2           including:

3                   (A) business operations, financial management, and grant writing;

4                   (B) digital strategies;

5                   (C) architecture and physical space design;

21                   (B) must have at least \$5,000.00 in average annual revenue.

1           (4) A business whose owner’s income is higher than the federal labor  
2           market area in which the business operates shall provide a 50 percent match for  
3           the costs of professional services funded by a grant.

4           (c) The regional development corporations shall operate the Exchange to  
5           produce benefits for both the client companies as well as the vendors providing  
6           the assistance, and to expand the capabilities of the regional development  
7           corporations to serve an even larger portion of the rural business community,  
8           including historically underserved populations.

9           (d) The regional development corporations shall publish a report on the  
10           activities and performance of the Exchange on or before January 15 and July  
11           15 each year.

2 § 6. RURAL INDUSTRY DEVELOPMENT GRANT PROGRAM

3 (a) Creation; purpose.

4 (1) A Rural Industry Development Grant Program is created within the  
5 Agency of Commerce and Community Development to provide grant funding  
6 through local development corporations for business relocation and expansion  
7 efforts, including the purchase, demolition, and renovation of property for  
8 industrial use.

9 (2)(A) There is established a Rural Industry Development Special Fund  
10 comprising amounts appropriated to the Fund, contributions from other  
11 sources, and the return of principal from the sale of any property invested  
12 through the Program.

13 (B) Monies in the Fund shall be available to Agency to make grants  
14 through the Program to assist local development corporations with business  
15 relocation and expansion efforts throughout Vermont.

16 (C) Notwithstanding any provision of law to the contrary, interest

3           (2) the ability of the proposed project to meet the site-specific needs of  
4           businesses considering whether to expand or locate in this State;

5           (3) the funding that the applicant has identified, or secured, to leverage a  
6           grant award; and

7           (4) the readiness of an applicant to move a project forward.

8           (c) Eligible applicants; priority.

9           (1) To be eligible for a grant, an applicant must be a local development  
10           corporation, as defined in subdivision 212(10) of this title, located within this  
11           State.

12           (2) The Secretary of Commerce and Community Development may  
13           designate projects and agreements as first priority based on rural communities  
14           who continue to experience insufficient economic and grand list growth as per  
15           the rural index.

16           (d) Eligible activities. A grant recipient may use funding for the following:

17           (1) to purchase land for potential industrial use;

18           (2) for the costs of site development, permitting, or providing  
19           infrastructure for property the recipient owns;

1           (3) for the equity investment required for a loan transaction through the  
2           Vermont Economic Development Authority under 10 V.S.A. chapter 12,  
3           subchapter 3; or

4           (4) for the matching requirement of another State or federal grant  
5           consistent with this section.

6           (e) Application; market assessment.

7           (1) An applicant shall include in its application a local and regional  
8           market assessment that demonstrates reasonable need for the proposed
