It establishes the Rural Industry Development Special Fund for this purpose. Grants shall not exceed \$1,000,000 or 20 percent of the total project cost. The bill transfers \$10,000,000 from the General Fund in FY 2024 to the Rural Industry Development Grant Fund.
