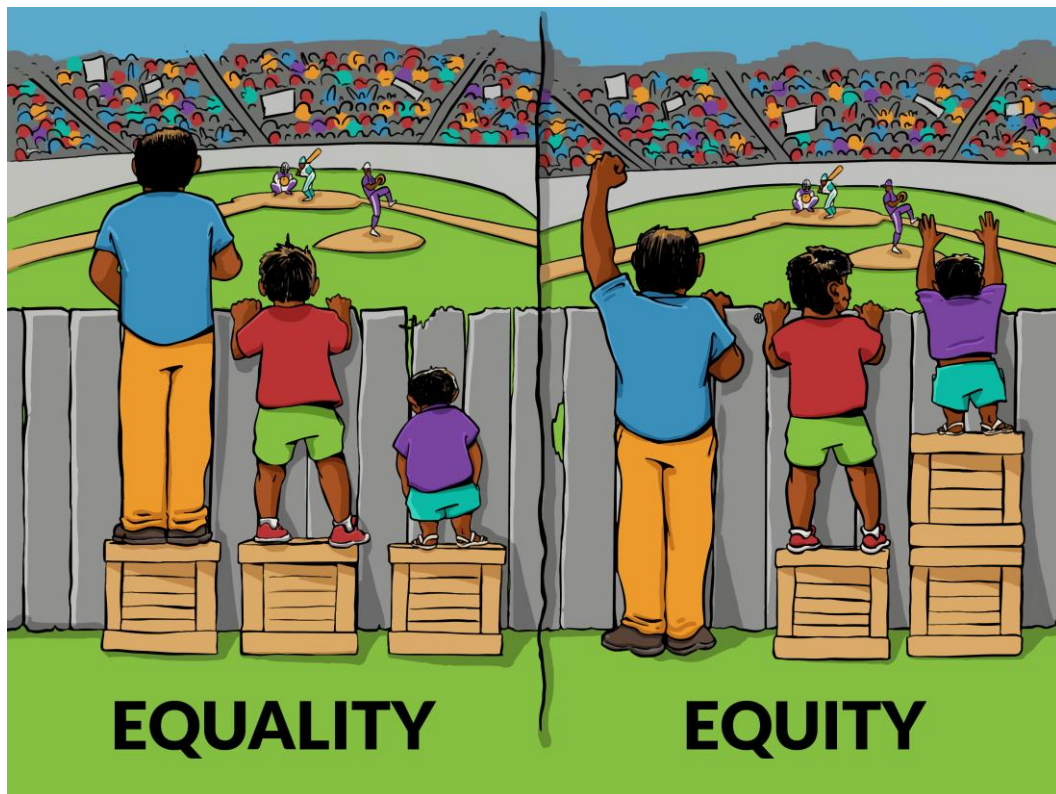


Simple Analysis of Vermont's American Rescue Plan Act (ARPA) Funds' Geographic Distribution

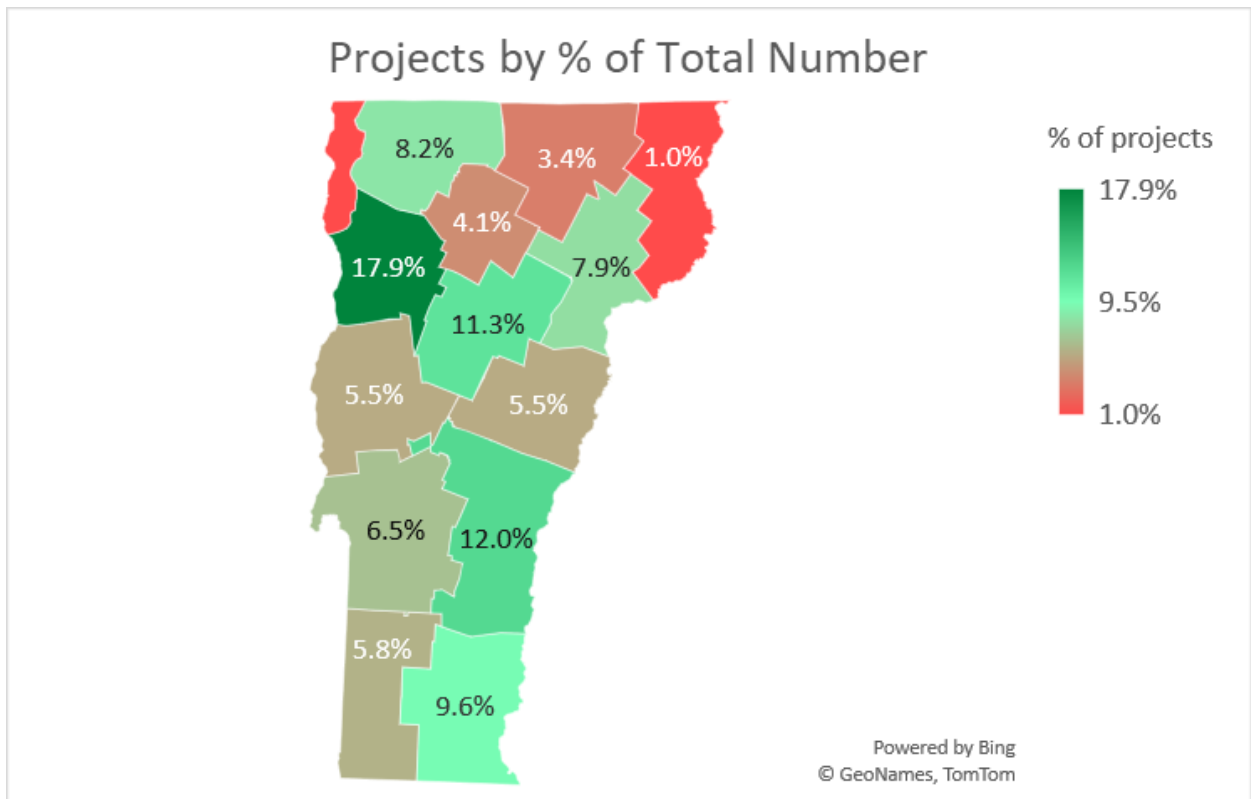
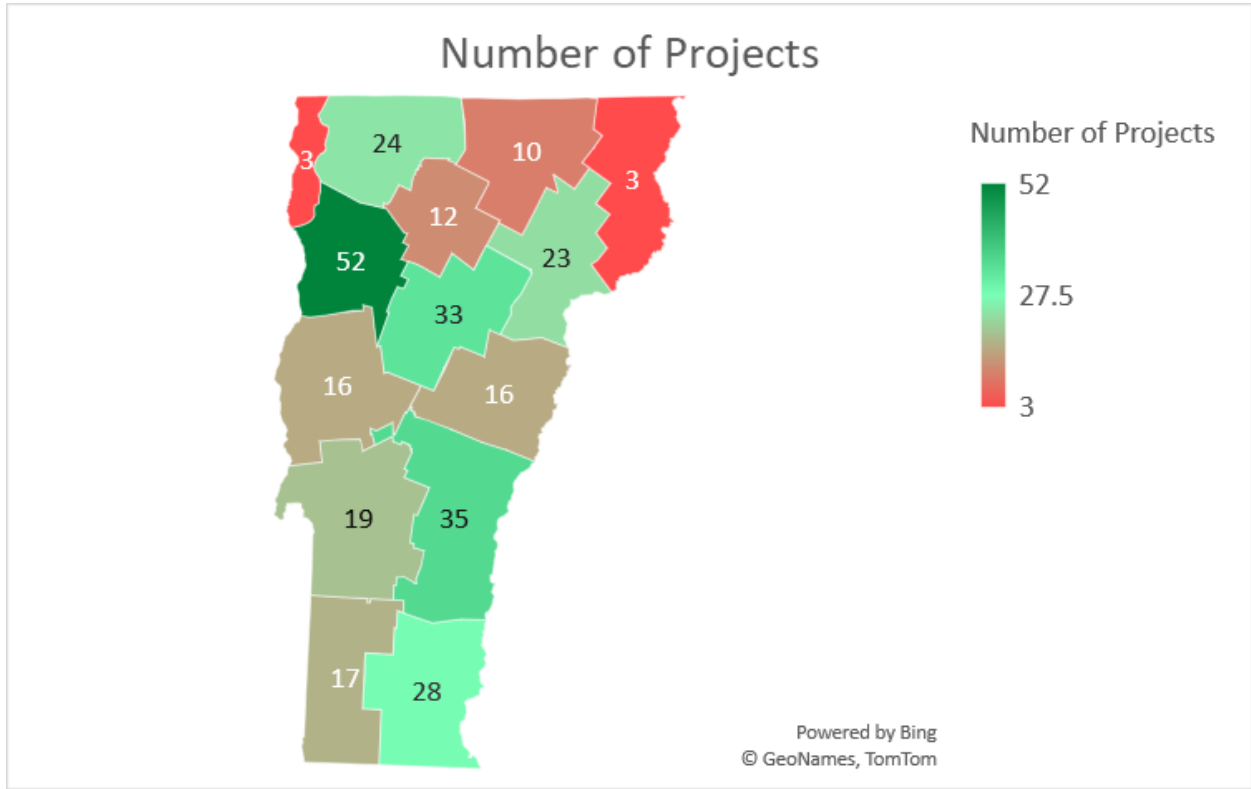
The following data analysis is from application-based programs created to administer American Rescue Plan Act funds. It does not include funds for broadband expansion nor funds that were regionally distributed to community organizations for programs meant for individual households, such as weatherization.

The following shows the regional distribution of funds and projects. Because communities and regions have different needs, the amount of funding or the number of projects alone is not a good metric. However, together they can be used as a relative high-level proxy for what counties are benefiting or missing out on these opportunities.

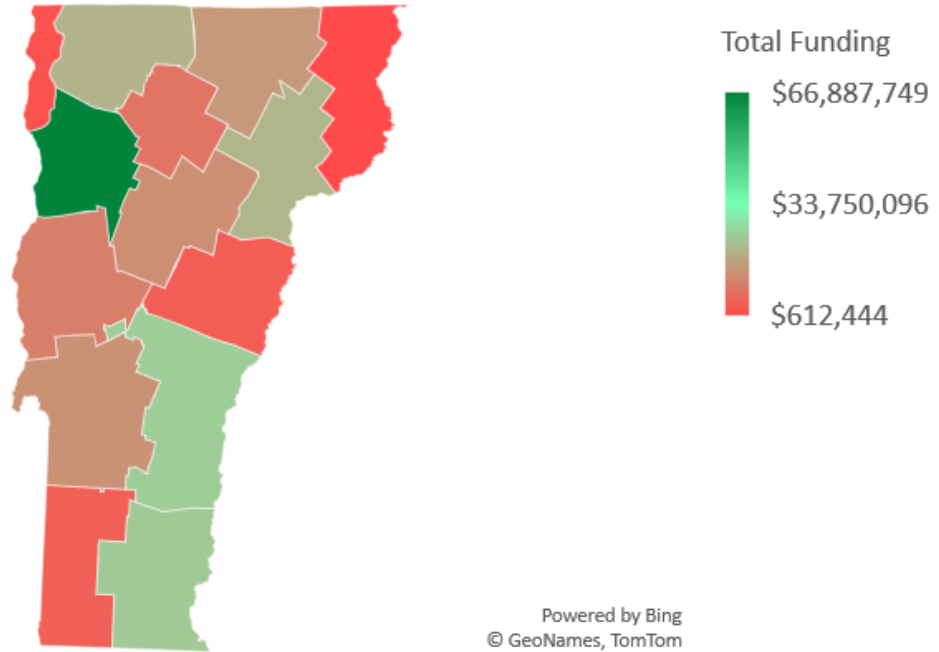

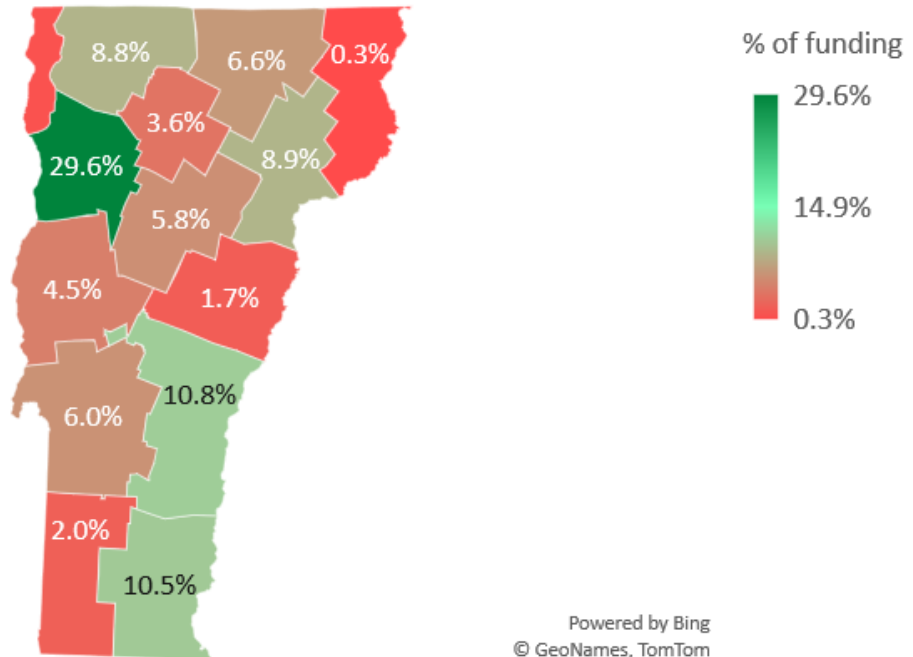
