What are the required statewide activities?

- Performance Reporting & Program Oversight
- Nondiscrimination Awareness and Compliance
- Rapid Response activities
- Developing and disseminating the following:
 - List of eligible training providers & registered apprenticeship programs (with performance information)
 - Information identifying eligible providers of on-the-job training (OJT), customized training, incumbent worker training internships, paid or unpaid work experience opportunities and transitional jobs
 - Information on effective outreach and partnerships with business;
 - Information on effective service delivery strategies and promising practices to serve workers and job seekers;
 - Information of physical and programmatic accessibility for individuals with disabilities;
- Conducting evaluations to promote continuous improvement, research and test innovative services and strategies, and achieve high levels of performance and outcomes.

- Carrying out activities described in the State Plan, including coordination and alignment of data systems used to carry out program requirements
 - Supporting the development of staff, including staff training to provide opportunities for individuals with barriers to employment to enter in-demand industry sectors or occupations and nontraditional occupations, and the development of exemplary program activities;
 - Supporting effective development, convening, and implementation of industry and sector partnerships;
 - Carrying out monitoring and oversight of activities for services to youth, adults, and dislocated workers
 - Operating a fiscal and management accountability information system, based on guidelines established by the Federal Government.
