In July 2021, regional Local Emergency Planning Committees (LEPC) were replaced with one statewide Local Emergency Planning Committee.














As noted in statute (Sec. 12. 20 V.S.A. § 6) Vermont Emergency Management will establish Regional Emergency Management Committees that

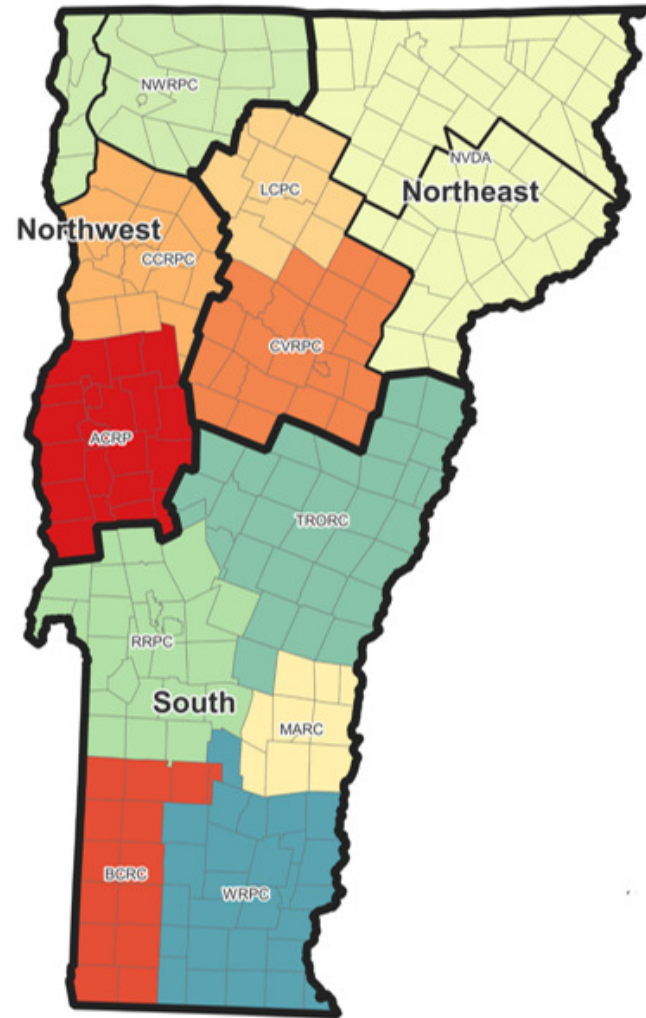
*“shall coordinate emergency planning and preparedness activities to improve their regions’ ability to prepare for, respond to, and recover from all disasters.”*

*Regional emergency management committees shall coordinate emergency planning and preparedness activities to improve their regions' ability to prepare for, respond to, and recover from all disasters.*

#### Responsibilities of each Regional Emergency Management Committee

- Coordinate and support regional all-hazards emergency management activities, including planning, training & exercising. Meet at least quarterly.
- Members shall develop and maintain a regional plan and submit it to their Vermont Emergency Management Regional Coordinator annually. This plan will describe regional coordination and regionally available resources.
- 1 individual, elected from each membership, shall represent the Regional Emergency Management Committee on the statewide Local Emergency Planning Committee. This individual will receive information about Hazardous Materials within their region and share it with Regional Emergency Management Committee members.
- 1 individual, elected from each membership, shall represent the Regional Emergency Management Committee in the Threat and Hazard Identification and Risk Assessment (THIRA) and Stakeholder Preparedness Review (SPR). This individual will report on the current capabilities and gaps in the region's response to threats/hazards.
- 1 individual, elected from each, shall represent the Regional Emergency Management Committee in the Integrated Preparedness Planning Workshop (IPPW). This individual will report on the plans, trainings, & exercises needed or planned for the region over the next 3 years.

# Quorum Language Change



## **Current**

Voting members - The local emergency management director or designee and one representative from each town and city in the region shall serve as the voting members of the committee.

Quorum is a majority

## **Proposed**

Proposing to lower regional emergency management committees' quorum requirements to five voting members until December 31, 2023 then permit a committee to subsequently vote to modify its quorum requirements upon initially meeting.
