Drug Charge Filings and Dispositions Using Court Data

This memo explores drug charge filings and dispositions in the Vermont Superior Court, Criminal Division from 2018 through November 2023.

Summary

- Heroin filings are down from their pre-pandemic levels.
- Cocaine filings and dispositions are rising back to their pre-pandemic levels.
- The most common crimes associated with drug charges are public order offenses.
- Property crimes are not often associated with drug charges.
- Cocaine is the most common drug charged with fentanyl cases, heroin cases, and the catchall depressant/stimulant/narcotic cases.

Figure 1 shows the number of charges filed by drug type and year. Cocaine filings are increasing while filings involving heroin are decreasing. Fentanyl charges are increasing. The fentanyl statute, 18 V.S.A. §4233a, was added in 2017. Vermont also has a catchall drug statute, 18 V.S.A. § 4234, which covers depressants, stimulants, and narcotics (DSN) not otherwise named in the drug laws. These filings are on the increase.

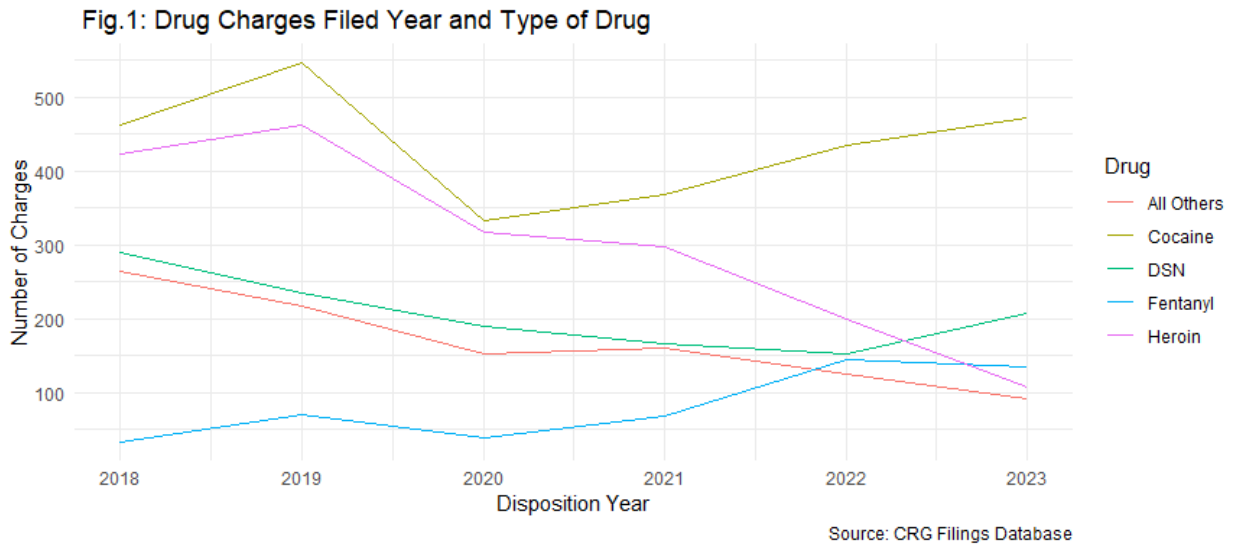
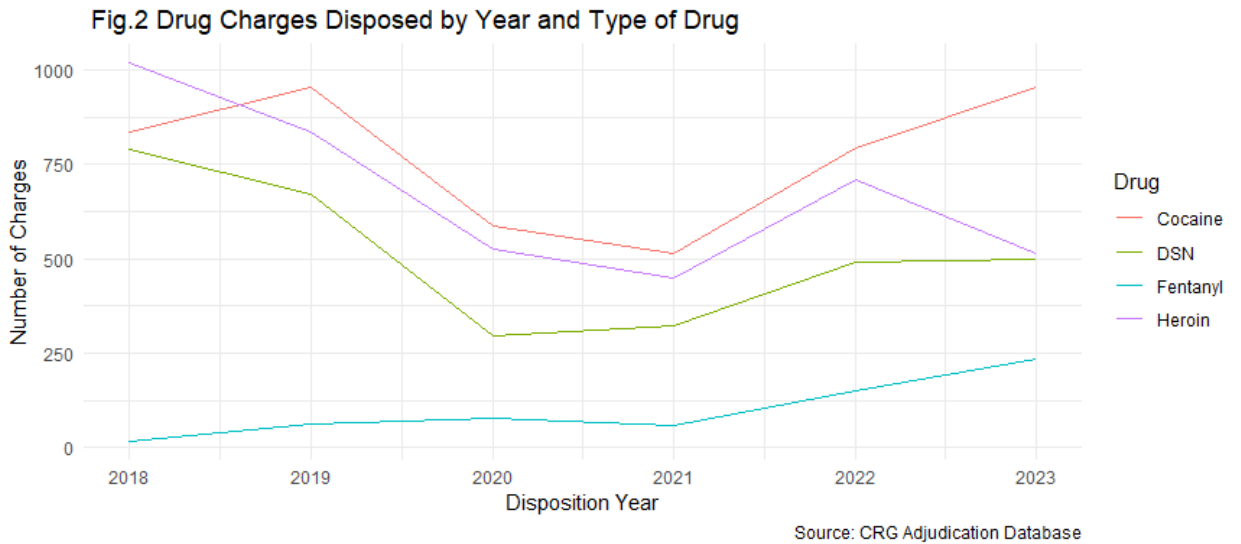


Figure 2 illustrates the types of drugs involved in charges disposed by year. The remaining tables in this memo describes charges disposed. Cocaine was the most common drug charge disposed.



Heroin Cases

From 2018-November 2023 4,047 charges were disposed of where at least one charge in the case was a violation of a subsection of 18 V.S.A §4233. Table 1 shows the other types of crimes that were on the cases with the heroin charges. The heroin charges were excluded from this analysis. Other drug offenses and public order offenses (e.g. Disorderly Conduct, Violation of Conditions of Release, Trespass) were the most common offenses charged with a heroin charge.

Table 2 shows that cocaine possession was the most common other charge involved in heroin cases, followed by the catchall statute.

Cocaine

Table 3 shows the other criminal charges filed with cocaine charges. As with heroin charges, other drug charges and public order offenses were the most common other charges. Charges involving weapons, including using during a felony and prohibited persons charges increased in 2022 and 2023 compared to prior years. There have been some changes in the firearms laws which may be affecting these numbers.
