Whereas, professionally, he devoted more than half a century to improving the lives of Vermont's educators and nonfaculty school staff, and

Whereas, in 1969, after a brief teaching stint in St. Albans, Norm Bartlett joined the staff of the Vermont Education Association (now VT-NEA) for an amazingly lengthy career that extended until May 31, 2021, and

Whereas, Norm Bartlett's first organizational role was as assistant executive director; then, in 1973, he became the VT-NEA's UniServ Director for the Northeast Kingdom; and, in 1987, he assumed a similar role for southern Vermont, and

Whereas, while at VT-NEA, Norm Bartlett diligently and successfully negotiated over 500 local school contracts, and

Whereas, although deeply dedicated to the cause of improving the pay and working conditions of all of Vermont's school personnel, Norm Bartlett also enjoyed an immensely busy life away from the bargaining table, and

Whereas, his broad range of hobbies included cooking, golfing, reading, sailing, and skiing, and

Whereas, numerous skiing adventures, both near and far away, were a highlight of his family's life, and

Whereas, the Bellows Falls Country Club benefited from his leadership as president as he established the Club's Thursday morning Gentlemen's League, and he also represented the Town of Putney on the governing board of Rescue Inc., the regional first-responder service, and

Whereas, Norm Bartlett's personally fulfilling life ended with his death on March 13, 2024 at 82 years of age, and his survivors include his wife, Kathleen, his children, and his grandchildren, now therefore be it

Whereas, Mike Taylor chairs the Vermont State Firefighters' Association's judging and awards committee, and

Whereas, his sons, Nick and Ian Taylor, of whom Mike and Sue Taylor, his wife of 45 years, are proud, have followed their father into the Department, and

Whereas, in a related role, Mike Taylor has served on the Bennington Rescue Squad's Board of Trustees, and

Whereas, Mike Taylor is hardworking, reliable, and always goes above and beyond the call of duty, and he is an ideal choice for this special recognition, now therefore be it

Whereas, annually, during the first full week in May, the American Nurses Association (ANA) and the ANA-Vermont celebrate and promote the nursing profession through the observance of National Nurses Week, and

Whereas, in 2024, National Nurses Week is May 6–12, and this commemoration is centered on the theme "Nurses Make the Difference," and

House concurrent resolution recognizing the importance of public awareness of tardive dyskinesia

Offered by: Representative Bartley of Fairfax

Whereas, tardive dyskinesia (TD) "is a persistent, involuntary movement disorder...characterized by uncontrollable, abnormal and repetitive movements of the face, torso, limbs, and fingers or toes," and

Whereas, 600,000 Americans are living with TD and nearly 65 percent of these individuals have not received a proper diagnosis, and symptoms of TD can impact individuals physically, socially, and emotionally, and

Whereas, the "prolonged use of antipsychotic medication that may be necessary to treat individuals living with mental illness[es]," such as bipolar disorder, major depressive disorder, schizoaffective disorder, and schizophrenia, can, in some cases, result in TD, and

Whereas, individuals who are taking any of these medications and are 55 years of age or older, have a substance use disorder, or are postmenopausal are more susceptible to contracting TD, and

Whereas, this illness may affect an individual's ability to sleep (64 percent); write or type, or both (48 percent); or eat or drink (37 percent), and

Whereas, in 2017, after extensive research, the U.S. Food and Drug Administration approved Ingrezza (valbenazine) as the first drug to respond to TD, and

Whereas, medical authorities stress how important it is that health care providers who prescribe an antipsychotic medication monitor the patient for possible indications of TD, and

Whereas, nationally, the first full week of May—this year occurring from May 5–11—is observed as Tardive Dyskinesia Awareness Week, and Governor Scott has recognized this important observance in the State of Vermont, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the importance of public awareness of tardive dyskinesia, and be it further

House concurrent resolution recognizing June 2024 as National Scoliosis Awareness Month in Vermont

Whereas, "Scoliosis is a sideways curvature of the spine that most often is diagnosed in adolescents," and

Whereas, although on occasion coinciding with "cerebral palsy and muscular dystrophy, the cause of most childhood [instances] of scoliosis is unknown," and

Whereas, "most cases of scoliosis are mild, but some curves worsen as children grow," and "[s]evere scoliosis can be disabling," and

Whereas, severely curved spines "can reduce the amount of space within the chest, making it difficult for [an individual's] lungs" to exercise the normal breathing functions, and

Whereas, careful monitoring is sufficient for those children with mild cases of scoliosis, but the more severe situations may require the wearing of a brace or corrective surgery to halt the worsening of the condition, and

Whereas, the purpose of National Scoliosis Awareness Month, which is observed annually in June, is "to highlight the growing need for public education [and] early detection and awareness" concerning this potentially serious and painful disease, and

Whereas, this annual event "unites scoliosis patients, families, physicians, clinicians, [health care and medical research] institutions and related businesses in collaborative [and mutually beneficial] partnerships," now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes June 2024 as National Scoliosis Awareness Month in Vermont, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Scoliosis Research Society and the Vermont Orthopaedic Society.

House concurrent resolution congratulating the JK Adams Co. of Dorset on its 80th anniversary

Whereas, JK Adams, Dorset's largest employer, was established on December 31, 1944, when founder Josiah Knowles Adams held an organizational directors' meeting at Barrow's House Inn in Dorset, and

Whereas, this Vermont firm "designs, manufactures and markets a line of customizable, functional, and high-quality wood products for the kitchen and home," and

Whereas, central themes for JK Adams are "rooted in nature, crafted for the home," and "the kitchen is the heart of the home," and

Whereas, in 1949, engineer and attorney Malcolm Cooper Sr. secured partial ownership in the company; in 1959, he bought out Josiah Adams; and, today, his son and grandsons hold corporate leadership roles in this family-owned business, and

Whereas, the Jones Garage in Dorset, today an office building, was the company's first production location, but, soon thereafter, JK Adams purchased the abandoned South Dorset icehouse, and this site, following early additions to the building, sustained a devastating 1962 fire that resulted in the construction of a new 22,000-square-foot metal structure, and after further expansion, this facility remains its manufacturing home, and

Whereas, over the decades, JK Adams has introduced new products and computerized production technology; opened the Kitchen Store, a retail facility, in Dorset; and has manufactured kitchen and homeware products for its own sales and those of other retailers, such as Crate & Barrel, Sur la Table, and Uncommon Goods, and

Whereas, JK Adams maintains a 19-acre plot of trees and forest that is subject to a forest-management plan; in 2009, it became the first company in its industry to earn Forest Stewardship Council certification; and, in 2022, the company became a Vermont State Benefit Corporation "expanding on its mission to sustainably craft heirloom products that nurture sharing food and connections, while investing in a culture of social opportunity and environmental responsibility," now therefore be it

Whereas, her life as a respected mental health counselor and administrator began in 1990 at Washington County Mental Health Services as an emergency services clinician on the mobile crisis team, and

Whereas, in 2005, Mary Moulton was promoted to the directorship of intensive care services where, to no one's surprise, she performed her duties magnificently; and, in 2010, she was deservedly named the organization's chief of operations, and

Whereas, in 2011, after Tropical Storm Irene devastated many Vermont communities, Mary Moulton's career at Washington County Mental Health Services was paused when State officials requested that she be granted a leave of absence to assume a leading role at the Department of Mental Health (the Department), initially as deputy commissioner and, subsequently, as commissioner, and

Whereas, Mary Moulton's primary mission at the Department was to oversee the implementation of 2012 Acts and Resolves No. 79, "An act relating to reforming Vermont's mental health system," and she supervised the development of law enforcement and crisis team training, a process in which she remains engaged, and

Whereas, in 2013, Mary Moulton became Washington County Mental Health Services Executive Director, and she has also coordinated the State's Behavioral Health Disaster Response Team, and

Whereas, in 2024, Mary Moulton is concluding her remarkable tenure at Washington County Mental Health Services, now therefore be it

Resolved by the Senate and House of Representatives:

Whereas, as a longtime and active member of the American Legion Post #13 and the Veterans of Foreign Wars, Michele Burgess was the ideal person to serve as the Home's liaison with the veterans' service organizations that support the Home's residents, and

Whereas, Michele Burgess's creativity, enabled the breadth of activities offered to the residents to be broadened, and they now include onsite events such as arts programs, bingo, exercise sessions, music groups, off-site trips to Lake Shaftsbury and Lake George, and special occasions, such as the Elks' dinner, the ladies' tea hour, and fishing derbies, and

Whereas, her initiative resulted in new support services, for example, providing golf carts—with which, as an avid golfer, she is familiar—to improve the residents' mobility, and

Whereas, Michele Burgess earned a wonderful place in the lives of the Home's residents, and her departure truly marks a farewell to a special friend, now therefore be it

Whereas, her reputation as a hard worker who was devoted to the veterans and their families was well-deserved, and she personally considered them as part of her family, and

Whereas, Barbara Reilly loved her work at the Home, rarely missed a day, and brought a sense of fun into the activities for which she was responsible, and

Whereas, gardening and attending musical events, at which she would dance and sing with the veterans, were especially pleasurable activities for her, and

Whereas, Barbara Reilly concluded her 42 years as a Vermont Veterans' Home employee in December 2019, now therefore be it

Whereas, the biblical concept of gleaning—allowing those in need of sustenance to gather the remnants of crops from harvested fields—has 21st-century agricultural and food security relevance, and

Whereas, a leading proponent and implementer of modern gleaning is Theresa Snow, a 2001 graduate of Sterling College, and she sharpened her farming knowledge while employed at Pete's Greens, the notable agricultural enterprise in Craftsbury, and

Whereas, in 2004, with the goal of teaching Vermonters about food, Theresa Snow piloted a gleaning project at Pete's Greens, and

Whereas, in 2005, under the fiscal umbrella of the Northeast Organic Farming Association of Vermont, she cofounded Salvation Farms "to reduce food loss on farms, increase the use of locally grown foods" and to "build increased resilience in Vermont's food system through agricultural surplus management," and

Whereas, while leading Salvation Farms, Theresa Snow was instrumental in establishing the following: the Vermont Commodity Program, a distributor of gleaned food crops to "charitable or institutional food sites"; a low-risk-offender gleaning project at the Southeast State Correctional Facility; the Pick for Your Neighbor orchard initiative in collaboration with the Vermont Food Bank; and a workforce development program for categories of persons who would experience difficulties securing employment, and she spearheaded the formation of the Vermont Gleaning Collective, and

Whereas, Theresa Snow was a founding member of the national organization known as the Association of Gleaning Organizations, and is a recipient of both the Vermont Businesses for Social Responsibility's Young Changemaker Award and the Ben & Jerry's Local Hero Award, and, in 2024, she is concluding her duties as Salvation Farms Executive Director, now therefore be it

Whereas, her involvement in community projects is a regular occurrence, and she always performs with no expectation of recognition but rather as her selfless response when a helping hand is required, and

Whereas, during the July 2023 flood, which resulted in extensive damage in the Town of Johnson, Lynda Hill stepped up to volunteer her time at the emergency operations center, the emergency shelter, and the donation center, and she even housed a town employee for a couple of days during the height of the crisis, refusing any form of reimbursement for her lodging services, and

Whereas, recognizing the importance of public education, Lynda Hill has served as a member of the Johnson School Board, and

Whereas, in 2022, seeking to contribute to the decision-making process for the operation of the municipal government, Lynda Hill successfully stood for election to the Town of Johnson Selectboard, her two-year term as a member of the municipality's legislative body was productive, and her municipal legislative service enhanced policy deliberations, and

Whereas, although Lynda Hill opted not to seek reelection in 2024, she will no doubt remain active in the civic life of Johnson, now therefore be it

H.C.R. 260

House concurrent resolution honoring the Tuskegee Airmen of World War II

Whereas, despite the racial restrictions that kept the U.S. Armed Forces segregated until 1948, from 1940 to 1946, the Tuskegee Airmen, the first U.S. Black military aviators, flew and fought valiantly during World War II, and

Whereas, their saga began when the 99th Pursuit Squadron was activated at Chanute Field in Rantoul, Illinois, on March 19, 1941; and, in June 1941, the squadron was transferred to Tuskegee Army Airfield in Alabama, and

Whereas, the Black airmen of the 99th were under the command of Captain Benjamin O. Davis Jr., one of only two Black U.S. Army line officers then serving, and

Whereas, in April 1943, the 99th was transferred to North Africa; assigned to the 33rd Fighter Group; flew its inaugural mission on May 30, 1943, attacking the small island of Pantelleria off the Italian coast; and the squadron subsequently flew combat missions over Sicily, and

Whereas, by January 1944, the 100th, 301st, and 302nd Fighter Squadrons of Tuskegee Airmen arrived in the war zone and were transferred to the 332nd Fighter Group, ultimately under the command of now-Colonel Benjamin O. Davis Jr., and

Whereas, the 332nd was stationed at the Ramitelli Airfield on Italy's Adriatic coast and initially conducted dive-bombing and strafing missions, and

Whereas, from June 1944 to March 1945, the 332nd escorted and protected the Fifteenth Air Force's heavy bombers flying over Nazi Germany, and when the 332nd was issued P-51 Mustang Fighters marked with red paint on the aircrafts' tails, the pilots became famously known as the Red Tails, and

Whereas, in total, the Tuskegee Airmen flew 15,533 combat sorties on 1,578 missions; 55 of the pilots were credited with destroying 112 German aircraft in the air; three Distinguished Unit Citations were awarded; 66 pilots were killed in action or accidents; and, overall, 150 died and 32 were captured and held as prisoners of war, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors the Tuskegee Airmen of World War II, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Friends of Tuskegee Airmen National Historic Site in Tuskegee, Alabama.
