Whereas, suicide is a serious mental health concern meriting special societal focus, and

Whereas, Umatter is an innovative suicide prevention program, and

Whereas, according to the Centers for Disease Control and Prevention, suicide is the third leading cause of death in the United States among persons between the ages of 10 to 24, and

Whereas, Umatter is based on the concept of multiple levels of suicide prevention starting with family and extending outward to friends, the community, and finally the larger society defined as the big picture, and

Whereas, the Vermont Suicide Prevention Coalition (VSPC), which implements Umatter, in association with the Center for Health and Learning, consists of representatives from public health, mental health, education, and youth leadership organizations, suicide advocacy prevention groups, Vermont 2-1-1, and suicide survivors, and

Whereas, the VSPC was established with financing from a federal Youth Suicide Prevention Grant, and its mission is to "create communities of hope throughout Vermont in which schools, agencies and people of all ages" are able to respond to instances of suicidal behavior, and

Whereas, VSPC is starting with the premise that suicide, regardless of the age group, is preventable, and

Whereas, among specific goals for the VSPC are increasing public awareness of the importance of addressing mental health issues, establishing a broad-based suicide prevention program in Vermont, sponsoring a social media campaign to reduce the stigma associated with using mental health services, and creating a five-year strategic plan to develop suicide prevention and early intervention programs, and

Whereas, Umatter also addresses short-term crisis scenarios urging individuals under stress to call 911, a local crisis hotline, the National Suicide Prevention Lifeline, or go to the nearest emergency room, and

Whereas, members of the Vermont Suicide Prevention Council are gathered today, February 14, 2014, at the State House to inform the General Assembly about the importance of suicide prevention education, now therefore be it

House concurrent resolution congratulating Mount Vernon Lodge No. 8 of Free and Accepted Masons in Morrisville on its bicentennial

Whereas, the Orange Lodge of Masons first met in Hyde Park on December 16, 1812, pursuant to the authority of the Grand Lodge of the State of Vermont of Free and Accepted Masons, and

Whereas, on October 12, 1813, the Grand Lodge issued a charter to the Orange Lodge as Mount Vernon Lodge No. 36, and its first regular communication, or meeting, was held on December 1st of that year, and

Whereas, from March 14, 1832 until December 16, 1850, anti-Masonic public attitudes caused some lodges to forfeit their charters, but the Mount Vernon Lodge persevered, meeting clandestinely and without recording any minutes, and

Whereas, on February 4, 1852, the redesignated Mount Vernon Lodge No. 8 convened in Morristown, and after several moves, including to Hyde Park, on March 26, 1863, it moved into the new Masonic Hall on the third floor of the Power's Block building in Morrisville, and

Whereas, on March 1, 1869, a fire destroyed the Masonic Hall, but fortunately, the lodge's records, aside from the original charter, were located elsewhere, and

Whereas, a duplicate charter was soon issued, and on June 24, 1870, the Mount Vernon Lodge No. 8's new permanent Masonic Hall was dedicated on the second floor of Town Hall in Morrisville, and

Whereas, an impressive centennial celebration was held in 1913, with Grand Lodge officers and many Masonic affiliated individuals from around the State in attendance, and

Whereas, on December 9, 1930, a new Masonic Lodge was dedicated at 65 Portland Street, which has remained in use to this day, and

Whereas, on June 11, 2008, the Mount Norris Lodge No. 69 in Eden, which was charted on January 12, 1865, merged with the Mount Vernon Lodge No. 8, and

Whereas, on October 12, 2013, the Grand Master of the Grand Lodge of the State of Vermont of Free and Accepted Masons rededicated the Masonic Lodge on Portland Street, in a beautiful and solemn celebration of Mount Vernon Lodge No. 8's bicentennial, now therefore be it

Whereas, the education proficiency gap between students from low-income households and other students is a significant problem, and

<u>Whereas</u>, studies have documented that students lose approximately two months of mathematics grade level equivalency each summer, and for students from low-income households, this annual knowledge loss extends to reading proficiency, and

Whereas, research has shown that up to two-thirds of the academic achievement gap between low-income and other students is attributable to unequal access to summer learning opportunities, and

Whereas, recent studies have demonstrated that consistent exposure to afterschool learning opportunities can narrow, and even eliminate, the mathematics achievement gap by the 5th grade, and

Whereas, more than 30,000 youths participate in Vermont's year-round afterschool and summer learning programs that offer innovative and engaging activities, and

Whereas, these programs offer students the opportunity to explore new ways of learning, to acquire new skills, and to form positive relationships with adults in the students' communities, and

Whereas, the afterschool and summer learning programs both complement and supplement classroom experiences, and the programs are conducted in close coordination with local schools, and

Whereas, through the outstanding work of Vermont Afterschool Inc., these academic activities are continuously improved to meet the latest best practices standards, and

Whereas, Vermont Afterschool Inc. offers professional development opportunities, including instruction in using individualized coaching models and participation in the STEM Learning Task Force, the Mentors for Quality Program, and an annual statewide conference, and

Whereas, today, February 20, 2014, educators, advocates, parents, and students are gathered at the State House to celebrate the success of afterschool and summer learning programs and to continue improving these important programs, now therefore be it

Whereas, among her other duties are serving as coordinator of the education support team and directing the after-school homework club, and

Whereas, since 2011, Katie Sedore has also taught English at the Granite Academy, an alternative education program that the Spaulding special education department established, and

Whereas, this outstanding teacher came to the attention of the Milken Family Foundation, which, since 1985, has presented the Milken Educator Award, and

Whereas, this award is intended for teachers who early in their careers have demonstrated impressive professional achievements and shown the promise of future accomplishments, and

Whereas, each winner is presented with a \$25,000 unrestricted cash award, and

Whereas, the Milken Foundation selected Katie Sedore to be a recipient of this "Oscar of Teaching," and she is an ideal winner of this prize, and

Whereas, at a special presentation ceremony, before the entire student body, Governor Shumlin made the surprise announcement, and even Tom Sedore was not informed in advance, now therefore be it

Hubert W. Vogelmann.

Whereas, the protection of Vermont's environment and natural beauty had no more passionate an advocate than Hub Voglemann, and

Whereas, his early life included an event of great daring, when, as a 17-year-old, he sailed on a Victory ship through a mine-filled Baltic Sea to deliver cattle to war-torn Poland, and

Whereas, the concern he demonstrated for his fellow human beings on that journey would translate into his life-long commitment to preserving the natural environment for future generations to enjoy, and

Whereas, Hub Vogelmann graduated from Heidelberg College, and earned a Ph.D. at the University of Michigan, and

Whereas, in 1955, the University of Vermont hired Hub Vogelmann as a botany professor, and his 36-year tenure included 16 years as chair of the botany department, and

Whereas, he was an admired and popular professor, and

Whereas, his international research adventures ranged from the Arctic to Mexico and the Amazon Basin, and

Whereas, in 1982, he warned that acid rain was causing severe damage to the forested slopes of Camel's Hump, and in 2000, the Hub Vogelmann Research Natural Area was dedicated at Camel's Hump State Park, and

Whereas, Hub Vogelmann established the Field Naturalist Program at the University of Vermont, and contributed to the development of Act 250, and

Whereas, Hub Vogelmann was a cofounder of the Vermont chapter of the Nature Conservancy, and he served on the boards of many State and national environmental organizations, and

Whereas, notable among Hub Vogelmann's numerous honors were his 1987 induction into the Vermont Academy of Arts and Sciences, and his honorary degree from the University of Vermont in 2006, and

Whereas, Hub Vogelmann, scholar, environmentalist, gardener, farmer, beekeeper, and great Vermonter, died on October 11, 2013, and his survivors include his dear companion, Mary Jane Dickerson, sons, Tom, Jim, and Andy, grandchildren, Scott, Connie, and Alice, and his brother, Stewart, now therefore be it
