9	Statement of purpose of bill as introduced: This bill proposes to prohibit
10	teachers and school administrators from striking and school boards from
11	imposing contracts and to require mandatory binding arbitration.

15	It is hereby enacted by the General Assembly of the State of Vermont:
16	Sec. 1. 16 V.S.A. § 2011 is added to read:
17	§ 2011. MANDATORY DETERMINATION BY THE VERMONT LABOR
18	RELATIONS BOARD
19	(a) If the parties' dispute remains unresolved as to any issue on the 15th
20	day after delivery of the fact-finding commission's report under section 2007
21	of this title or if the parties otherwise agree that they have reached an impasse,

1	then each party shall submit to the Vermont Labor Relations Board its last best
2	offer on all disputed issues, which shall be reviewed and decided upon as a
3	single package. The Labor Relations Board may hold hearings and may
4	consider the recommendations of the fact-finding committee, if one has been
5	activated.
6	(b) In reaching a decision, the Labor Relations Board shall give weight to
7	all relevant evidence presented by the parties, including:
8	(1) the lawful authority of the school board;
9	(2) stipulations of the parties;
10	(3) the interest and welfare of the public and the financial ability of the
11	school board to pay for increased costs of public services, including the cost of
12	<u>labor;</u>
13	(4) comparisons of the wages, hours, and conditions of employment of
14	the employees involved in the dispute with the wages, hours, and conditions of
15	employment of other employees performing similar services in public schools
16	in comparable communities or in private employment in comparable
17	communities;
18	(5) the average consumer prices for goods and services commonly
19	known as "the cost of living";

1	(6) the overall compensation currently received by the employees,
2	including direct wages, benefits, continuity conditions and stability of
3	employment, and all other benefits received; and
4	(7) the prior negotiations and existing conditions of other school and
5	municipal employees.
6	(c) Within 30 days of receiving the last best offers of the parties, the Labor
7	Relations Board shall select between the offers, considered in their entirety
8	without amendment, and shall determine the cost of its selection. The Labor
9	Relations Board shall not issue an order under this subsection that is in conflict
10	with any law or rule or that relates to an issue that is not bargainable. The
11	Labor Relations Board shall file one copy of the decision with the relevant
12	negotiations councils. Except as provided in subsection (e) of this section, the
13	decision of the Labor Relations Board shall be final and binding on the parties.
14	(d) The parties shall share equally all mutually incurred costs incidental to
15	this section.
16	(e) Upon application of a party, a Superior Court shall vacate an award on
17	the same grounds as set forth in 21 V.S.A. § 1733(d) and according to the same
18	procedures as set forth in 21 V.S.A. § 1733(e).
19	(f) Upon application by either party, a Superior Court may issue a
20	temporary restraining order or other injunctive relief and may award costs
21	including reasonable attorney's fees in connection with any action taken by a

1	representative organization, its officials, or its members or by a school board or
2	its representative in violation of this section, including engaging in a strike,
3	which shall have the same meaning as in 21 V.S.A. § 1722, and the imposition
4	of contractual terms.
