- (5) issues related to employment, including sick time, for those persons willing to be live donors of organs and tissue; and
- (6) other issues related to organ and tissue donation and transplantation.
- (d) The Working Group shall have the administrative, technical, and legal assistance of the Department of Health.

- (e) The Working Group shall submit a report on its findings and recommendations to the House Committees on Human Services, on Health Care, and on Transportation, the Senate Committees on Health and Welfare and on Transportation, and to the Governor by January 15, 2017. The report shall include a recommendation about whether the Department of Health should establish an ongoing advisory council on organ and tissue donation.
  - (f) The Working Group shall cease to exist on June 30, 2017 2020.
