Enclosed please find the 2015 Annual Report for the Agricultural Water Quality Enforcement Program, submitted in accordance with the Agricultural Nonpoint Source Pollution Reduction Program Memorandum of Understanding, entered into by the Agency of Natural Resources, Department of Environmental Conservation and the Agency of Agriculture on April 16, 1993.

Please note that this is a comprehensive enforcement report that includes inspections conducted to determine compliance with the Required Agricultural Practices (RAP) Regulations and Medium and Large Farm Operations permits. The report summarizes the efforts of five Field Agents that respond to small farm compliance issues, four Medium and Large Farm Operations Coordinators, a Small Farm Water Quality Inspector (a new position created in 2014), a state-wide CREP Coordinator (Conservation Reserve Enhancement Program), and the Agency's three full-time equivalent (FTE) Agricultural Engineers.

This year we have created an Appendix to the Annual report that presents our compliance and enforcement efforts in graphic form. We may use this Appendix as a stand-alone document that will provide a more easily "digestible" representation of our efforts over the past year.

The Vermont Agency of Agriculture, Food and Markets (VAAFM) implements a comprehensive approach to the regulation of farms in the State in order to best protect water resources. The development of a three-tiered approach to the regulation of Vermont farms allows for a logical progression in regulatory oversight as a farm grows in size from a Small Farm Operation (SFO) subject to regulation under the Required Agricultural Practices Regulations, to a Medium Farm Operation (MFO) regulated under the state's MFO General Permit, to a Large Farm Operation (LFO) regulated under an individual LFO permit.

On June 16, 2015, Governor Shumlin signed Act 64 – the Vermont Clean Water Act - into law, effectively amending and enacting multiple requirements related to water quality in the State. The act amended several provisions regarding agricultural water quality. The "accepted agricultural practices" (AAPs) were renamed the "required agricultural practices" (RAPs) and that term is used throughout this report. The RAPs are standards by which a farm must manage their agricultural operations. VAAFM has been charged to revise the RAPs by rule on or before July 1, 2016. The revised RAPs will include new or enhanced requirements for small farm certification, nutrient storage, soil health, buffer zones, livestock exclusion, and nutrient management.

The following report summarizes the Agency's enforcement and engineering/technical assistance efforts over the 2015 calendar year. The report summarizes the efforts of five Field Agents that respond to small farm compliance issues alongside their normal duties regulating pesticides, feed, seed and fertilizers; four Medium and Large Farm Operations Permit and Inspection Coordinators, a Small Farm Water Quality Inspector (a new position created in 2014), a state-wide CREP Coordinator (Conservation Reserve Enhancement Program), and the Agency's Agricultural Engineers which were staffed at three full-time equivalents (FTE) in 2015 but is now staffed at three FTEs through the Vermont Clean Water Act. In 2015, the Agency performed a total of 912 inspections/visits/surveys to farms to determine compliance with the Required Agricultural Practices Regulations, the Medium Farm Operation general permit, and the Large Farm Operation individual permits and to offer technical and engineering assistance. Inspections represent a formal inspection done on a farm to assess compliance with a rule and/or permit, visits are representative of technical assistance on the ground, and surveys are specific to a special assessment or project. In May 2015, the Agency launched the North Lake Farm Survey (NLFS), a pilot project designed to begin quantifying water quality needs by surveying livestock farm facilities located in the Missisquoi River Basin and St. Albans Bay watershed. VAAFM employees have surveyed over 250 facilities since the project launched in May, and have worked closely with farmers to assess their potential impact on water quality and help them to understand Vermont's water quality regulations. The project will continue until all identified livestock operations in the region have been reached.

As a result of these inspections/visits/surveys, a total of 26 farms received formal enforcement actions, two enforcement actions are pending, and 17 farms were referred to the Agency of Natural Resources for suspected direct discharges of wastes to surface water.

<u>RAP Compliance and Assistance</u>: In 2015, a total of 615 visits were made to small farms (SFO's). Of these, 339 inspections/surveys were conducted to assess compliance with the RAPs.

It is interesting to note that while the MFO and LFO programs are inspection-based compliance programs, the RAP enforcement program has also, over the years, been shifting steadily towards more of an inspection-based program as opposed to being driven solely by complaints from the public. In addition to the 339 inspections/surveys conducted on small farms, 276 visits were made to small farms to provide them with education and technical/engineering assistance to help them comply with water quality requirements.

As indicated in the attached investigation tracking summary table (Table 7), compliance check surveys were conducted to ensure compliance with the winter manure spreading ban. Each survey is logged as a single investigation, but each survey covers a number of farms in a given area. In 2015, 26 pre-winter spreading ban compliance checks covering approximately 230 farms were conducted to ensure that farmers were properly managing their manure, emptying their pits, and getting ready for the winter spreading ban. Once the ban was in effect, 12 compliance checks were conducted to ensure that no manure spreading was occurring during the winter spreading ban. These checks covered approximately 103 farms. So, while only 38 inspections are logged for these compliance check efforts before and during the ban, a total of 333 farms were found to be in compliance at the time of these checks.

As a result of compliance efforts conducted in 2015, 20 small farms received formal enforcement actions (this includes one case referred to the Attorney General's Office), and 10 small farms were referred to the Agency of Natural Resources for suspected direct discharges of waste to surface water.

<u>MFO General Permit Compliance</u>: In 2015, a total of 172 visits were made to Medium Farm Operations. Of these, 107 inspections/surveys were conducted on medium farms to assess compliance with the state's MFO general permit conditions.

Eight regulatory follow-up visits were made to farms that received enforcement actions to evaluate the farm's progress in coming into compliance with the general permit requirements. Sixty-five (65) visits to MFOs involved providing technical assistance to farmers that show interest and motivation to correct a potential violation identified through an inspection or to participate in the Conservation Reserve Enhancement Program (CREP). The Agency will perform multiple technical assistance visits to ensure a farm moves steadily towards achieving compliance. When a farmer is not showing a commitment to correct a potential violation, the Agency will pursue an enforcement action.

As a result of compliance efforts conducted in 2015, a total of four medium farms received formal enforcement actions, one enforcement action is pending, and four medium farms were referred to the Agency of Natural Resources for suspected direct discharges of waste to surface water.

<u>LFO Individual Permit Compliance</u>: In 2015, a total of 125 visits were made to Large Farm Operations. Of these, 60 inspections/surveys were conducted to assess a farm's compliance with their individual LFO permit and the LFO Rules.

NOTE: This table only addresses the inspections conducted to determine compliance with the RAPs and those inspections of MFOs and LFOs that either lead to the issuance of an enforcement action or were undertaken in response to complaints from the public (these investigations are summarized in Table 7). A number of inspections, such as surveys for compliance with the winter manure spreading ban, encompass more than one watershed. Therefore, the number of investigations on a watershed basis may exceed the absolute number of inspections conducted. The enforcement action taken is paired with the designation "SFO" for small farm, "MFO" for medium farm, and "LFO" for large farm. In some cases, field staff address and correct issues in the field without the need for a written enforcement action. These cases are referred to as "verbal".

(*) Tactical Planning Basins.

Under the VT Department of Environmental Conservation's (VT DEC) prior "Guidelines" approach to basin planning, it was envisioned that Basin Plans would be developed for the 17 unique planning watersheds in Vermont (used here in Table 4). While most of these basins reflect true watershed boundaries or logical watershed groupings (e.g., Winooski River, or Wells, Waits, Ompompanoosuc Rivers), others, such as Basin 4, 5, or 13, reflect neither watershed boundaries per-se, nor logical groupings of communities that share a sense of common attachment to surface waters. As such, the current Tactical Planning Process combines the prior 17 watershed areas into 15 revised planning basins. These regions are intended to ensure that small areas occurring outside of major planning watershed, but that share common landscapes, communities, and organizations are included in planning processes of maximum relevance to the citizens of those areas. To accomplish this, VT DEC's Watershed Management Division, using the tactical Planning Process, will develop plans that: 1) Parse the small lower Basin 16 (direct to CT River) subwatersheds with Basin 14 or 9 as appropriate, to create the Wells, Waits, Ompompanoosuc and Middle CT River Tactical Plan, and the White River Region Tactical Plan; 2) Parse the small Basin 13 subwatersheds with Basins 10, 11, and 12; 3) Merge Basins 2 and 4 to create the South Lake Champlain Basin Tactical Plan. The Agency of Agriculture will utilize these 15 basins when tracking and reporting on water quality enforcement cases in 2016.

Figure 1. In 2015, the Agency performed a total of 912 inspections/visits/surveys^(*) of farms to determine compliance with the Required Agricultural Practices (RAPs) Regulations, the Medium Farm Operation (MFO) general permit, and the Large Farm Operation (LFO) individual permits, and to offer technical and engineering assistance. Overall regulatory compliance rates are high for farms of all sizes and exceed 85%.

(*) In May 2015, the Agency launched the North Lake Farm Survey (NLFS), a pilot project designed to begin quantifying the impacts of agriculture on Lake Champlain by surveying farm facilities located in the Missisquoi River Basin and St. Albans Bay watershed. VAAFM employees have surveyed over 250 facilities since the project launched in May, and have worked closely with farmers to assess their potential impact on water quality and help them to understand Vermont's water quality regulations. The project will continue until all identified livestock operations in the region have been reached.




Figure 2. RAP Compliance and Assistance: In 2015, a total of 615 visits were made to small farms (SFO). Of these, 339 inspections/surveys were conducted to determine compliance with the RAPs.




Figure 3. As a result of SFO inspections conducted in 2015, 20 small farms received formal enforcement actions including one case referred to the Attorney General's Office, resulting in a regulatory compliance rate of 86%.




Figure 4. MFO General Permit Compliance: In 2015, a total of 172 visits were made to Medium Farm Operations. Of these, 107 inspections/surveys were conducted on medium farms to evaluate compliance with the State's MFO general permit conditions.




Figure 5. As a result of MFO inspections conducted in 2015, a total of four medium farms received formal enforcement actions and one enforcement action is pending, resulting in a regulatory compliance rate of 93%.




Figure 6. LFO Individual Permit Compliance: In 2015, a total of 125 visits were made to Large Farm Operations. Of these, 60 inspections/surveys were conducted to evaluate a farm's compliance with their individual LFO permit




Figure 7. As a result of LFO inspections conducted in 2015, two large farms received formal enforcement actions and one enforcement action is pending, resulting in a regulatory compliance rate of 93%.





Figure 8. The Agency provides both regulatory services and non-regulatory services in the form of technical assistance. Technical assistance is provided by Agency Engineers, a Conservation Reserve Enhancement Program Coordinator, and also by the regulatory field staff. Agency staff will perform multiple technical assistance visits to ensure a farm moves steadily towards achieving compliance.







Figure 9. The following charts illustrate the general nature of the complaint-generated inspections and compliance checks conducted on small, medium, and large farms.

<u>Field Practices</u> includes: cropfield runoff — erosion, ditch maintenance/impacts to water, general compliance check — field practices, livestock pasturing near wells, manure management — field practices, spreading during the ban, spreading ban compliance checks, manure spreading exemption requests, prespreading ban compliance checks, and vegetative buffers.

<u>Production Area</u> includes: carcass disposal/slaughter waste, livestock access to water/streambank impacts, general compliance check – production area, manure management – production area, milkhouse waste, and silage leachate/waste feed.

This graphic is a companion piece to Table 4 in the 2015 Annual Report, and represents all compliance checks and inspections into alleged violations of RAPs, MFO and LFO inspections conducted in response to complaints, and MFO and LFO inspections that led to enforcement actions. This graphic does <u>not</u> track all MFO and LFO inspections conducted in 2015. Please see Figures 4 and 6 of this Appendix for a total number of MFO and LFO inspections conducted in 2015.




Figure 11. This chart illustrates the number of verbal warnings, ANR referrals, and enforcement actions issued by farm size for violations of the RAPs, MFO general permit, and LFO individual permits and Rules. To aid in the comparison of the nature of the violation by farm size, RAP requirements have been grouped into "production area" and "field practices". Figure 11 below provides a breakdown of actions by individual RAP section. [Note - an enforcement action may include more than one count / violation of the RAPs or MFO / LFO permit requirements, so numbers of violations may exceed the total number of enforcement actions issued.]




Figure 12. This chart provides a breakdown of verbal warnings, ANR referrals, and enforcement actions issued to small farms by specific sections of the RAP Rules. [Note - an enforcement action may include more than one count / violation of the RAPs, so numbers of violations may exceed the total number of enforcement actions issued.]
