13 It is hereby enacted by the General Assembly of the State of Vermont:

16 ~~(a) Creation. There is created the Southeast State Correctional Facility~~

17 ~~Study Committee to study and make recommendations on the future use of the~~

18 ~~Southeast State Correctional Facility.~~

19 ~~(b) Membership. The Committee shall be composed of the following five~~

20 ~~members.~~

1 ~~(1) the manager of the Town of Windsor;~~

2 ~~(2) two members of the Town of Windsor Selectboard, who shall be~~
3 ~~appointed by the Chair of the Selectboard; and~~

4 ~~(3) two residents of the Town of Windsor, who shall be appointed by the~~
5 ~~Chair of the Selectboard.~~

6 ~~(c) Powers and duties. The Committee shall study the potential uses of~~
7 ~~space at the Southeast State Correctional Facility.~~

8 ~~(d) Report. On or before December 15, 2018, the Committee shall submit~~
9 ~~a written report to the House Committee on Corrections and Institutions and~~
10 ~~the Senate Committee on Institutions with its findings and any~~
11 ~~recommendations for legislative action.~~

12 ~~(e) Meetings.~~

13 ~~(1) The Chair shall call the first meeting of the Committee to occur on~~
14 ~~or before August 1, 2018.~~

15 ~~(2) The Committee shall select a chair from among its members at the~~

17 ~~(3) A majority of the membership shall constitute a quorum.~~

~~(a) On or before August 1, 2018, the Commissioner of Buildings and General Services shall issue a request for information for recommendations on the future use and development of the Southeast State Correctional Facility and the surrounding 118.57 acres of land owned by the Department of Buildings and General Services. The General Assembly intends that the responses to the request for information would include recommendations for both public and private uses, including a State-owned facility, and would allow for consultation with the Town of Windsor.~~

~~(b) On or before January 15, 2019, the Commissioner of Buildings and General Services shall submit a report to the House Committee on Corrections and Institutions, the Senate Committee on Institutions, and the Selectboard for the Town of Windsor with the results of the request for information described in subsection (a) of this section and recommendations for the use of the Southeast State Correctional Facility based on these results.~~

~~Sec. 1. SOUTHEAST STATE CORRECTIONAL FACILITY; REPORT~~

~~(a) The Commissioner of Buildings and General Services shall investigate and analyze options for the future use of the Southeast State Correctional Facility and the surrounding 118.57 acres of land owned by the Department of~~

Buildings and General Services. As part of the investigation, the Commissioner shall consult with the Secretary of Administration and any other State entities that would have a potential use for the facility or land.

(b) On or before December 15, 2018, the Commissioner of Buildings and General Services shall submit a report, which shall include an analysis and recommendations on the highest and best State use resulting from the investigation described in subsection (a) of this section to the House Committee on Corrections and Institutions, the Senate Committee on Institutions, and the Chair of the Town of Windsor Selectboard.
