Whereas, youths 12–25 years of age represent a vital stage of adolescent development and deserve resources that are appropriate for their unique needs, and

<u>Whereas</u>, as the third-leading scorer in the history of the University of New Hampshire Wildcats' varsity ice hockey, Mike McShane was a natural to embark on a coaching career, and following graduation, he polished his teaching skills, earning a master's degree in education at Boston University, and

<u>Whereas</u>, Mike McShane accepted his first coaching job at New Hampton Prep School in New Hampshire, securing three Division I prep championships, and <u>Whereas</u>, as an assistant coach at Dartmouth College, Mike McShane helped the Big Green win two Ivy League titles and advance to the semifinals of the NCAA Division I ice hockey championships, and

<u>Whereas</u>, after success coaching at St. Lawrence University and Providence College, including 1989 New England Coach of the Year recognition, Mike McShane arrived at Norwich University to coach the 1995–1996 season, and

Whereas, his 22-season Norwich record of 478–123–36 has far surpassed anyone's grandest expectations and represents an astounding .778 winning percentage, and his 36 seasons overall have resulted in a tally of 722–341–67, equaling an impressive .669 winning percentage, and

<u>Whereas</u>, among Mike McShane's many achievements are 24 coach of the year awards, including for the 2016–2017 NCAA Division III championship season being named the American Hockey Coaches Association's Ed Jeremiah National Division II–III Coach of the Year for a record fifth time and similar accolades from the New England Hockey Conference, USCHO.com, and the New England Hockey Writers Association, and

Whereas, Norwich, under his ice hockey stewardship, has won 18 of the last 19 New England Hockey Conference regular season titles and 12 post-season conference championships, and
