15	(a) As of January 1, 2018, all school employees will be on new health care
16	plans. The new health plans cover the same health care services and networks,
17	but they have lower premium costs. The new plans also create higher out-of-
18	pocket exposure through deductibles and co-payment requirements. However,
19	because the premiums for these plans are markedly lower, there are
20	opportunities to keep employees' out-of-pocket costs at current levels while
21	also realizing up to \$26 million in annual savings. Based on the data from

1	finalized contracts to date, these savings may result in substantially fewer

3	(b) On or before June 30, 2017 or 30 days after the adoption of its annual

5	school district shall submit to the Secretary of Education and the
6	Commissioner of Finance and Management a report documenting its actual
7	health care costs for calendar years 2016 and 2017 and its budgeted health care
8	costs for 2018. This report shall be on a form prescribed by the Commissioner
9	of Finance and Management and shall specify the employee contribution and
10	employer contribution totals for each calendar year.
11	(c) Not later than 60 days after the adoption of all collective bargaining
12	agreements covering health care benefits for school employees for plan year
13	2018, each supervisory district, supervisory union, and school district shall
14	submit to the Secretary of Education and the Commissioner of Finance and
15	Management, a report documenting its anticipated health care costs for fiscal
16	year 2018, based on the new collective bargaining agreements covering plan

6	savings offset under this subsection shall remain in the Education Fund in an
