# Act 174 Trainings for Local Officials Progress Report, December 2016

Regional Planning Commissions, in partnership with the Department of Public Service, held eleven trainings over the course of two weeks. The training focused on the goals of Act 174, the implications for Section 248 proceedings and the specific requirements of the determination standards for local and regional plans. RPCs may also hold trainings for specific local or regional audiences, and each RPC will hold another region-wide training in spring 2017.

In 2017 RPCs will provide each municipality with a compilation of maps and data and will work directly with a minimum of three municipalities in their region to complete energy plans that will meet the standards.

### **Summary of the Trainings:**

227 local officials attended

**121** municipalities were represented

**87** % rated the training excellent or good



Municipal officials left the trainings with a better understanding of Act 174, the determination standards and what will be necessary for municipalities to achieve substantial deference in Section 248 proceedings.
