16	Statement of purpose of bill as introduced: This bill proposes to prohibit the
17	exercise of eminent domain by utilities for purposes of fossil fuel

An act relating to prohibiting utilities from using eminent domain for fossilfuel infrastructure

1 It is hereby enacted by the General Assembly of the State of Vermont: 2 Sec. 1. 30 V.S.A. § 110 is amended to read: 3 § 110. EMINENT DOMAIN; COMPANIES AUTHORIZED 4 (a) When it is necessary for a corporation formed under this chapter or a 5 foreign corporation under the jurisdiction of the Public Utility Commission to 6 acquire property within this State, or some easement or other limited right in 7 such property in order that it may render adequate service to the public in the 8 conduct of its business, it may condemn such property or right, as provided in 9 sections 111-124 of this title. All other companies, as defined in sections 201 10 and 501 of this title, which are within the scope of sections 203 and 501 of this 11 title, shall have the same power of condemnation and be subject to the same 12 procedure as hereinafter provided for condemnation by corporations subject to 13 the jurisdiction of the Public Utility Commission. However, no corporation or 14 company may condemn any property or right in order to construct or expand 15 facilities or structures that would: 16 (1) transport fossil fuel, except as necessary to more safely or more 17 economically serve customers in an existing service territory; or 18 (2) produce electricity, heat, or other energy using fossil fuel. 19 (b) As used in this section, "fossil fuel" means an energy source formed in 20 the earth's crust from decayed organic material. The phrase does not include

- 1 methane produced from animal waste. The common fossil fuels are petroleum,
