Whereas, on February 24, 2022, Russia invaded its neighbor, the independent nation of Ukraine, with a fury that shocked the world, and, as of February 24, 2024, aside from the multitude of military personnel casualties, Ukraine had experienced over 10,500 civilian deaths, including 587 children, and

Whereas, St. Nicholas Pediatric Hospital in Lviv serves as the national medical hub for the treatment and rehabilitation of children injured by this war, and

Whereas, a world away, in Marshfield, Vermont, teacher Cindy Scott's third-grade class at Twinfield Union School, comprising students Autumn, Cassidy, Elise, Evelyn, Finn, George, Georgia, Gus, Jace, Liev, Lennix, Lincoln, Maeve, Matthew, Micah, Phil, Sadie, and Shay, decided, on their own initiative, to create "fidget" toy packets for these war victims, with personal notes of caring and love from each student composed in both English and Ukrainian, and arrangements were made for personal delivery of the packages, and

Whereas, after the gifts were delivered, the Twinfield third graders participated in a Zoom session with their counterparts in the "Superhero Class" at St. Nicholas Pediatric Hospital, during which the youngsters at each location asked questions, sang songs, and recited poetry, and

Whereas, this extraordinary act of friendship was recognized with a fun class photo that appeared in the *Times Argus* newspaper and the third graders' receipt of a beautiful and heartfelt letter of gratitude from St. Nicholas Pediatric Hospital, now therefore be it

<u>Whereas</u>, the citizens of Brattleboro are well acquainted with the Broutsas family: the late Michael Broutsas, a veteran State representative, was the first Vermont legislator born in Greece; and his daughter, Esta Broutsas Smith, has contributed in many ways to the quality of life in Brattleboro, and

Whereas, Esta Broutsas was born in January 1924 in Greenfield, Massachusetts, and her family moved to Brattleboro shortly after her birth, and

Whereas, although she started kindergarten unable to speak English, as a teacher for over half a century, Esta Broutsas Smith maximized the reading ability of many students, even those with learning challenges, and

Whereas, at 19 years of age, Esta Broutsas became the sole teacher at a one-room schoolhouse in Guilford; for many years, she was a special educator at the Green Street School in Brattleboro; and, although she concluded her career as a full-time teacher at 75 years of age, her career in education continued as she volunteered to assist prisoners in the improvement of their reading skills, and

Whereas, the arts are important in her life, and she frequently attended drama and music performances at local venues, and, even today, she remains a regular virtual attendee, and

Whereas, her love of outdoor recreation and her appreciation for Vermont's natural beauty were exemplified through daily road or woods hikes, cross-country skiing, and avidly playing tennis until she reached 90 years of age, and

Whereas, Esta Broutsas Smith's strong sense of justice complemented the humanitarian values of the Unitarian Universalist Church, her spiritual home, and

Whereas, she has resided in the same house since 1956, situated on the farm with the large red barn that her father purchased in 1928, and

Whereas, Esta Broutsas Smith's active lifestyle, healthy diet, continuing interest in the surrounding world, and her large, supportive extended family, have all contributed to her life's reaching the century milestone, now therefore be it

Whereas, for a man who was unable to read until the seventh grade and finds math a steep challenge, Bill Blachly has summited seemingly insurmountable peaks in life and especially in the dramatic arts, and

Whereas, Bill Blachly's personal journey, which has featured the inevitable comic and tragic scenes, started with his birth on April 13, 1924 in New Jersey, where he was raised in the Township of Montclair; and, as a youth, he enjoyed attending Broadway shows and Metropolitan Opera performances in New York City, and

Whereas, during his World War II U.S. Navy service, his vessel sank, but, fortunately, he was rescued, and he later attended Oberlin College in Ohio and graduated from Goddard College, and

Whereas, in 1956, Bill Blachly abandoned a career in college administration and purchased the dilapidated Broadview Farm in Calais, where he initially milked a small dairy herd and later raised a flock of sheep, and

Whereas, in 1965, prior to the historic Vermont legislative reapportionment, the voters of the Town of Calais elected Bill Blachly, for one term, as their

first Democratic State representative—and their last, regardless of political party—to serve in the "Big House," and, despite his mathematical shortcomings, he later worked in the Vermont Department of Taxes, and

Whereas, Bill Blachly volunteered with community theater organizations in Plainfield and Barre, and was a leader in the restoration of the Barre Opera House; and, in 1983, on extremely short notice, he transferred a Plainfield Little Theater production of Anton Chekhov's *Uncle Vanya* to a nonexistent performance venue in his own barn, which he named the Unadilla Theater after the manufacturer's name that was listed on the building's rafters, and

Whereas, 21 Gilbert and Sullivan, 10 Shakespeare, 10 Chekhov, six Fugard, six Shaw, three Ibsen, and 130 other productions later, he has created a community theater legacy with his partner since 1980, Ann O'Brien; along with his former wife, Alice; and other family members and friends, and

Whereas, his own thespian desires were satisfied as the incumbent member of Congress who Fred Tuttle challenges in the 1996 classic Vermont film *Man with a Plan*, now therefore be it

Whereas, in August 1982, while camping in the Worcester Range on a rainy night, three young Vermont friends—Steve Bushey, Paul Jarris, and Ben Rose—committed themselves to skiing the length of Vermont from Massachusetts to Quebec, and

Whereas, they were not mere idle dreamers, and, over the next two years, Steve Bushey, while writing his master's thesis at Carleton University in Ottawa, Ontario, identified a route for this proposed winter odyssey, and

Whereas, in February 1984, Steve Bushey and Ben Rose filed articles of association with the Secretary of State establishing the Catamount Trail Association; and, on February 29, 1984, these three daring adventurers, with the support of a fourth friend, the late Jim Painter, skied northward from

Whitingham to the Canadian port of entry adjacent to North Troy, where, on March 20, they presented themselves to Canadian Customs officers before returning to Vermont, and

Whereas, as the result of this 1984 project, the Catamount Trail Association (CTA) was born, and today it is a thriving Vermont recreational organization, voluntarily stewarding and managing the 31 sections of the Catamount Trail, and

Whereas, in commemoration of the Catamount Trail's 40th anniversary on February 8, 2024, Paul Jarris and Ben Rose, along with CTA section leaders Bob Brandt and Kevin Batson and CTA Board Chair Jay Stearns, who served as the group's videographer, set out to ski the current route of the Catamount Trail in an event named the Ruby Run, and

Whereas, insufficient snow north of Stowe halted the trip on March 3, 2024, but a 40th anniversary celebration, which Steve Bushey also attended, still occurred that day at the Trapp Family Lodge; and, in 2025, all three of the original skiers intend to traverse the remaining nine sections from Stowe to the Quebec border, now therefore be it

Whereas, her first professional role was as a victim-witness advocate at the Northwestern District Attorney's office in Northampton, Massachusetts, where she was subsequently promoted to a supervisory position, and

Whereas, Sally Borden's responsibilities as Director of Training at the Massachusetts Office of Victim Assistance entailed supervising statewide training for victim advocacy, and

Whereas, for several years, Sally Borden returned to California, where she served as the Executive Director of the Shelter Against Violent Environments Inc., an organization that provides support services for domestic violence victims and survivors and their children in Alameda County, California, and

Whereas, since 1998, Sally Borden has been associated with the KidSafe Collaborative in Burlington, which works to improve the response to child abuse and neglect, where she initially served as a project director, and, since 2001, as the organization's executive director, and

Whereas, Sally Borden has led or participated in many national and State panels and projects; is the recipient of several honors recognizing her professional excellence and exemplary community roles, including the Antonio B. Pomerleau Medal of Honor; and she is concluding her work at KidSafe Collaborative, now therefore be it

Whereas, the duties of correctional officers in Vermont include providing security for residents and staff in correctional facilities, supervising all aspects of daily living, and fulfilling a mission to rehabilitate individuals and prepare them for successful reentry into the community, and

Whereas, correctional employees must also confront extraordinary on-thejob risks, including the occurrence of violence, the responsibility to provide life-saving emergency medical care, and the prevalence of issues such as substance addiction, chronic health conditions, and multigenerational trauma, and

Whereas, Vermont's Department of Corrections is unique in being administered under the Agency of Human Services and in its unified statewide system that serves both sentenced offenders and detained individuals awaiting trial, and

Whereas, statewide, the Vermont Department of Corrections has 12 community-based probation and parole field offices at which probation and parole officers and community correctional officers supervise sentenced individuals in the community, and

Whereas, both the federal executive and legislative branches have designated the first full week of May as National Correctional Officers and Employees Week, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes May 5–11, 2024 as National Correctional Officers and Employees Week in Vermont, and be it further

Whereas, a half century after its formation, the Allard Lumber Company remains a proud and thriving family-owned and -operated business, now therefore be it

Whereas, students of all ages participate by walking to school instead of riding on the bus or in personal vehicles, and

Whereas, Walking Wednesdays is based on a national initiative to encourage schools and communities to help youngsters increase their daily physical activity, and

Whereas, the school's healthy weekly endeavor has continued for 17 years, and it is one of the longest ongoing programs at Northfield Elementary School, and

Whereas, Walking Wednesdays has the support and involvement of community members, parents, grandparents, local businesses, and Norwich University, and

Whereas, Mike Gonneville finds the most rewarding part of Walking Wednesdays to be the regular stop in front of The Veterans' Place Inc., a residential facility on Vine Street, where, with hands on hearts, the students recite the Pledge of Allegiance with the Veterans, and the facility's director reports that residents "live for this moment" each week, now therefore be it

Whereas, every U.S. state and territory has an agency to finance the construction of affordable housing, and, on April 11, 1974, Governor Salmon signed the Vermont Housing Finance Agency Act, which became Act 260, and

Whereas, the Vermont Housing Finance Agency's (VHFA) mission is to "finance and promote affordable, safe and decent housing opportunities for low- and moderate-income Vermonters," and

Whereas, since 1974, VHFA has assisted 31,000 home buyers and supported the development of 9,600 affordable apartments, and

Whereas, VHFA is a strong partner to the lenders, municipalities, utilities, developers, real estate professionals, investors, and each branch of government, and

Whereas, several housing shocks—including the Great Recession, Tropical Storm Irene, COVID-19, an increasing number of natural disasters, inflation, and varying interest rates—put pressure on housing affordability, accessibility, and safety, and VHFA deftly navigated through these crises, and

Whereas, recently, VHFA rose to address the State's evolving housing needs, launching several new programs, including expanding access to weatherization; paying off mortgage, utility, and tax arrearages; funding for-sale home construction; expanding employer-supported housing; and supporting first-generation homebuyers, and

Whereas, VHFA started the Vermont Housing Investment Fund in 2020, which has already added \$17 million in philanthropic, federal, and in-state funding to address critical housing funding gaps, and
