

ANR ARPA: State Parks Connectivity

Program – These funds are being used to improve broadband access at state parks by installing fiber optic cable (and/or the infrastructure necessary to support future installation of fiber optic cable). FPR and Agency of Digital Services have worked closely with the Vermont Community Broadband Board to define the project and track the progress of the Communication Union Districts (CUD). This lengthy process is now complete and the RFP issuance is imminent. While the need is present at all 55 state parks, the RFP will be for 'last mile' infrastructure needed for improved broadband within 8-10 high priority parks based on existing level of service, park attendance, availability of fiber within 'last mile' etc.




