14	heading in their entireties and inserting in lieu thereof a reader assistance
15	heading and a new section to be Sec. 14 to read as follows:

17	Sec. 14. STUDY; COMMUNICATIONS INFRASTRUCTURE;
18	RIGHT-OF-WAY
19	(a) The Secretary of Transportation, in consultation with the Commissioner
20	of Public Service and the Secretary of Digital Services, shall conduct a study
21	concerning access to and use of the public right-of-way (ROW) in Vermont by

1	telephone (wired and wireless) and broadband companies. In particular, the
2	Secretary shall determine how the ROW is currently being accessed and used
3	by such companies in Vermont and, in addition, shall review and assess how
4	other jurisdictions outside Vermont manage and charge for such access and
5	use.
6	(b) As used in this section, "public right-of-way" means the area on, below,
7	along, across, or above a public roadway that is part of the State highway
8	system.
9	(c) On or before October 15, 2025, the Secretary shall submit a written
10	report of the Secretary's findings and recommendations to the Senate
11	Committees on Finance and on Transportation and the House Committees on
12	Ways and Means, on Transportation, and on Environment and Energy.
13	<u>Third</u> : By striking out Sec. 14, effective dates, in its entirety and inserting
14	in lieu thereof a new section to be Sec. 15 to read as follows:
15	Sec. 15. EFFECTIVE DATES
16	This act shall take effect on passage, except that:
17	(1) Sec. 13 (PILOT Fund appropriation) shall take effect on July 1,
18	<u>2024.</u>
19	(2) Secs. 1–6 (VUSF contribution method; 988 funding) shall take effect
20	on July 1, 2025.
