9	for, treat, or supervise a child or family who is the subject of a report or record

11	(G) a Probate Division of the Superior Court involved in			
12	guardianship proceedings; and			
13	(H) other governmental entities for purposes of child protection.			
14	(2) Determinations of relevancy shall be made by the Department.			
15	(3) In providing records or information under this subsection, the			
16	Department may withhold:			
17	(A) information that could compromise the safety of the reporter or			
18	the child or family who is the subject of the report; or			
19	(B) specific details that could cause the child to experience			
20	significant mental or emotional stress.			

1	(4) In providing records or information under this section, the
2	Department may also provide other records related to its child protection
3	activities for the child.
4	(5) Any persons or agencies authorized to receive confidential
5	information under this section may share such information with other persons
6	or agencies authorized to receive confidential information under this section
7	for the purposes of providing services and benefits to the children and families
8	those persons or agencies mutually serve.
9	(f) Disclosure to prevent harm. Upon request, relevant Department
10	information created under this subchapter may be disclosed to a parent with a
11	reasonable concern that an individual who is residing at least part time with the
12	parent requestor's child presents a risk of abuse or neglect to the requestor's
13	child. As it is used in this subsection, "relevant Department information" shall
14	mean information regarding the individual that the Department determines
15	could avert the risk of harm presented by the individual to the requestor's
16	child. If the Department denies the request for information, the requestor may
17	petition the Family Division of the Superior Court, which may, after weighing
18	the privacy concerns of the individuals involved with the parent's right to
19	protect his or her child, order the release of the information.
20	(g) Disclosure to adults that were subject to foster care placement.

1	(1) It is the intent of the General Assembly that it be the policy of the
2	State that:
3	(A) adults who were subject to placement in State foster care,
4	institutions, and other systemic placements have a statutory right to access
5	their own records in order to more fully understand their own personal stories,
6	including their health, education, family, and other histories; access healing in
7	their chosen way; and be recognized and trusted as legitimate custodians of
8	their own information;
9	(B) the Department make good faith efforts to disclose such records
10	in the broadest form permitted under applicable federal or State law in order to
11	assist with the administration of Vermont's state plan for foster care and
12	establishing eligibility for programs or services; and
13	(C) any disclosures made by the Department that are prohibited by
14	applicable federal or State law be construed as good faith efforts of the
15	Department to comply with the State's policy and statutory scheme.
16	(2) Upon request, Department records created under this subchapter shall
17	be disclosed, at no cost, to an individual who meets the following criteria, to
18	the extent permitted by federal or State law:
19	(A) the individual is the subject of the records requested;
20	(B) the individual is 18 years of age or older; and

3	(3) In providing records or information pursuant to this subsection, the			
4	Department may withhold or redact the following:			
5	(A) identifying information about any person, other than the subject,			
6	in which there is a substantial likelihood that a person's safety would be

8	(B) information that creates a substantial likelihood that would			
9	compromise an active law enforcement investigation; or			
10	(C) reports or investigatory records about the subject of the record			
11	request in which there is a formal allegation that the subject committed an act			
12	of abuse or neglect.			
13	(g)(h) Penalty. Any records or information disclosed under this section and			
14	information relating to the contents of those records or reports shall not be			
15	disseminated by the receiving persons or agencies to any persons or agencies,			
16	other than to those persons or agencies authorized to receive information			
17	pursuant to this section. A person who intentionally violates the			
18	confidentiality provisions of this section shall be fined not more than			
19	\$2,000.00.

1	(a) Except as otherwise provided, court and law enforcement reports and			
2	files concerning a person subject to the jurisdiction of the court shall be			
3	maintained separate from the records and files of other persons. Unless a			
4	charge of delinquency is transferred for criminal prosecution under chapter 52			
5	of this title or the court otherwise orders in the interests of the child, such			
6	records and files shall not be open to public inspection nor their contents			
7	disclosed to the public by any person. However, upon a finding that a child is
