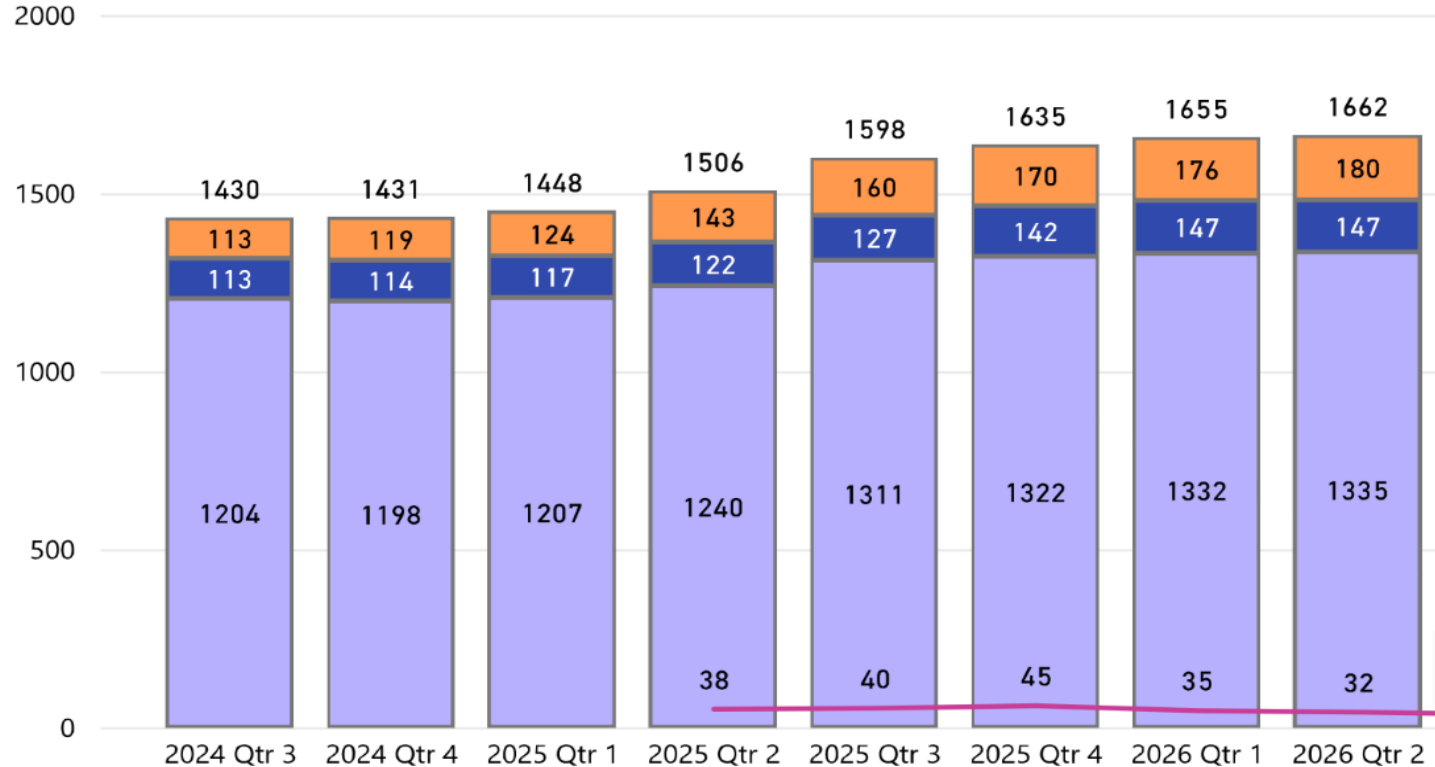

Average Incarcerated Population Trends

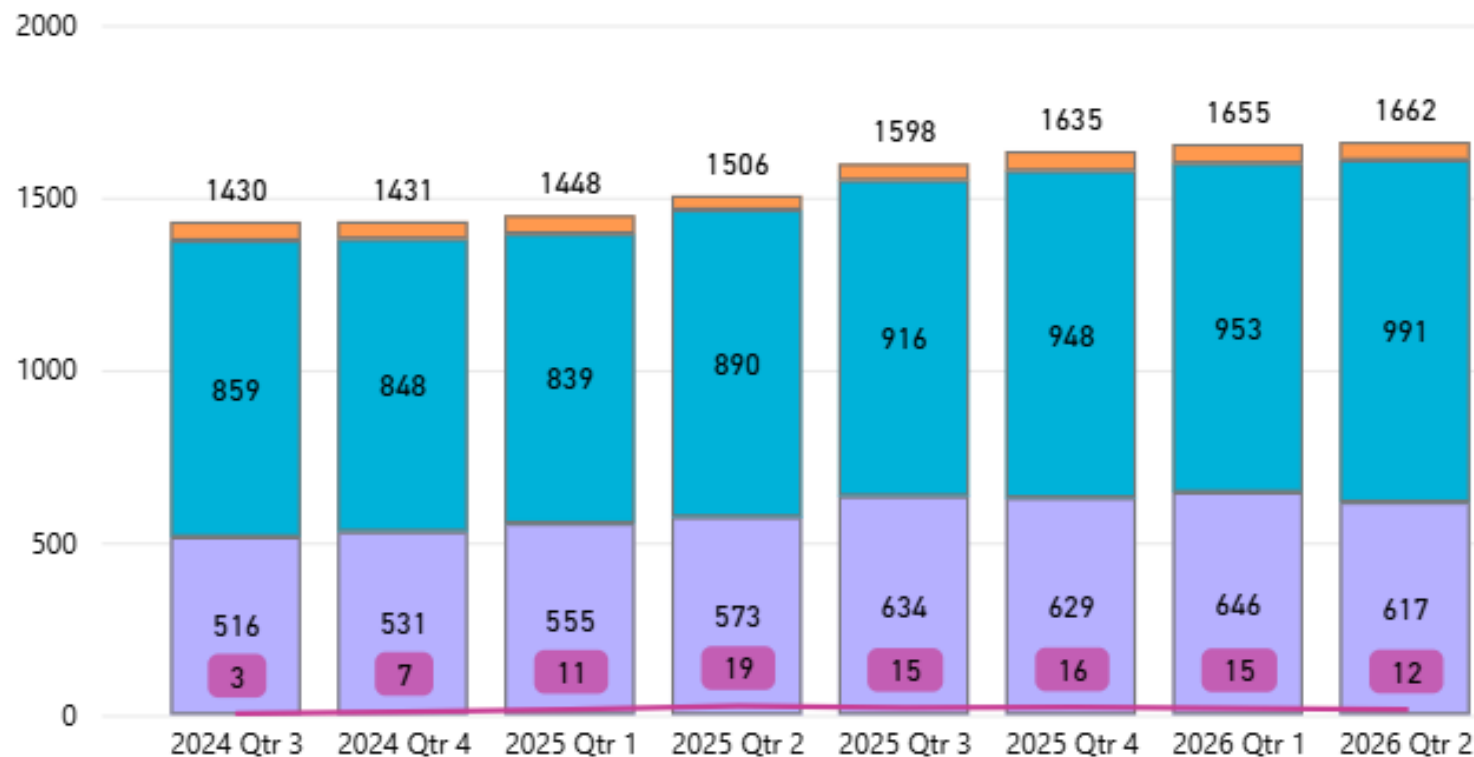

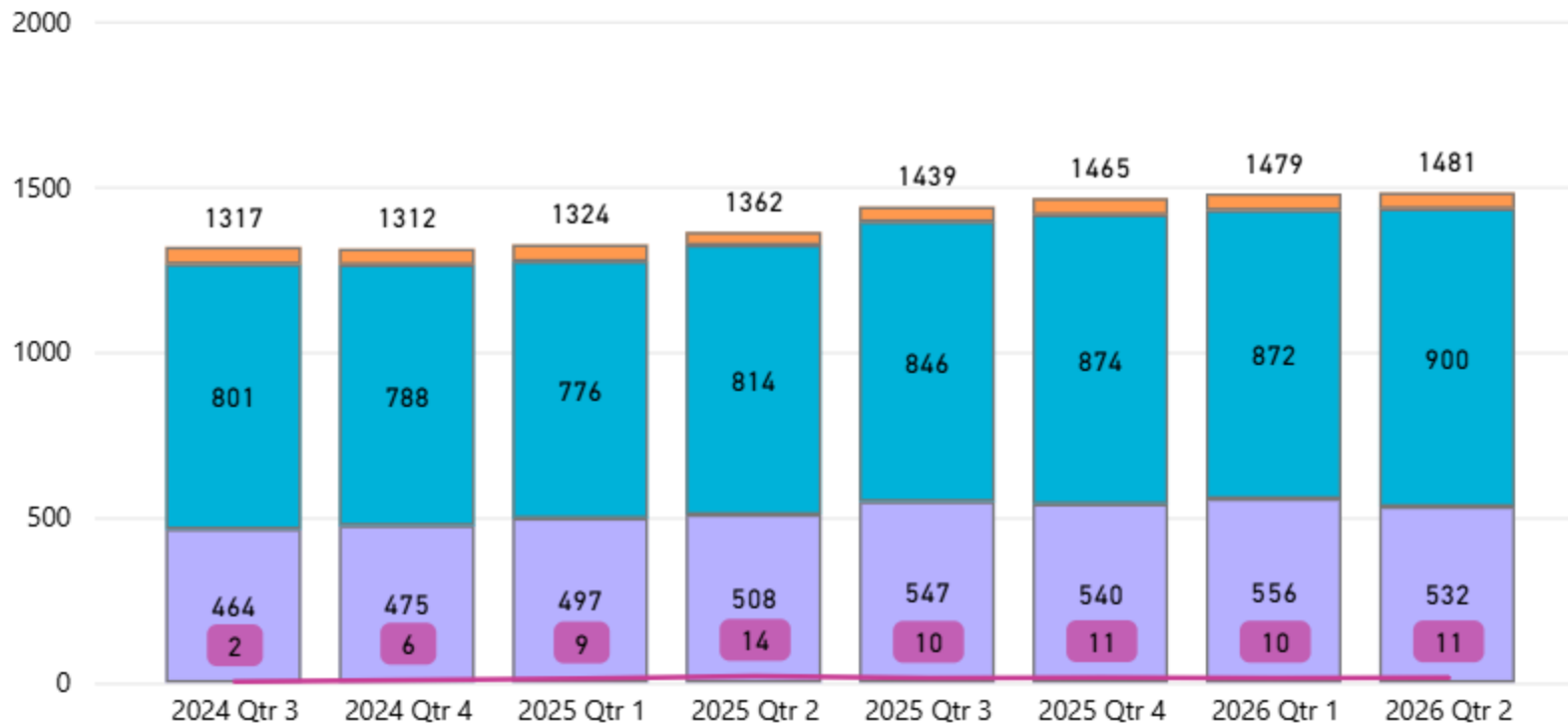

Average Incarcerated Population Trends: Male

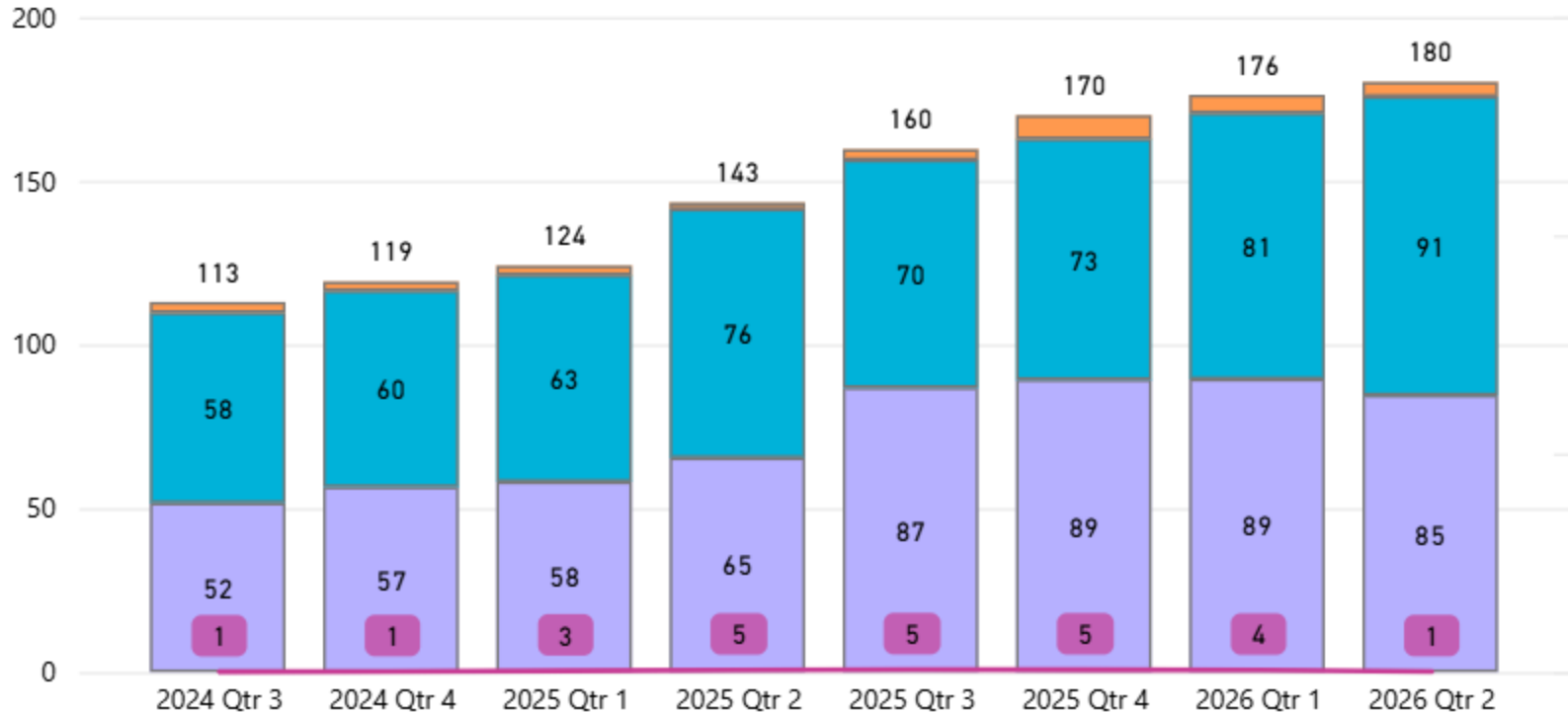

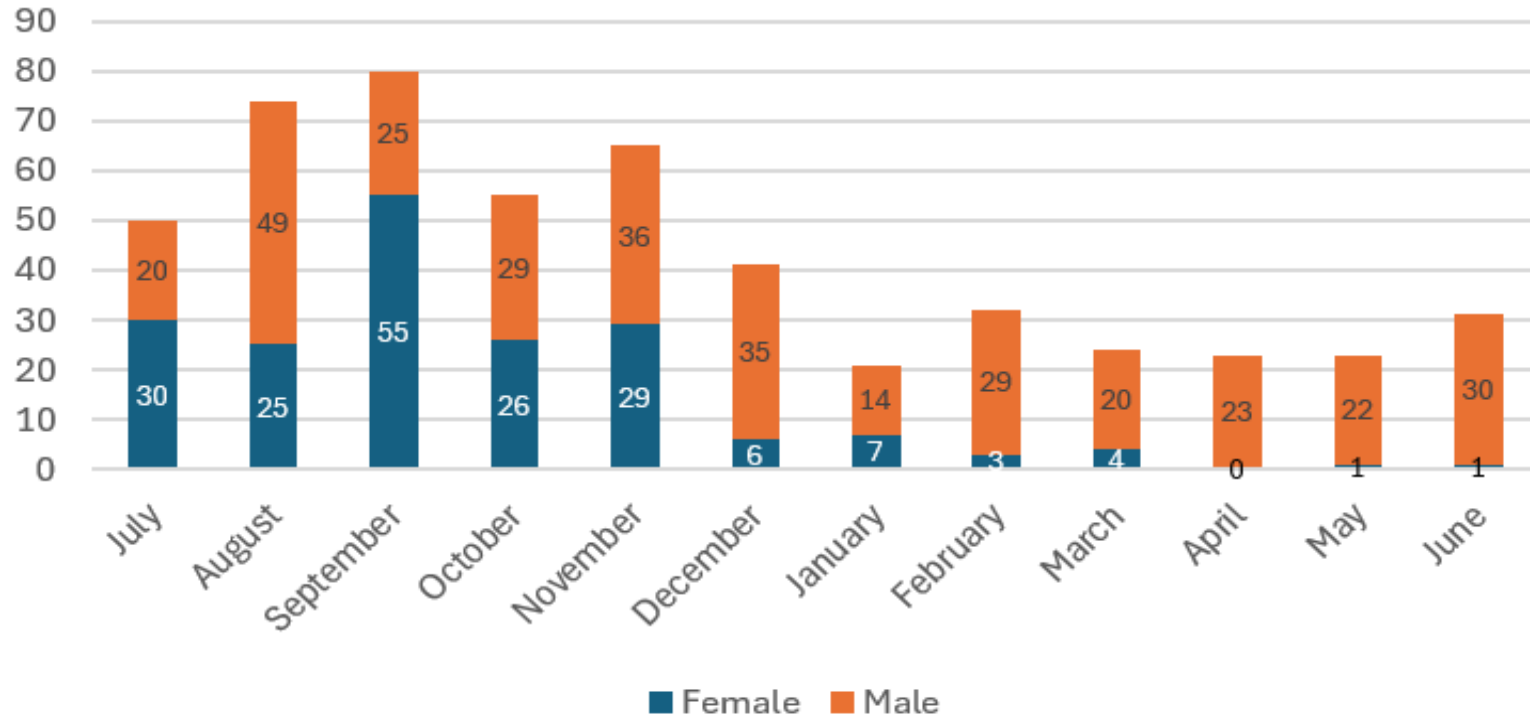
Average Incarcerated Population Trends: Female

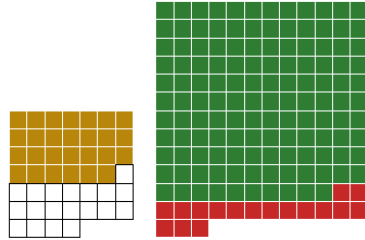
Immigration Detainees Booked by Month, FY 2026



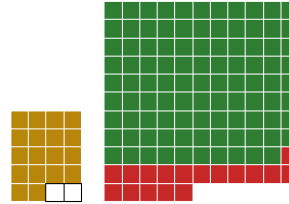

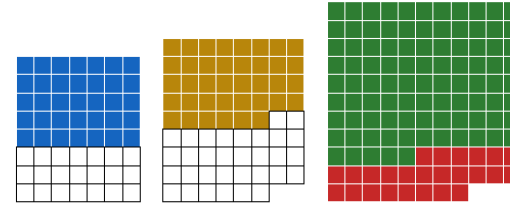

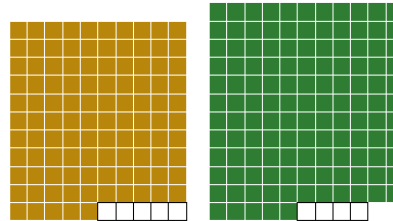

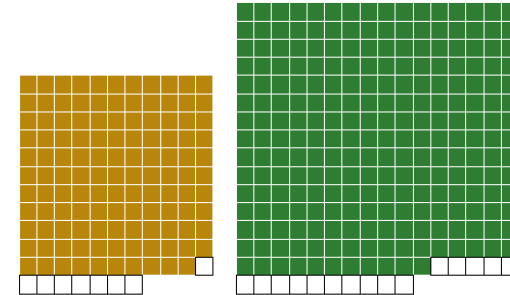

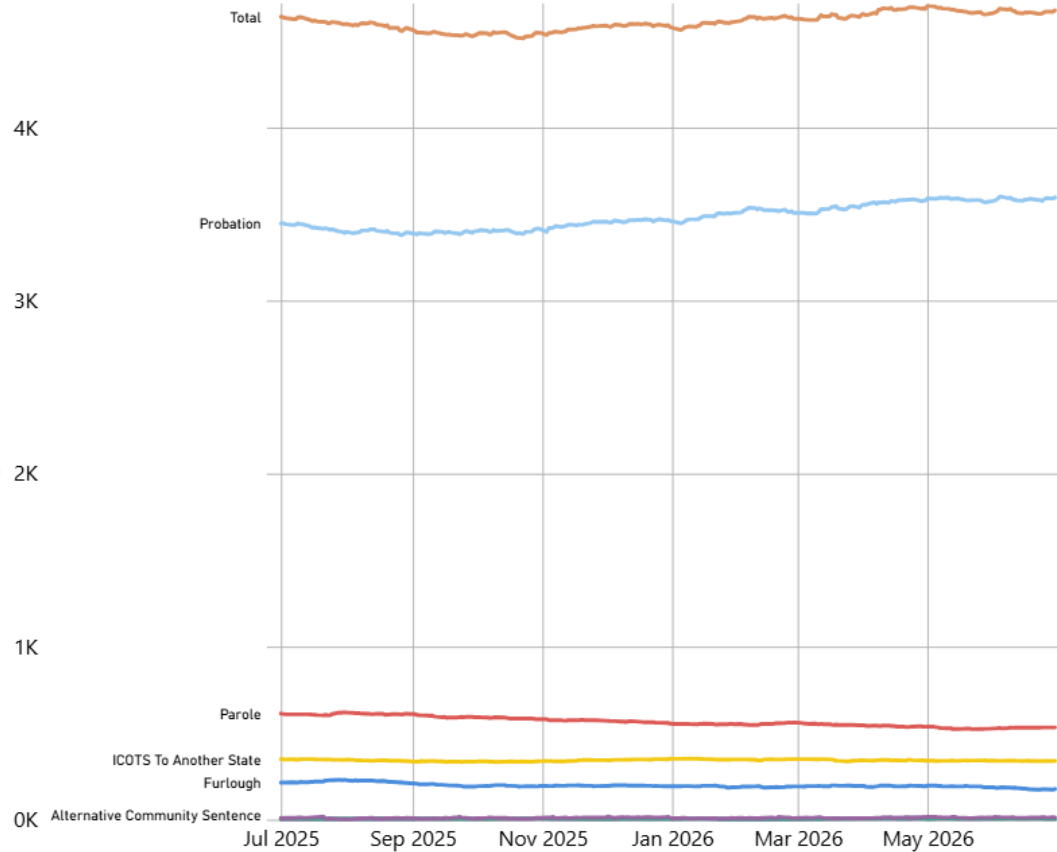

Community Supervision Population Counts Over the Past 12 Months



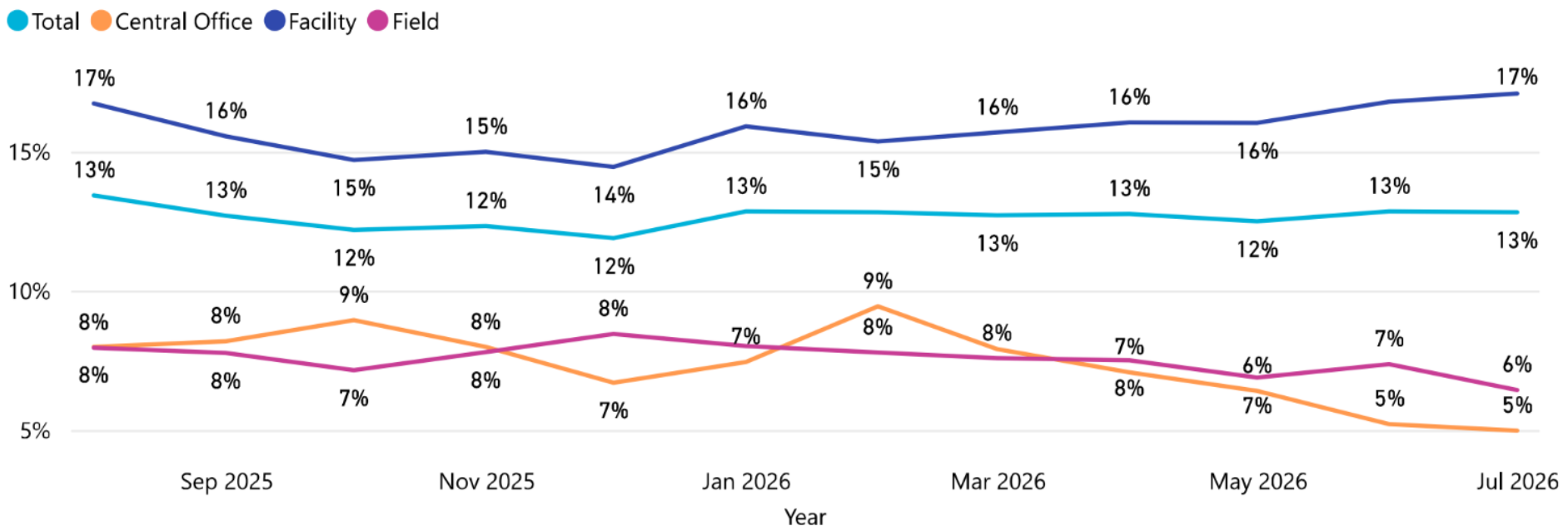
