Subject: Fish and wildlife; youth hunting; eligibility
Statement of purpose: This bill proposes to allow nonresidents to participate in
the state's youth hunting programs.

An act relating to eligibility for the state youth hunting programs

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. 10 V.S.A. § 4742 is amended to read:

§ 4742. YOUTH HUNTING DAY

(a) The Sunday prior to opening day of regular deer season shall be youth
hunting day.

(b) A person who is under 16 years of age, ~~who has at least one parent or a
guardian who is a legal resident of Vermont, and~~ who has successfully
completed a hunter safety course, may take one wild deer on youth hunting day
in accordance with the rules of the board. In order to hunt under this section, a
young person shall also hold a valid hunting license under section 4255 of this
title and be accompanied by an unarmed adult who holds a valid hunting

1 license and who is over 18 years of age. An adult accompanying a youth under
2 this section shall accompany no more than two young people at one time.

3 (c) Each year the board shall determine whether antlerless deer may be
4 taken under this section in any deer management unit or units. A
5 determination under this subsection shall be made by rule, shall be based on
6 the game management study conducted pursuant to section 4081 of this title
7 and, notwithstanding subsection (g) of that section, may allow taking of
8 antlerless deer.

9 (d) No person shall hunt under this section on privately owned land without
10 first obtaining the permission of the owner or occupant.

11 (e) Before the first youth hunting day and after each fall hunting season, the
12 department shall collect information on youth hunting day during the regional
13 public hearings held pursuant to subsection 4081(f) of this title. Information
14 relative to the public's knowledge and concerns about the deer herd shall be
15 gathered. The board shall administer youth hunting day, by deer management
16 unit, based on public input and scientific information.

18 § 4742a. YOUTH DEER HUNTING WEEKEND

19 (a) The Saturday and Sunday prior to opening day of regular deer season
20 shall be youth deer hunting weekend.

1 (b) A person who is age 15 and under, ~~who has at least one parent or a~~
2 ~~guardian who is a legal resident of Vermont, and~~ who has successfully
3 completed a hunter safety course, may take one wild deer during youth deer
4 hunting weekend in accordance with the rules of the board. In order to hunt
5 under this section, a young person shall also hold a valid hunting license under
6 section 4255 of this title and be accompanied by an unarmed adult who holds a
7 valid hunting license and who is over 18 years of age. An adult accompanying
8 a youth under this section shall accompany no more than two young people at
9 one time.

10 (c) Each year the board shall determine whether antlerless deer may be
11 taken under this section in any deer management unit or units. A
12 determination under this subsection shall be made by rule, shall be based on
13 the game management study conducted pursuant to section 4081 of this title
14 and, notwithstanding subsection (g) of that section, may allow taking of
15 antlerless deer.

16 (d) No person shall hunt under this section on ~~privately owned~~ privately
17 owned land without first obtaining the permission of the owner or occupant.

18 (e) Before the first youth deer hunting weekend and after each fall hunting
19 season, the department shall collect information on youth deer hunting
20 weekend during the regional public hearings held pursuant to subsection
21 4081(f) of this title. Information relative to the public's knowledge and

1 concerns about the deer herd shall be gathered. The board shall administer
2 youth deer hunting weekend, by deer management unit, based on public input
3 and scientific information.

5 § 4908. YOUTH TURKEY HUNTING WEEKEND

6 (a) The Saturday and Sunday prior to opening day of spring turkey season
7 shall be youth turkey hunting weekend.

8 (b) A person who is age 15 and under, ~~who has at least one parent or a~~
9 ~~guardian who is a legal resident of Vermont, and~~ who has successfully
10 completed a hunter safety course, may take one wild turkey during youth
11 turkey hunting weekend in accordance with the rules of the board. In order to
12 hunt under this section, a young person shall also hold valid hunting and turkey
13 licenses under section 4255 of this title and be accompanied by an unarmed
14 adult who holds a valid hunting license and is over 18 years of age. An adult
15 accompanying a youth under this section shall accompany no more than two
16 young people at one time.

17 (c) No person shall hunt under this section on privately-owned land without
18 first obtaining the permission of the owner or occupant.
