Whereas, the unusual hours and demanding duties that are fundamental to volunteer firefighting can deter individuals from remaining in this position for an extended duration, and

Whereas, a volunteer firefighter who has remained on the job for a half-century is an extraordinary individual who merits special praise and recognition, and

Whereas, Charles Rivers joined the Brandon volunteer fire department in June 1960, and

Whereas, his leadership skills became apparent to all, and he served the department as both a lieutenant and, for several years, as its much-admired chief, and

Whereas, Charles Rivers' work ethic and dedication to the firefighting fraternity have been major contributors to the success of the Brandon volunteer fire department, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates Charles Rivers on the 50th anniversary of his service as a Brandon volunteer firefighter, and be it further

**H.C.R. 195.**

House concurrent resolution expressing regret for the sterilization of Vermonters pursuant to the Sterilization Act of 1931

Offered by: Representative Donahue of Northfield

Whereas, the state-sponsored sterilization of many Vermonters, based upon the false science and misguided social judgment that they were genetically inadequate and of poor heredity stock, is one of the most unfortunate chapters in our state's history, and

Whereas, in 1912, the General Assembly passed legislation to "authorize and provide for the sterilization of imbeciles, feeble-minded and insane persons, rapists, confirmed criminals and other defectives" which Governor John Mead vetoed on the advice of Attorney General R.E. Brown that the measure was unconstitutional in part due to its discriminatory intent and lack of due process, and

Whereas, the Senate overrode the governor, and although the House of Representatives upheld his veto after a successful Senate override, the idea of broadly based sterilization legislation was not permanently defeated, and

Whereas, Francis Galton, the cousin of Charles Darwin, coined the term "eugenics" meaning "the science of improving the genetic condition of the human race," and

Whereas, in 1925, UVM zoology professor Henry F. Perkins established the Eugenics Survey of Vermont with a stated mission to determine the extent of defective behavior and depraved immorality in the state by combining biology, education, and social work, and

Whereas, in 1927, when addressing a conference of social workers in Montpelier, Perkins reported his purportedly highly academic findings proving a blood or heredity foundation in the mental degeneration in classes of families he defined as pirate, gypsy, and chorea, and

Whereas, Perkins predicted that legislation, which he had assisted in drafting, providing for sterilizing the "socially inadequate" individuals would be introduced, and

Whereas, in Buck v. Bell, 274 US 200 (1927), U.S. Supreme Court Justice Oliver Wendell Holmes held that Virginia’s sterilization law was neither unconstitutional nor a denial of due process, and

Whereas, in 1931, as a result of the pseudoscience and hearsay that permeated the reports of the Vermont Eugenics Survey, as well as the establishment of the Vermont Commission on Country Life, that in part was an expansion of the survey’s activities, the General Assembly adopted Act No. 174, “An Act for Human Betterment By Voluntary Sterilization,” which was intended:

to prevent the procreation of idiots, imbeciles, feeble-minded or insane persons, when the public welfare of idiots, imbeciles, feeble-minded or insane persons likely to procreate, can be improved by voluntary sterilization, and

Whereas, as a result of this legislation, a large number of individuals were subjected to this state-sponsored sterilization program, many without their knowledge or consent, and

Whereas, although the Eugenics Survey was ended in 1936, and the forced sterilizations ultimately halted, the damage to many Vermont families was widespread, and poor Irish and Italian immigrants, along with other persons in poverty, were among those targeted, and

Whereas, individuals diagnosed with mental disabilities and persons of French Canadian and Abenaki ancestry were disproportionately affected and harmed, and

Whereas, it is impossible for the General Assembly to undo the grievous damage that was inflicted on these persons and their families, but it can issue a strong statement denouncing this dark chapter in Vermont’s history to demonstrate the legislature’s resolve to guard against such events occurring in the future, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly expresses its profound sorrow and sincere regret that such a program of sterilizations was sanctioned under an act of this legislative body.

Whereas, the 2009 championship running Cougars were Trevor Bibb, Nick Marshall, Jason Hardacre, Chris Scanlon, Hayden Bove, Derrek Schultz, Nick Shallow, Ethan Self, Tom Kitsos, and Braden Yeates, and

Whereas, Coach Bill Eschholz trained his students to succeed on the running courses by instilling in them a sense of purpose and by providing valuable technical instruction, now therefore be it

House concurrent resolution in memory of retired Vergennes fire chief Ralph J. Jackman

Whereas, Ralph Jackman was born in Bristol, VT in 1924 and resided in Addison County his entire life except for college and military service, and

Whereas, he left his studies at St. Michael's College to serve in the U.S. military during World War II, fought in the Battle of the Bulge, and remained a member of the U.S. Army Reserve until 1972, and

Whereas, for 43 years, Ralph Jackman and his brother, Charles, owned Jackman Fuels, Inc., and

Whereas, Ralph Jackman joined the Vergennes fire department in 1947 and mastered the skills needed to extinguish blazes under all possible circumstances, and

Whereas, based on his strong leadership skills, in 1954, Ralph Jackman was selected as the department's chief, and retained his post for a remarkable 55 years until his recent retirement in November 2009, and

Whereas, while Ralph Jackman was chief, Vermont's smallest city's fire department constructed a new fire station, pioneered the use of a hose reel truck and a four-inch hose, and established the state's first fire cadet program, and

Whereas, statewide, his firefighting colleagues recognized his administrative capabilities and twice elected him president of the Vermont State Firefighters Association, and

Whereas, closer to home, Ralph Jackman served a term as president of the Addison County Firefighters Association in which he held a lifetime membership, and

Whereas, Ralph Jackman was the recipient of professional firefighting honors, including being named the Robert B. King Fire Chief of the Year and the Francis J. Shorkey Fire Chief of the Year, and in 2008, U.S. Senator Bernie

Sanders placed a statement on Ralph Jackman's accomplishments into the Congressional Record, and

Whereas, he actively worshiped as a parishioner at Saint Peter's Roman Catholic Church and participated in many civic organizations, and

Whereas, Ralph Jackman established a family tradition as three of his grandsons are career firefighters, and five great-grandsons volunteer in local departments, and

Whereas, this inspiring community leader and public servant died in the presence of his loving family on January 2, 2010, at the age of 85, and his survivors include his wife, Myrle, five daughters, Lynn, Catherine, Christine, Susan, and Carleen, his daughter-by-heart, Deborah Senesac, 12 grandchildren, three step-grandchildren, and 12 great-grandchildren, now therefore be it

Whereas, the boys' team claimed not only a first-place divisional standing, but also the division's individual winner who completed the 5-kilometer course in a time of 18:35, and

Whereas, the 2009 Vermont state cross-country title represented the ninth for the boys and fourth for the girls,

Whereas, the championship Harwood Highlander boys were Tim Shepard, Nick Wizniewski, Zachary Munro, Dylan Thompson, Nathan Cutler, Geordy Aitken, and Patrick Meany, and

Whereas, both the girls (4th), and boys (5th), were among the top six finishers among all three divisions, earning each team a slot at the New England high school cross-country championship meet that was held in Manchester, Connecticut on November 14, and

Whereas, the boys raced on a muddy course surface while the girls had to compete in the throes of a torrential downpour, and both teams finished above their seeding, and

Whereas, Coach John Kerrigan, who was extremely proud of both teams' exciting results at the 2009 state cross-country championship meet, has, in over 30 years coaching a variety of sports at Harwood, led his students to 25 state championships, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the 2009 Harwood Union High School Highlanders girls' and boys' Division II championship cross-country teams, and be it further
