6 Subject: Municipal government; municipal charters; city of Montpelier;

8 Statement of purpose: This bill proposes to approve amendments to the charter

9 of the city of Montpelier.

10 An act relating to approving amendments to the charter of the city of
11 Montpelier

12 It is hereby enacted by the General Assembly of the State of Vermont:

13 Sec. 1. CHARTER APPROVAL

14 The general assembly approves the amendments to the charter of the city of

15 Montpelier as set forth in this act. Proposals of amendment were approved by

16 the voters on November 2, 2010.

17 Sec. 2. MERGER APPROVAL

18 The general assembly approves the merger of the Berlin Fire District No. 1

19 and the city of Montpelier. The merger was approved by the voters of the

20 Berlin Fire District No. 1 and the city of Montpelier on March 2, 2002, and

1 was confirmed by the voters of the Berlin Fire District No. 1 and the city of
2 Montpelier on November 2, 2010.

3 Sec. 3. 24 App. V.S.A. chapter 5 § 317 is amended to read:

4 § 317. COUNCIL APPOINTMENTS

5 The city council shall, pursuant to Subchapter 10 of this charter, appoint a
6 city manager, city treasurer, city attorney, and city representative to the Central
7 Vermont Regional Planning Commission and may remove any such appointee
8 and appoint another. The city council shall also appoint the following officers,
9 none of whom shall be members of the city council: members of the
10 Montpelier housing authority, housing and building code board of appeals,
11 ~~board of adjustment~~ development review board, and planning commission.

12 The city council shall appoint only such other officers as it is specifically
13 required to do by law. Any appointment made by the city council to fill a
14 vacancy shall be only for the balance of the unexpired term in which the
15 vacancy occurred.

16 Sec. 4. 24 App. V.S.A. chapter 5 § 509 is amended to read:

17 § 509. ELECTION OF OFFICERS

18 At the annual meeting the said city shall elect from among the legal voters
19 thereof a mayor for a term of two years; a city clerk for a term of three years; a
20 ~~city treasurer for a term of three years; three auditors for a term of three years~~
21 ~~commencing in 1985~~; one commissioner of Green Mount Cemetery for a term

1 of five years; one park commissioner for a term of five years, two school
2 commissioners, each for a term of three years, except that three school
3 commissioners shall be elected in 1974 and each third year thereafter; and one
4 council member from each district for a term of two years, who shall hold
5 office until their successors are duly elected and qualified.

6 Sec. 5. 24 App. V.S.A. chapter 5, subchapter 11 is amended to read:

7 Subchapter 11. Indebtedness; Sinking Fund;

8 Bonds and Notes for Improvement

9 § 1101. POWERS

10 The city may issue bonds or notes for any improvement authorized by
11 general or special law including this charter. The word “improvement,” as
12 used in this subchapter, shall include, apart from its ordinary signification, the
13 acquisition of land, the construction or purchase or remodeling of buildings or
14 additions, the purchase and installation of furnishings or equipment for any
15 new or existing improvement or department, the construction of water works,
16 the construction of sewers and sewage treatment or disposal plants, the
17 construction of streets or bridges or sidewalks, the acquisition and construction
18 of facilities for the production and delivery of heat or electricity and of
19 devices, facilities, and other measures to meter electricity, conserve energy, or
20 promote efficient energy use, and the acquisition or construction of any other

1 work or improvement for which municipalities of the state may now or
2 hereafter be authorized to raise money.

4 § 1122. SPECIAL INDEBTEDNESS FOR WATER PURPOSES ~~OR,~~
5 SEWAGE DISPOSAL, AND HEAT AND ELECTRICITY
6 IMPROVEMENTS

7 For the purpose of owning, operating, extending, adding to, improving,
8 conducting, controlling, and managing its public water works system, a public
9 sewage disposal system ~~or both,~~ heat or electricity facilities and devices,
10 facilities, and other measures to meter electricity, conserve energy, or promote
11 efficient energy use, or any combination thereof, the city, by action of the city
12 council, in lieu of the issuance of bonds or the levy of taxes and in addition to
13 any other lawful methods or means of providing for the payment of
14 indebtedness shall have the power to provide for or to secure the payment for
15 all or a part of the cost of purchasing, acquiring, leasing, constructing,
16 extending, adding to, improving, conducting, controlling, operating, or
17 managing its said water works system ~~or a,~~ public sewage disposal system, ~~or~~
18 ~~both,~~ heat or electricity facilities and devices, facilities, and other measures to
19 meter electricity, conserve energy, or promote efficient energy use, or any
20 combination thereof by pledging, assigning, or otherwise hypothecating all or
21 any part of the net earnings or profits derived, or to be derived from the

1 operation thereof. To that end the city council shall have full power to
2 authorize and direct the execution and issuance of contracts and evidences of
3 indebtedness as may be necessary to carry out the provisions of this section.
4 Such contracts and evidence of indebtedness shall be in such form, shall
5 contain such provision, and shall be executed as may be determined by the city
6 council. Nevertheless, no such indebtedness shall be incurred nor evidence
7 thereof be issued, nor shall such revenues be pledged, assigned, or otherwise
8 hypothecated by the city council unless and until at least a majority of the legal
9 voters of the city present and voting thereon at a duly warned meeting, called
10 for that purpose, shall have first voted to authorize the same. Such meeting
11 shall be warned and held in the same manner as meetings for the transaction of
12 ordinary business without regard to the foregoing bonds or notes for
13 improvements. Evidences of indebtedness issued as authorized herein shall be
14 payable solely from the net earnings or profits derived, or to be derived from
15 the operation of such public water works system, ~~or~~ sewage disposal system, ~~or~~
16 both heat or electricity facilities and devices, facilities, and other measures to
17 meter electricity, conserve energy, or promote efficient energy use, or a
18 combination thereof, and shall not constitute a municipal indebtedness nor
19 impose an obligation or liability upon the city to pay the same from any funds
20 of the city other than such net earnings or profits. A statement referring to the
21 limited nature of the obligation and that it has been issued under this section

1 shall be made plainly to appear in or upon each evidence of indebtedness.

2 Such certificates shall be legal investments for savings banks and trust

3 companies in the state.

9 § 1210. THERMAL ENERGY RATES

10 The city council shall establish rates to be paid for the use of heat and
11 improvements supplied by the city for the production and distribution of heat,
12 and such rates shall be called heat rates. Such heat rates shall be a lien in the
13 nature of a real estate tax upon the real estate so supplied with heat,
14 improvements for the delivery of heat, or both, and shall be collected and
15 enforced under such regulations and ordinances as the city council shall
16 prescribe.

17 § 1211. HEAT METERS

18 The city council may provide for use of meters or other devices as a
19 basis of charging users of heat supplied by the city system. and may in its
20 discretion provide for use of such devices by all users of specified classes.

1 § 1212. ELECTRICITY METERS

2 The city council may provide for meters to measure the delivery of
3 electricity for the purpose of selling electricity at wholesale or by net metering
4 pursuant to 30 V.S.A. § 219a or for other uses as authorized by law.

12 § 1301. LAYING OUT STREETS, SIDEWALKS, SEWERS, HEAT OR
13 ELECTRICITY FACILITIES AND DEVICES, FACILITIES, AND
14 OTHER MEASURES TO CONSERVE ENERGY OR TO
15 PROMOTE EFFICIENT ENERGY USE

16 The city council, upon notice to persons affected, may lay out, of any
17 convenient width, alter, maintain, establish, and change the grade of and
18 discontinue any street, road, highway, lane, alley, ~~or~~ sidewalk, or any heat or
19 electricity facilities and devices, facilities, and other measures to conserve
20 energy or to promote efficient energy use in said city and appraise and settle
21 the damage therefore; and may make, maintain, and repair such common

1 sewers and sewage disposal plants and facilities for the production and
2 distribution of heat or electricity within or without the City of Montpelier as
3 the public health or the convenience of individuals shall require. The city
4 council may take land and other property necessary to accomplish such
5 purposes on making compensation for the same, causing their proceedings to
6 be recorded in the city clerk's office in said city.

8 § 1303. SPECIAL ASSESSMENTS – STREETS ~~AND~~ SIDEWALKS, AND
9 HEAT PRODUCTION AND DISTRIBUTION IMPROVEMENTS

10 The city council, in laying out or establishing new streets ~~or~~ highways, or
11 facilities for the production and distribution of heat or electricity, and in
12 making, altering, or repairing sidewalks, and in grading, paving, acadamizing,
13 curbing, and guttering streets and highways, either at the time of laying out or
14 improving the street or making the sidewalk or after its completion, shall have
15 the power and may upon notice to the owners of adjoining lands assess the
16 owners of such lands so much of the expense of making such new street or
17 sidewalk or street improvements, or heat or electricity improvements,
18 including land damage for new streets, as the city council shall adjudge such
19 lands to be benefited thereby.

1 § 1304. SPECIAL ASSESSMENT—HEAT AND ELECTRICITY
2 IMPROVEMENTS

3 The city council shall have the power to create an energy district of the City
4 of Montpelier or part thereof and to incur indebtedness for or otherwise finance
5 by any permitted means acceptable facilities for the production and delivery of
6 heat or electricity and of devices, facilities, and other measures to meter
7 electricity to conserve energy or to promote efficient energy use on properties
8 within the district. Participation by any property owner in these improvements
9 is subject to city council approval. Persons who participate with an eligible
10 project or projects shall be subject to the requirements of this special
11 assessment. The city council shall establish the criteria and procedures for
12 participation in this special assessment.
