6 Statement of purpose of bill as introduced: This bill proposes to require

7 Medicaid coverage for home telemonitoring services.

8 An act relating to Medicaid coverage for home telemonitoring services

9 It is hereby enacted by the General Assembly of the State of Vermont:

12 ~~(a) The Agency of Human Services shall provide Medicaid coverage for~~
13 ~~services performed by home health agencies using home telemonitoring for a~~

14 ~~Medicaid beneficiary who:~~

15 ~~(1) requires after-care following surgery of the circulatory system~~
16 ~~involving cardiac valve replacement or coronary artery bypass graft surgery;~~

17 ~~(2) is diagnosed with one or more of the following conditions:~~

18 ~~(A) chronic ischemic heart disease;~~

19 ~~(B) heart failure;~~

20 ~~(C) pneumonia;~~

- 1 ~~(D) obstructive chronic bronchitis with acute exacerbation;~~
- 2 (E) chronic obstructive pulmonary disease (COPD);
- 3 (F) asthma with COPD;
- 4 (G) preeclampsia;
- 5 (H) diabetes; or
- 6 (I) myocardial infarction; or
- 7 (3) exhibits two or more of the following risk factors:
- 8 (A) two or more hospitalizations in the prior 12-month period;
- 9 (B) frequent or recurrent emergency room admissions;
- 10 (C) a documented history of poor adherence to ordered medication
- 11 regimes;
- 12 (D) a documented history of falls in the prior six-month period;
- 13 (E) limited or absent informal support systems;
- 14 (F) living alone and being home alone for extended periods of
- 15 time; or
- 16 (G) a documented history of challenges accessing care.
- 17 (b) The Agency shall ensure that clinical information gathered by a home
- 18 health agency while providing home telemonitoring services is shared with the
- 19 patient's treating health care professionals and may impose other reasonable
- 20 requirements on the use of home telemonitoring services.

Sec. 1. 33 V.S.A. § 1901g is added to read:

§ 1901g. MEDICAID COVERAGE FOR HOME TELEMONITORING SERVICES

(a) The Agency of Human Services shall provide Medicaid coverage for home telemonitoring services performed by home health agencies or other qualified providers as defined by the Agency of Human Services for Medicaid beneficiaries who have serious or chronic medical conditions that can result in frequent or recurrent hospitalizations and emergency room admissions. The Agency shall use evidence-based best practices to determine the conditions or risk factors to be covered.

(b) A home health agency or other qualified providers as defined by the Agency of Human Services shall ensure that clinical information gathered by the home health agency or other qualified providers as defined by the Agency of Human Services while providing home telemonitoring services is shared with the patient’s treating health care professionals. The Agency of Human Services may impose other reasonable requirements on the use of home telemonitoring services.

(c) As used in this section:

(1) “Home health agency” means an entity that has received a certificate of need from the State to provide home health services and is certified to provide services pursuant to 42 U.S.C. § 1395x(o).

(2) "Home telemonitoring service" means a health service that requires scheduled remote monitoring of data related to a patient's health, in conjunction with a home health plan of care, and access to the data by a home health agency or other qualified providers as defined by the Agency of Human Services.

Sec. 2. GRANT FUNDING

The Department of Vermont Health Access and home health agencies shall seek to maximize opportunities for grant funding to offset start-up, equipment, technology, maintenance, and other costs related to home telemonitoring in order to minimize the expense to the Medicaid program.

Sec. 3. EFFECTIVE DATE

This act shall take effect on July 1, 2014.
