RE: 2014 Act 186 – Vantage Performance Measure Budget Programs
DATE: August 18, 2014 (supplemental to July 30, 2014 report)

For the FY 2015 Governor’s Recommended Budget Submission, Vantage, the statewide budget development system, included Outcomes, Performance Measures and \$ budget information for 13 programs, across 11 different departments. For FY 2016, including the 13 programs from last year’s pilot program, we have asked to have performance measure data for, at least, one program from each of the 30 units of government participating. The selection processes, for which new programs may be included in the Vantage system, are underway. We are targeting a due date in early- to mid- October for program selection, following the release of the FY 2016 Budget Instructions.
