

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Natural Resources and Energy to which was referred
3 House Bill No. 823 entitled “An act relating to encouraging growth in
4 designated centers and protecting natural resources” respectfully reports that it
5 has considered the same and recommends that the bill be amended by striking
6 out all after the enacting clause and inserting in lieu thereof the following:

7 * * * Amendments to 10 V.S.A. chapter 151 (Act 250) * * *

8 Sec. 1. 10 V.S.A. § 6001 is amended to read:

9 § 6001. DEFINITIONS

10 In this chapter:

11 * * *

12 (3)(A) “Development” means each of the following:

13 * * *

14 (iv) The construction of housing projects such as cooperatives,
15 condominiums, or dwellings, or construction or maintenance of mobile homes
16 or ~~trailer~~ mobile home parks, with 10 or more units, constructed or maintained
17 on a tract or tracts of land, owned or controlled by a person, within a radius of
18 five miles of any point on any involved land, and within any continuous period
19 of five years. However:

20 (I) A priority housing project shall constitute a development
21 under this subdivision (iv) only if the number of housing units in the project is:

1 (aa) 275 or more, in a municipality with a population of
2 15,000 or more;

3 (bb) 150 or more, in a municipality with a population of
4 10,000 or more but less than 15,000;

5 (cc) 75 or more, in a municipality with a population of 6,000
6 or more but less than 10,000.

7 (dd) 50 or more, in a municipality with a population of
8 3,000 or more but less than 6,000;

9 (ee) 25 or more, in a municipality with a population of less
10 than 3,000; and

11 (ff) notwithstanding subdivisions (aa) through (ee) of this
12 subdivision (iv)(I), 10 or more if the construction involves the demolition of
13 one or more buildings that are listed on or eligible to be listed on the State or

16 **Historic Preservation has determined that the proposed demolition will**
17 **have no adverse effect, will have no adverse effect if specified conditions**
18 **are met, or will have an adverse effect that will be adequately mitigated.**
19 Any imposed conditions shall be enforceable through a grant condition, deed
20 covenant, or other legally binding document.

1 (II) The determination of jurisdiction over a priority housing
2 project shall count only the housing units included in that discrete project.

3 (III) Housing units in a priority housing project shall not count
4 toward determining jurisdiction over any other project.

6 units that is are rented by the occupants whose gross annual household income

3 (a) Before granting a permit, the ~~district commission~~ District Commission

6 (5)(A) Will not cause unreasonable congestion or unsafe conditions with
7 respect to use of the highways, waterways, railways, airports and airways, and
8 other means of transportation existing or proposed. *[Note: deleted previously*
9 *proposed changes to 5(A).]*

10 (B) As appropriate, will incorporate transportation demand
11 management strategies and provide safe access and connections to adjacent
12 lands and facilities and to existing and planned pedestrian, bicycle, and transit

12 Settlement patterns. To promote Vermont’s historic settlement pattern of
13 compact village and urban centers separated by rural countryside, a permit will

15 when it is demonstrated by the applicant that in addition to all other applicable
16 criteria, the development or subdivision:

17 (i) will make efficient use of land, energy, roads, utilities, and
18 other supporting infrastructure;

17 **§ 6086b. DOWNTOWN DEVELOPMENT; FINDINGS**

18 Notwithstanding any provision of this chapter to the contrary, each of the
19 following shall apply to a development or subdivision that is completely within
20 a downtown development district designated under 24 V.S.A. chapter 76A and

1 for which a permit or permit amendment would otherwise be required under
2 this chapter:

3 (1) In lieu of obtaining a permit or permit amendment, a person may
4 request findings and conclusions from the Board, which shall approve the
5 request if it finds that the development or subdivision will meet subdivisions
6 6086 (a)(1) (air and water pollution), (2) (sufficient water available), (3)
7 (burden on existing water supply), (4) (soil erosion), (5) (traffic), (8) (historic
8 sites and rare and irreplaceable natural areas only) (8)(A) (endangered species;
9 necessary wildlife habitat), (9)(B) (primary agricultural soils), (9)(C)
10 (**productive forest** soils), (9)(F) (energy conservation), and (9)(K) (public
11 facilities, services, and lands) of this title.

12 (2) The request shall be complete as to the criteria listed in subdivision
13 (1) of this subsection and need not address other criteria of subsection (a) of
14 this section.

15 (A) The requestor shall file the request in accordance with the
16 requirements of subsection 6084(a) of this title, except that the filing shall
17 be with the Board, and the requestor shall provide a copy of the request to
18 each agency and department listed in subdivision (3) of this section.

19 (B) Within five days of the request's filing, the Chair of the Board
20 shall determine whether the request is complete. Within five days of the date
21 the Chair determines the request to be complete, the Board shall provide notice

1 of the complete request to each person required to receive a copy of the filing

4 natural resources, other than primary agricultural soils. In this subdivision (E),
5 “important natural resources” shall have the same meaning as under 24 V.S.A.
6 § 2791.

7 (F) The Secretary of Agriculture, Food and Markets or designee shall
8 submit a written determination on whether the improvements will reduce or
9 convert primary agricultural soils and on whether there will be appropriate
10 mitigation for any reduction in or conversion of those soils.

11 **(4) Any person may submit written comments or ask for a hearing**
12 **within 30 days of the date on which the Board issues notice of a complete**
13 **request. If the person asks for a hearing, the person shall include a**
14 **petition for party status in the submission. The petition for party status**
15 **shall meet the requirements of subdivision 6085(c)(2) of this title, except**

6 complete request under this section or, if it holds a hearing, within 15 days of

9 located, to each State agency listed in subdivision (3) of this section, to the
10 municipality, to the municipal and regional planning commissions for the

4 § 6093. MITIGATION OF PRIMARY AGRICULTURAL SOILS

5 (a) Mitigation for loss of primary agricultural soils. Suitable mitigation for
6 the conversion of primary agricultural soils necessary to satisfy subdivision
7 6086(a)(9)(B)(iv) of this title shall depend on where the project tract is located.

8 (1) Project located in designated downtown, growth center, or
9 neighborhood development area. If the project tract is located in a ~~designated~~
10 downtown development district, growth center, or neighborhood development
11 area associated with a downtown development district designated under
12 24 V.S.A. chapter 76A, an applicant who complies with subdivision
13 6086(a)(9)(B)(iv) of this title shall deposit an offsite mitigation fee into the
14 Vermont ~~housing and conservation trust fund~~ Housing and Conservation Trust
15 Fund established under section 312 of this title for the purpose of preserving
16 primary agricultural soils of equal or greater value with the highest priority
17 given to preserving prime agricultural soils as defined by the U.S. Department

16 shall be preserved inside designated downtowns, growth centers, and

19 acreage or fees, or some combination of these measures, shall be as specified
