5 Subject: Municipal government; municipal charters; Town of West Fairlee;  
6 adoption and codification

7 Statement of purpose of bill as introduced: This bill proposes to approve the  
8 adoption of and codify the charter of the Town of West Fairlee.

9 An act relating to approval of the adoption and codification of the charter of  
10 the Town of West Fairlee

11 It is hereby enacted by the General Assembly of the State of Vermont:

12 Sec. 1. CHARTER APPROVAL

13 The General Assembly approves the adoption of and codifies the charter of  
14 the Town of West Fairlee as set forth in this act. The voters approved the  
15 charter on March 18, 2015.

16 Sec. 2. 24 App. V.S.A. chapter 155B is added to read:

17 CHAPTER 155B. TOWN OF WEST FAIRLEE

18 § 1. TOWN TREASURER

19 (a) The Selectboard shall appoint a Town Treasurer, in the manner set forth  
20 in subsection (b) of this section. The appointee shall be competent in the

1 keeping of records, investments, and accounting, and shall serve at the pleasure  
2 of the Selectboard. The person chosen need not be a resident or voter of  
3 the Town.

4 (b)(1) Prior to appointing a Treasurer, the Selectboard shall appoint a  
5 committee to review and recommend to the Selectboard qualified candidates  
6 for the position of Treasurer.

7 (2) The committee shall be composed of two members of the  
8 Selectboard, the Town Clerk, a lister, and three residents of the Town.

9 (3) The committee shall have the authority to solicit candidates,  
10 advertise notice of a vacancy in the Treasurer's position, and make an  
11 investigation of a candidate's credentials and background as the committee  
12 deems appropriate. Upon completion of the investigation and interviewing of  
13 candidates, the committee shall submit to the Selectboard the names of those  
14 candidates deemed qualified for the position.

15 (c) The Selectboard shall appoint a Treasurer from that list, if applicable, or  
16 shall notify the committee that none of the candidates shall be appointed, not  
17 later than 30 days following submission of the names of candidates deemed  
18 qualified by the committee.

19 (d) Members of the committee described in subsection (b) of this section  
20 shall serve until a Treasurer is appointed by the Selectboard. Meetings of

1 the committee shall be conducted in accordance with the Vermont Open  
2 Meeting Law.

3 (e) In case of a vacancy, until such time as a Treasurer is appointed  
4 pursuant to this section, the Selectboard shall appoint an interim Treasurer  
5 or manager.

6 (f) The Treasurer shall:

7 (1) Perform the duties required by State statutes or as provided by  
8 this chapter.

9 (2) Promptly deposit funds coming into his or her hands in such  
10 depositories as may be designated by the Selectboard.

11 (3) Invest Town funds, with the approval of the Selectboard.

12 (4) Keep such books and accounts as required by the Selectboard.

13 (5) Make monthly reports to the Selectboard of the financial activities of  
14 the Town. Such reports shall include:

15 (A) a listing of all expenditures during the preceding month;

16 (B) a listing of all revenue received during the preceding month,  
17 indicating the source of such revenues;

18 (C) an accounting of all reserve funds of the Town; and

19 (D) a statement showing the balance in the general, highway, and all  
20 special funds at the end of the preceding month.

21 (6) Perform the duties of the Collector of Current Taxes.

1           (7) Perform such other duties as specified in the accounting and  
2           financial policies adopted by the Selectboard.

3           Sec. 3. TRANSITIONAL PROVISIONS; ELECTED TOWN TREASURER

4           Notwithstanding the provisions of Sec. 2 of this act, 24 App. V.S.A.  
5           chapter 155B, § 1 (Town Treasurer), that provides that the office of Town  
6           Treasurer shall be appointed by the Selectboard, an elected Town Treasurer in  
7           office immediately prior to the effective date of that section may continue to  
8           hold that office for the remainder of his or her term. However, that elected  
9           Town Treasurer shall perform the duties set forth in 24 App. V.S.A.  
10          chapter 155B, § 1(f) (Town Treasurer duties) in Sec. 2 of this act. At the end  
11          of the elected Town Treasurer's term of office or, in the case of a vacancy in  
12          his or her office, the provisions of Sec. 2 of this act, 24 App. V.S.A. chapter  
13          155B, § 1, shall apply.

14          Sec. 4. EFFECTIVE DATE

15          This act shall take effect on passage.
