H.C.R. 31.

House concurrent resolution in memory of Marion Pritchard

Offered by: Representatives Frenier of Chelsea and Graham of Williamstown

Whereas, Marion van Binsbergen was a Dutch gentile whom the Nazis falsely imprisoned and tortured early in their occupation of Holland, and

Whereas, following her release, Marion van Binsbergen was horrified when she witnessed Nazi officials violently force a group of Jewish youngsters, residents of a children's home, into a truck taking them to their probable deaths in Nazi concentration camps, and

Whereas, in response, she joined the Dutch resistance registering Jewish infants as her own and helping Jewish children acquire food ration cards, medical care, and false identification papers, and

Whereas, for two and one-half years, she resided with a Jewish father and his three children in the servants' quarters of a country estate and shot and killed a Dutch policeman and Nazi sympathizer who was about to discover the family, and

Whereas, following World War II, Marion van Binsbergen worked for the United Nations in Germany where she met her future husband, former American Army Captain Anton Pritchard, and

Whereas, the Pritchard family moved to Vershire in the 1970s, and Marion Pritchard compiled an extensive collection of Holocaust literature that she donated to the Vershire Public Library, and

Whereas, Yad Vashem, the World Holocaust Remembrance Center in Jerusalem, honored her as Righteous Among the Nations and the University of Michigan presented her its Wallenberg Medal, and she participated in oral history and film projects documenting Holocaust rescue efforts, and

Whereas, Marion Pritchard died in Washington, D.C., on December 11, 2016, and her survivors include her sons, Arnold, Ivor, and Brian, now therefore be it

That the General Assembly extends its sincere condolences to the family of Marion Pritchard, and be it further

Whereas, cardiovascular diseases and stroke kill one woman every 80 seconds in the United States, and

Whereas, cardiovascular diseases affect an estimated 44 million women in the United States, and

Whereas, 90 percent of women have one or more risk factors for developing heart disease or stroke, and

Whereas, only 36 percent of African American women and 34 percent of Hispanic women know that heart disease is their greatest health risk, the comparable percentage for white women two decades ago, and

Whereas, more women should be encouraged to call 911 when they experience any heart attack symptoms, and

Whereas, the American Heart Association's Go Red For Women motivates women to learn their family history and to meet with a healthcare provider to determine their risk for cardiovascular diseases and stroke, and

Whereas, women involved with Go Red For Women live healthier lives, and

Whereas, Go Red For Women encourages women to take control of their heart health by knowing and managing five important medical measurements: total cholesterol, HDL (good) cholesterol, blood pressure, blood sugar, and body mass index, and

Whereas, today, February 3, 2017, the promotion of women's healthy lifestyles and prudent medical monitoring are of particular focus, and many persons are wearing red to acknowledge the commendable work of the American Heart Association's Go Red For Women, now therefore be it

House concurrent resolution honoring Bonnie and Timothy Burke for their outstanding work at Wilson House in East Dorset

Whereas, in 1852, the local entrepreneur Ira Cochran opened a new hotel in the village of East Dorset, and

Whereas, by the late 19th century, the Wilson family owned an interest in the hotel that in 1895 was named the Wilson House, and which, on November 26 of that year, was the birthplace of William G. Wilson, and

Whereas, William Wilson was the unidentified Bill W. who cofounded Alcoholics Anonymous (AA) in 1935, and

Whereas, in 1987, Ozzie Lepper purchased the then-deteriorating Wilson House, restoring it as a hotel, a respite site for AA participants, and as a memorial to William Wilson, and

Whereas, the mission of the now nonprofit Wilson House is "to responsibly maintain the historic birthplace, memory, spirit, and purpose of Bill Wilson," and

Whereas, since its reopening in the late 1980s, Wilson House has been a spiritually-based organization that "fosters community relations and avoids commercialism," and

Whereas, Bonnie Burke is devoted to her Christian faith and had spent much of her time helping the disabled as her late first husband had been disabled for many years, and

Whereas, after her husband's death, she was invited on a blind date with Ozzie

Lepper who explained the role of Wilson House and discussed the importance of AA participants thanking God for the sobriety they have achieved, and

Whereas, Bonnie and Ozzie married, and she became a critical player in the restoration of Wilson House, its programming, and the development of the adjacent Griffith Library that houses memorabilia of William Wilson, and

Whereas, in 2011, after Ozzie Lepper had died, Bonnie married Tim Burke who has been a loyal supporter of and participant in his wife's involvement with Wilson House, and

Whereas, Bonnie Burke is now writing a book about Wilson House, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors Bonnie and Timothy Burke for their outstanding work at Wilson House in East Dorset, and be it further

House concurrent resolution designating February 8, 2017 as Farm to School Awareness Day at the State House

Offered by: All Members of the House

Whereas, 2007 Acts and Resolves No. 24 established the Rozo McLaughlin Farm-to-School Program (the program) "to improve the health and welfare of Vermont's students" by establishing a grant program "for the purpose of helping Vermont schools develop relationships with local farmers," and

Whereas, according to a report that the Center for Rural Studies prepared for the Vermont Farm to School Network, every dollar spent in Vermont schools on local food purchasing contributes an additional 60 cents to the local economy, and

Whereas, data from the Vermont Agency of Agriculture, Food, and Markets as of January 2016 recorded that the program was serving 120 schools and more than 30,000 students, and

Whereas, stated differently, Vermont Food Education Every Day (VT FEED) calculates that two-thirds of Vermont schools participate in some type of farm to school activities, and 95 percent of the farm food students eat originates in Vermont, and

Whereas, schools with farm to school programs have reported twice the national average for vegetable consumption, and

Whereas, the Department of Health reports that 12.4 percent of high school students are obese, too many others are overweight, and local schools' farm to school participation can potentially lead to healthier diets and lower this disturbing adolescent health situation, and

Whereas, a continuing poor diet can lead to chronic disease and, in the long term, even death, and

Whereas, at the opposite end of the food spectrum, Hunger Free Vermont reports that 17 percent of Vermont children reside in food insecure homes and nutritious school meals can provide these youngsters critical nourishment, and

Whereas, today, February 8, 2017, participants in farm to school programs are visiting the State House to remind the General Assembly of farm to schools' importance for both students and farmers, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates February 8, 2017 as Farm to School Awareness Day at the State House, and be it further

House concurrent resolution commemorating the 240th anniversary of the Battle of Hubbardton

Offered by: Representatives Devereux of Mount Holly, Canfield of Fair Haven, and Helm of Fair Haven

Offered by: Senators Collamore, Flory, and Mullin

Whereas, on July 5, 1777, during the Revolutionary War, American troops evacuated Fort Ticonderoga, located on Lake Champlain's western shore, on observing British cannons mounted on high ground overlooking the fort, and

Whereas, General Arthur St. Clair led the American forces west towards Castleton, stopping along the way in Hubbardton to allow the American rear guard to arrive, and

Whereas, on July 6, 1777, British General Simon Fraser discovered that the Americans had abandoned Fort Ticonderoga and left in pursuit with a force composed of grenadiers, light infantry, components of the 24th Regiment, loyalists, and American Indian scouts, and

Whereas, although the American rear guard had yet to arrive at Hubbardton, General St. Clair decided to proceed towards Castleton leaving Seth Warner, commanding the Green Mountain Boys, and Colonel Nathan Hale, leading the 2nd New Hampshire Regiment, to wait for the balance of the American troops, and

Whereas, when the American rear guard arrived late on July 6, 1777, Warner decided to keep his men overnight at Hubbardton, establishing defensive positions and sending patrols to watch the road heading west towards Fort Ticonderoga, and

Whereas, the first British troops arrived in Hubbardton near dawn on July 7, 1777, surprising some of the Americans, but they soon repositioned themselves and fired mightily at the exhausted British, and

Whereas, although the Americans did weaken their enemies' left flank, British grenadiers ultimately repelled the Americans with both sides sustaining significant casualties, including the fatal wounding of the American Colonel Ebenezer Francis, whom the British buried with their forces as a sign of respect, and

<u>Whereas</u>, the Battle of Hubbardton was the only Revolutionary War military engagement fought in Vermont, as the Battle of Bennington, despite its name, occurred in nearby New York, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the 240th anniversary of the Battle of Hubbardton, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Vermont Historical Society, the Vermont Division for Historic Preservation, and the Hubbardton Town Clerk.

Whereas, since July 11, 1798, African Americans were barred from enlistment in the U.S. Marine Corps, and

Whereas, on June 25, 1941, President Franklin Roosevelt issued an executive order barring racial discrimination in military enlistment, and

Whereas, in 1942, the first modern era African American Marines trained in a segregated unit at Montford Point Camp at Camp Lejeune, North Carolina, but an integrated U.S. Marine Corps required President Truman to issue a further executive order on July 26, 1948, and

Whereas, one of these pioneering African American U.S. Marines was Nathaniel

Boone of Englewood, New Jersey, who enlisted in 1946 and served as a radar technician, and

Whereas, after his honorable military discharge, Nathaniel Boone used funds made available under the GI Bill of Rights to attend Bates College, where he met his wife, Harriet Howel, and upon graduating from Bates, he earned a law degree at Boston University, and

Whereas, for 30 years, Nathaniel Boone practiced law in New Jersey, and

<u>Whereas</u>, in 1957, Nathaniel and Harriet Boone honeymooned in Manchester and, enchanted with this Vermont resort community, they returned regularly, purchasing a home in nearby Winhall in 1972 before becoming permanent residents in 1989, and

Whereas, in retirement, Nathaniel Boone has assumed active community roles, including volunteering with the Manchester Music Festival; serving as a tour guide and board chair at Hildene, the home of President Abraham Lincoln's son, Robert Todd Lincoln; and as an active member, along with his wife, at the local First Congregational Church, and

Whereas, in 2012, the U.S. Congress awarded the Congressional Gold Medal, one of the nation's two highest civilian honors, to Nathaniel Boone and each of the other surviving Montford Point U.S. Marines, and

Whereas, Nathaniel Boone attributes the opportunities resulting from his Marine Corps service as paving the path to his personal success and that of his daughter, Daryl, a Harvard University librarian; his son, Peter, a Connecticut orthopedic surgeon; and each of his three grandchildren, and

Whereas, the 2012 Winhall Town Report was dedicated to Nathaniel Aaron Boone, now therefore be it

That the General Assembly honors Nathaniel A. Boone of Winhall for his pioneering national service, and be it further

Whereas, the murder of Trayvon Martin on February 26, 2012 in Florida sparked outrage in the Black community, and

Whereas, a strong perception following this homicide that the nation placed a low value on the lives of Black Americans led Alicia Garza, Opal Tometi, and Patrisse Cullors to form the Black Lives Matter movement (BLM), and

Whereas, BLM was formed to affirm Black Americans' humanity and resilience in the face of deadly oppression, and

Whereas, the killing of Michael Brown, 18 years of age, in Ferguson, Missouri, on August 9, 2014, ignited major growth in BLM, and

Whereas, the deaths of at least 250 unarmed Black Americans in 2016 reaffirmed the continuing crisis in the relationship between Black Americans and law enforcement officials, and

<u>Whereas</u>, BLM's literature states, "Black Lives Matter Vermont is a growing network of individuals, families and businesses invested in the liberation of Black Vermonters, and the deactivation of systemic racism endured by all people of color in our state," and

Whereas, the repeated incidents of violence against Black Americans have demonstrated the core reason that BLM was established, and

<u>Whereas</u>, BLM supporters in Vermont, who include members of all races, have stood in solidarity with this nationwide movement, and

Whereas, according to the U.S. Census, as of July 1, 2015 only 1.3 percent of Vermonters are Black, and they still face discrimination in many aspects of their daily lives, and

Whereas, the General Assembly has acknowledged the problems Black

Vermonters encounter with public safety officials, and in 2012 (Act 134) and 2014 (Act 193), the General Assembly enacted legislation leading to the establishment of biasfree policing policies, and a greater law enforcement awareness and readiness to adopt those policies, and

Whereas, the Vermont Black Lives Matter movement has spurred a continuing dialogue to ensure that all Vermonters are guaranteed fundamental civil rights and equality, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the importance of the Black Lives Matter Movement in the U.S. and Vermont Black communities, and be it further
