

**Vermont Criminal Justice Training Council
Report to the Senate and House Committees on Judiciary
Implementation Plan for Act No. 193, Sec. 3, 20 VSA 2366
(Law Enforcement Agencies; Fair and Impartial Policing Policy)**

October, 2014

Act No. 193, Sec. 3, 20 VSA 2366(a)(1), as amended, states:

§ 2366. LAW ENFORCEMENT AGENCIES; BIAS-FREE FAIR AND IMPARTIAL POLICING POLICY; RACE DATA COLLECTION

(a)(1) No later than January 1, 2013 Except as provided in subdivision (2) of this subsection, on or before September 1, 2014, every State, local, county, and municipal law enforcement agency, and every constable who exercises law enforcement authority pursuant to 24 V.S.A. § 1936a and who is trained in compliance with section 2358 of this title, shall adopt a fair and impartial policing policy. The policy shall contain substantially the same elements of either the current Vermont State Police fair and impartial policing policy or the most current model policy issued by the Office of the Attorney General.

The same act and statute, subsection (d), requires the Vermont Criminal Justice Training Council (VCJTC) to report on the following:

(d) On or before October 15, 2014, and annually thereafter on April 1, the Criminal Justice Training Council shall report to the House and Senate Committees on Judiciary which departments and officers have adopted a fair and impartial policing policy, which policy has been adopted, and whether officers have received training on fair and impartial policing.

Required Policy

Developing the above report (see attached) was fairly straightforward for state, municipal, and county agencies. The leaders of the agencies were notified by their associations or commissioners of the requirement and provided the Council with the information. In a relatively few instances, some agencies did not report by the September 1 deadline, but subsequent follow-up contact by the Council showed that the agency did have a compliant policy in place prior to the 09/01 deadline. In two instances, the agency head was not aware of the new requirement and had not acted on updating the agency policy, so that individual was informed that, under Act 193, that agency was deemed to have adopted the model policy as issued by the Office of the Attorney General. The agency head was provided with information on where the policy could be located and

downloaded, and informed that the agency was now bound by that policy, effective immediately.

Constables proved to be far more challenging with regards to communicating the requirements of Act 193 to them and ascertaining which policy, if any, their jurisdiction had adopted. Additionally, some of the appointed constables are also the police chiefs in their communities and would, presumably, not take an enforcement action as a constable, but instead as the police chief.

The Vermont League of Cities and Towns will be sending notification to its members requesting information about the status of their constables and the existence of any fair and impartial policing policies. The response was not available by the due date of this report.

Officers Trained

As of the date of this report, 437 Vermont law enforcement officers have received the Fair and Impartial Policing training (see attached).. This particular training has only been available to VT law enforcement officers since 2012, when it was officially adopted by the VCJTC and made a mandatory training in both the full time and part time certification classes. In addition, two civilian staff members at the Vermont Police Academy have had the same training, and one of them is a trainer certified by the national program—it's that staff member who is responsible for delivering the training to law enforcement officers.

The VCJTC doesn't have the ability to determine how many law enforcement officers received the training provided by Curtis Reed, as those trainings are arranged by the agencies and there is no oversight or involvement by the Council.
