Act No. 193, Sec. 3, 20 VSA 2366
Fair and Impartial Policing Training

October 1, 2014 – April 1, 2015

Act No. 193, Sec. 3, 20 VSA 2366(d), states:

(d) On or before October 15, 2014, and annually thereafter on April 1, the Criminal Justice Training Council shall report to the House and Senate Committees on Judiciary which departments and officers have adopted a fair and impartial policing policy, which policy has been adopted, and whether officers have received training on fair and impartial policing.

From October 1, 2014, to April 1, 2015, 146 Vermont law enforcement officers received the Fair and Impartial Policing training (the report itself will indicate 157 officers, but 11 of those were instructors presenting the training and would have already been counted in the earlier report).

In the previous report, the Royalton Police Department and the Waterbury Police Department had not reported their compliance to the Council as of the report submission date. Both agencies are now compliant, and both have adopted the Attorney General's policy.
