2	§ 901. CREATION OF DEPARTMENT
3	There is created the department of information and innovation within the
4	agency of administration. The department shall have all the responsibilities
5	assigned to it by law, including the following:

7	(12) to provide technical support and services to the departments of
8	human resources and of finance and management for the statewide central
9	accounting and encumbrance system, the statewide budget development
10	system, the statewide human resources management system, and other agency

1	software developed in-house or by contractors for state government shall be
2	licensed as free software or open source software.
3	(D) For the purposes of this subdivision (13), the term "open source
4	software" requires compliance with the following criteria:
5	(i) The license for the software shall not restrict any party from
6	selling or giving away the software as a component of an aggregate software
7	distribution containing programs from several different sources. The license
8	shall not require a royalty or other fee for the sale.
9	(ii) The software program shall include source code, and shall
10	allow distribution in source code as well as compiled form. Where some form
11	of a product is not distributed with source code, there shall be a
12	well-publicized means of obtaining the source code for no more than a
13	reasonable reproduction cost preferably, downloading via the Internet without
14	charge. The source code shall be the preferred form in which a programmer
15	would modify the program. Deliberately obfuscated source code shall not be
16	allowed. Intermediate forms such as the output of a preprocessor or translator
17	shall not be allowed.
18	(iii) The software license shall allow modifications and derived
19	works and shall allow them to be distributed under the same terms as the

original software distribution.

1	(iv) The software license may restrict source code from being
2	distributed in modified form only if the license allows the distribution of
3	"patch files" with the source code for the purpose of modifying the program at
4	build time. The license shall explicitly permit distribution of software built
5	from modified source code. The license may require derived works to carry a
6	different name or version number from the original software.
7	(v) The license shall not discriminate against any person or group
8	of persons.
9	(vi) The license shall not restrict anyone from making use of the
10	program in a specific field of endeavor. For example, it may not restrict the
11	program from being used in a business or from being used for genetic research.
12	(vii) The rights attached to the program shall apply to all to whom
13	the program is redistributed without the need for execution of an additional
14	license by those parties.
15	(viii) The rights attached to the software program shall not depend
16	on the program's being part of a particular software distribution. If the
17	program is extracted from that distribution and used or distributed within the
18	terms of the program's license, all parties to whom the program is redistributed
19	shall have the same rights as those that are granted in conjunction with the

1	(ix) The license shall not place restrictions on other software that
2	is distributed along with the licensed software. For example, the license shall
3	not insist that all other programs distributed on the same medium be
4	open-source software.
5	(x) No provision of the license may be predicated on any
6	individual technology or style of interface.
