18	private school children shall stop his or her vehicle immediately and shall keep

it stationary while the flashing red signal lights are in operation.

1	(b) The driver of a vehicle need not stop upon a highway with separate		
2	roadways upon meeting or overtaking a school bus which is on a different		
3	roadway, or upon a controlled access highway where the school bus is stopped
