#### H.C.R. 256.

House concurrent resolution honoring family caregivers of persons with Alzheimer's and related diseases on the 2010 Alzheimer's Awareness Day at the state house

Offered by: All Members of the House Offered by: All Members of the Senate

Whereas, Alzheimer's disease is a devastating form of dementia that deprives individuals of life memories and their ability to function independently in society, and

Whereas, despite the growing awareness of this malady, from which large numbers of mostly older Americans suffer, no medical cure has yet been discovered, and

Whereas, Alzheimer's disease incapacitates or greatly diminishes its victims' cognitive and motor skills, and

Whereas, families of Alzheimer's victims also are greatly affected as the families reach the inevitable decision of implementing an around-the-clock home care plan or institutionalizing their loved ones, and

<u>Whereas</u>, although the hoped-for medical breakthrough to treat Alzheimer's disease is still elusive, many programs have been developed to support those with Alzheimer's disease and their families, and

Whereas, in Vermont, these services include adult day programs that provide constructive activities and companionship for individuals with Alzheimer's disease, respite programs that offer essential intervals of relief for individuals who take care of a person with Alzheimer's disease on a continual basis, and mental health clinicians who are especially trained to assist older persons with age-related mental health challenges, and

Whereas, in order to educate legislators on the complex issues related to Alzheimer's disease and related disorders, family and professional caregivers

and service support specialists are gathering at the state house on February 23, 2010, and

Whereas, these individuals perform truly heroic roles either in helping loved ones who have Alzheimer's disease or as professionals working on a broader community basis, now therefore be it

## Resolved by the Senate and House of Representatives:

That the General Assembly welcomes all of the providers of Alzheimer's disease support services on Alzheimer's Awareness Day, and be it further

Whereas, Jim Matteau joined the staff of the Windham Regional Commission (WRC) in 1985, beginning an illustrious career that continued for over two decades, and

Whereas, his first WRC position was to serve as director of the Council on Aging for Southeast Vermont, which at the time was a WRC unit, and

<u>Whereas</u>, the quality of Jim Matteau's job performance, overseeing seven senior centers in Windham and Windsor counties, impressed everyone, and in 1989, he assumed the role of WRC Associate Director, and

Whereas, a decade later, Jim Matteau was promoted to WRC Executive Director, and

Whereas, in his role as WRC Executive Director, Jim Matteau served many diverse roles such as: setting in motion solid waste planning that was implemented in every town under the commission's jurisdiction; playing an instrumental part in the establishment of Connecticut River Transit and on other transportation projects; overseeing regional planning updates; addressing Act 250 and Act 248 issues in a fair manner; and being active in energy-related issues, and

Whereas, Jim Matteau was actively involved in the Vermont Association of Planning and Development Agencies, and

Whereas, in 2001, the Northeast States Emergency Consortium honored Jim Matteau as its Vermont Emergency Manager of the Year, and

Whereas, Jim Matteau advocated actively and effectively on behalf of the WRC's member towns, and

Whereas, after 25 years on the WRC staff, and 11 as its executive director, Jim Matteau is now retiring from the commission, leaving an outstanding legacy of excellence, now therefore be it

Whereas, upon moving to Vermont, Peter Clark became immersed in municipal government and served in many local and regional roles, both elected and appointed, throughout his adult life, and

<u>Whereas</u>, he first settled in Winhall, where he held the positions of auditor and lister, and after he relocated to Londonderry, Peter Clark assumed many leadership roles in that town, and

Whereas, one of his jobs was serving as the Londonderry zoning administrator during a time when the town was experiencing an increase in residential construction of both year-round and second homes due to the town's proximity to ski resorts, and

<u>Whereas</u>, Peter Clark's zoning expertise was also put to good use while he served on the zoning board of adjustment, and he repeated his role as a lister which he had performed so well in Winhall, and

Whereas, for a remarkable 40 years, Peter Clark was a Londonderry justice of the peace, and while also serving on the board of civil authority, as does every justice of the peace, he chaired that panel for a period of time, and

Whereas, Bennington and Springfield called upon Peter Clark's knowledge of municipal finance and taxation when he served terms as tax assessor in each town, and

Whereas, Peter Clark became a respected authority on the assessment of land valuation for purposes of municipal taxation, and the Vermont Division of Property Valuation and Review (PVR) selected him as a district advisor, and in this role, he provided much-appreciated training and assistance to listers in 64 towns, and

Whereas, Peter Clark proudly exercised his best independent judgment on issues before him, and

Whereas, other PVR district advisors and listers throughout his district found Peter Clark to be a wonderful mentor and teacher, and he had a calming impact at difficult moments, and

Whereas, Peter Clark actively participated in Town Meeting Day activities, and for relaxation played golf and skied, and

Whereas, in his personal life, he was married to his wife, Sandra, for 41 years, and they were the parents of three sons, Douglas, Peter Jr., and John, and two daughters, Lisa and Heather, and were the proud grandparents of 10 grandchildren, and

Whereas, his life of public service ended on November 17, 2009, with his death at the age of 79, now therefore be it

Whereas, for much of her tenure as town clerk, Bonnie West has also been the Jamaica town treasurer and she also serves as the town agent to deed land, and

Whereas, when not working at town hall, Bonnie West might be found at the firehouse, where she is the treasurer of Jamaica Volunteer Fire & Rescue, or at the scene of a fire, and

Whereas, her husband, Gary, has served for many years as an assistant fire chief, her son Dana is a rescue lieutenant, her son Dale is the assistant chief and training officer, and Dana's wife, Danni, is a fire department member, and the three younger members of the West family—Dana, Dale, and Danni—are each trained EMTs, and

Whereas, the 2007 Jamaica town report was dedicated to the extraordinary public service of the West family, and

Whereas, a chapter in the West family's legacy of serving the town of Jamaica will end on Tuesday, March 2, 2010, when Bonnie West concludes her 17 years of service as Jamaica town clerk, now therefore be it

House concurrent resolution commending Jennifer Clark for her nursing work in Haiti

Whereas, Jennifer Clark of Northfield is an intensive care unit (ICU) nurse at Dartmouth-Hitchcock Medical Center in Lebanon, New Hampshire, and

Whereas, a team of the hospital's personnel, including Jennifer Clark, other nurses, and doctors, recently completed an 11-day special mission to Haiti where it provided urgently needed health care services to the victims of the devastating earthquake that struck the Caribbean island nation on January 12, 2010, and

Whereas, the Dartmouth team flew on a privately provided airplane, directly from the West Lebanon airport to Santo Domingo, Dominican Republic, and then proceeded by land to the Haitian capital of Port-au-Prince, and

Whereas, once they arrived at their destination, a large hospital complex that once served the city, the team was appalled at the extent of the devastation and human suffering, and

Whereas, because of the earthquake's severity, much of the hospital was unusable, and the Dartmouth team offered its medical support services from a large tent that housed 20 to 26 patients at a time, and

Whereas, the Dartmouth team also included personnel, such as a nurse anesthetist, who worked in the hospital's still usable operating room together with doctors from other major medical centers in the United States, and

Whereas, Jennifer Clark was amazed at the emotional encouragement that the patients, who had never met before arriving at the hospital, provided to each other as they began often difficult recovery regimens from injuries sustained in the earthquake, and

<u>Whereas</u>, her 11 days in Haiti were personally fulfilling and satisfying as Jennifer Clark brought her professional expertise to patients who are in dire need of extensive medical attention, and

Whereas, were it not for the willingness of health care professionals, such as Jennifer Clark, to travel to Haiti and work under the most demanding and difficult conditions, these earthquake victims would not have been afforded the chance to receive the medical care necessary to maximize their chances of resuming even a semblance of normal life, and

Whereas, Jennifer Clark exemplifies the most admirable attributes of a health care professional, and she has expressed willingness to return in the future to Haiti in order to offer her medical expertise, now therefore be it

Whereas, David Hamilton was a hard-working Vermonter who served his hometown in many ways and cared deeply about the well-being of his community, and

Whereas, he was born on April 11, 1941, and resided in Jamaica all of his 68 years, and

Whereas, for a decade, David Hamilton was the caretaker and handyman at the home of the author Pearl Buck, and

Whereas, as a small businessman, he owned an excavation company for over 20 years, and

Whereas, an entrepreneurial and industrious individual, David Hamilton would work as an excavator for local contractors while also providing caretaking, lawn mowing, and snowplowing services for individual customers, and

Whereas, another of his jobs had been as a local school bus driver, and

Whereas, when not performing any of these jobs, David Hamilton had a parallel career as a leading local official in the town of Jamaica, and

Whereas, for 23 years, David Hamilton sat on the Jamaica Selectboard, and

Whereas, as a selectboard member, he gave thoughtful consideration to the important policy issues and financial matters that were before him for consideration, and

Whereas, his role on the selectboard also required him to serve on the board of civil authority where he was responsible for reviewing property tax appeals and supervising many aspects of the electoral process, and

Whereas, David Hamilton held a seat on the town's cemetery commission, and his expertise was called upon when he was temporarily asked to perform the duties of Jamaica's road commissioner, and

Whereas, for 15 years, David Hamilton chaired the annual Vermont Green Up activities in Jamaica, and

Whereas, he served as a member of the nearby Stratton Fire Department, and

Whereas, he derived great pleasure and satisfaction from his fraternal association with the Masons and was an avid hunter, and

Whereas, in 1972, David Hamilton, who was one of seven siblings, married Janet Bell, and the Hamiltons' two children are James and Darlene, and

Whereas, on February 15, David Hamilton's life ended, tragically and prematurely, when he was killed in a logging accident in the woods of Jamaica, and

Whereas, David Hamilton's family will miss him very much, and he leaves a lasting legacy of friendship and goodwill in his community, now therefore be it

Whereas, Linda Coburn was the oldest in a family of seven children that included siblings Marty, Billie, Kathy, Carol, Mary, and David, and

Whereas, her family had owned the historic Danby Four Corners Store since the 1970s and proudly continued this ownership until the family closed the store, seemingly forever, in 2009, and

Whereas, her sister, Marty, and, earlier, her mother, Margaret, had served as the store's owners, and

Whereas, Linda Coburn married Butch Ralph, and their two children are Harry and Judy, and

Whereas, starting in the middle 1980s, Linda and Butch Ralph assumed joint managerial responsibility of the Danby Four Corners Store, and

Whereas, their joint management was truly a business partnership of equals, and Linda developed a reputation as a shrewd businesswoman who effectively and successfully continued the family's role of providing Danby residents an unusually broad variety of goods for purchase even by the standards of a Vermont general store, and

Whereas, among the items available for purchase at Danby Four Corners Store were groceries, beer and wine, gas and kerosene, ammunition, soft-serve ice cream, clothing, stringed musical instruments such as Martin guitars, banjos, and fiddles along with guitar strings, snowsuits, and boots, including LaCrosse and Sorel brands as well as western riding boots and the belts to accompany them, and

Whereas, most appealingly for local youngsters, the Danby Four Corners Store was one of the last places where penny candy could still be admired and purchased as it sat on the oak and glass-enclosed counters, and

Whereas, the Danby Four Corners Store was also a department of fish and wildlife agency for the sale of hunting and fishing licenses and served as the local video rental center, and

Whereas, the Ralph family, including Linda, Butch, their son Harry, and friends Tom Griffith and Steve Thurston enjoyed a musical camaraderie as members of a country and bluegrass band, "Family and Friends," that often played at local benefit concerts, and

Whereas, Linda Ralph was a woman of boundless energy and generosity who baked birthday cakes for local residents who lived alone and created Easter baskets for families that could not afford to purchase them for their children, and

Whereas, Linda Ralph died of pancreatic cancer on December 18, 2008, and a family tradition that had lasted over three decades ended when the Ralph family shuttered the Danby Four Corners Store in 2009, and

Whereas, her family members and many friends miss Linda Ralph and her vibrant role in Danby, and

Whereas, the Danby community has been excited to learn of plans to revive the Danby Four Corners Store under new ownership, now therefore be it

## Resolved by the Senate and House of Representatives:

That the General Assembly expresses its condolences on the death of Linda Ralph and recognizes her family's long and successful proprietorship of the Danby Four Corners Store, and be it further

Whereas, since 1995, Prudential Financial and the National Association of Secondary School Principals have presented The Prudential Spirit of Community Awards to locally nominated middle and senior high school students in each state whose volunteer projects have exhibited a special commitment to community service, and

Whereas, in a thrilling moment in the history of women's Olympic moguls skiing, 23-year-old Hannah Kearney of Norwich, a 2004 Hanover High School graduate, fulfilled her dream of becoming an Olympic gold medalist as she sped and jumped her way to a stupendous victory through fog, rain, and sleet down the 827-foot moguls course at Cypress Mountain near Vancouver, British Columbia, and

Whereas, this triumph was the product of nearly two decades of training and grueling practice that started at the age of six, and

Whereas, by the age of 12, Hannah Kearney was a top-level regional skier, and she became a national competitor the following year, and

Whereas, 2002 was an eventful year in her budding moguls-skiing career as Hannah Kearney won not only the eastern and junior national moguls crowns, but even more impressively, she clinched the duals and moguls gold medals at the Junior World Championship, and in the following year, exuding great confidence, she repeated her 2002 accomplishments, and

Whereas, proceeding fully into adult moguls competition, at age 19 she won the prestigious women's moguls world championship title, and

<u>Whereas</u>, although Hannah Kearney earned a coveted spot on the 2006 United States Winter Olympics team, her 22nd-place performance was personally disappointing, but this daughter of Norwich recreation director Jill Kearney and local carpenter Tom Kearney was not easily deterred, and

Whereas, the path to Cypress Mountain was laden with dangerous obstacles as Hannah Kearney had sustained multiple injuries since 2006, and

Whereas, in order to overcome her injuries, she battled back with unbelievable stamina, completing 1,000 jumps into the Lake Placid water pit and then spending six weeks in intensive snow training, and

Whereas, her efforts were rewarded with a berth on our nation's 2010 Olympic team as she won the U.S. trials, and then she sharpened her competitive edge with a victory in a World Cup event, and

Whereas, Hannah Kearney completed the qualifying round at Cypress Mountain in first place slightly ahead of her nearest rival, Canadian Jennifer Heil, and

Whereas, after her final run, Jennifer Heil was momentarily in the lead with 25.69 points, but Hannah Kearney immediately responded with her own powerful final run, a tightly controlled performance punctuated with perfect jumps that so impressed the judges they immediately awarded Hannah Kearney sufficient points to bring her total score to 26.63 points and assure that she would bring the 2010 women's moguls gold medal home to Vermont, and

Whereas, in celebration, she triumphantly danced around the finish area bedecked with an American flag, joyously accepting congratulatory good wishes including those of her extremely proud parents, and she has earned her place among the elite of American winter Olympians, now therefore be it
