Whereas, the team's impressive late season surge earned it the third seed in Division II playoff competition, in which the Raiders continued to display their winning ways, gaining a berth in the championship game and the opportunity to play the fourth-seeded Missisquoi Thunderbirds, and

Whereas, the Thunderbirds celebrated their first-ever boys' basketball championship appearance with a 9–5 first-quarter lead, but the scoring advantage was short-lived, and

Whereas, awakened to Missisquoi's basketball playing prowess, U-32 assumed a more offensively effective playing style in the second quarter, starting with a 6–0 opening exhibition, and left the floor at halftime with a 22–16 lead, and

Whereas, U-32 quickly learned it could not rest on its past laurels as Missisquoi's third quarter was its best with 15 points, and the Raiders barely maintained their scoring advantage with a fragile 32–31 lead, and

Whereas, the fourth quarter would prove decisive as U-32 drew on all of its skill and put on a great basketball performance, including a 17–6 run that culminated in a 52–43 victory, and won the 2010 Division II championship, and

Whereas, Raiders Jack Shea, Carter Austin-Bradley, Trevor Cote, Nathan Magne, Ryan Shea, Sam McArdle, Watumbe Noble, Brian Pellegrini, John Helme, Nolan Callahan, Zeb Bolduc, and Clark Stridsberg played wonderfully, and manager Chad Ducas fulfilled his supporting role with great competence, and

Whereas, Head Coach Dan Gandin oversaw his fourth U-32 championship squad, and his great assistant coaches Chris Hudson and Mike Macke were invaluable in the 2010 boys' basketball campaign, now therefore be it

Whereas, head coach Tim Messier and assistant coaches Greg Stokes and Mark Cattelona worked diligently all season with victory in mind, as did team program assistant Stacy Stokes, now therefore be it

House concurrent resolution commemorating the 200th anniversary of the birth of Senator Justin Smith Morrill, the father of America's land-grant colleges

<u>Whereas</u>, Justin Smith Morrill, the son of a blacksmith, was born on April 14, 1810, in Strafford, Vermont, and

Whereas, after his formal education ended at age 15, he entered the world of commerce, and

Whereas, Justin Smith Morrill retired from business at age 38 to live the life of a gentleman farmer in Strafford, and

Whereas, in 1854 he was elected to represent Vermont's Second Congressional District in the United States House of Representatives, serving a total of six terms in that chamber, and

Whereas, in 1857, when higher education was generally restricted to the teaching of theology, medicine, and philosophy to affluent white men, Representative Morrill introduced a bill in Congress that changed the course of American higher education, and

Whereas, his legislation created a national system of land-grant colleges to teach subjects related to agriculture and mechanical arts to Americans from all walks of life, as Representative Morrill explained, "in order to promote the liberal and practical education of the industrial classes," and

Whereas, the University of Vermont is one of the nation's leading land-grant colleges, and

Whereas, since the passage of the Land-Grant College Act in 1862, more than 23 million students have graduated from the 105 land-grant colleges it spawned, and

Whereas, in 1866, the Vermont General Assembly elected Justin Smith Morrill as a United States senator from Vermont, an office to which he was re-elected five times for a combined total of 43 years representing Vermont in the two houses of Congress, and

Whereas, before being elected to Congress, Justin Smith Morrill designed his Gothic Revival house in Strafford and its experimental gardens, which are its centerpiece, and

Whereas, in 1960, the United States secretary of the interior designated the Morrill Homestead as the first National Historic Landmark in Vermont, and

Whereas, in 1969, the Justin Smith Morrill Homestead was donated to the State of Vermont to be open to the public as a Vermont historic site, and

Whereas, today, April 14, 2010, marks the 200th anniversary of the birth of Justin Smith Morrill, the father of America's land-grant colleges, now therefore be it

Whereas, promoting the academic success of students who come from families with minimal economic resources and who aspire to be the first members of their family to attend college is the laudable goal of the federal TRIO programs, and, in Vermont, these important academic preparatory programs serve students at seven colleges and through the Vermont Student Assistance Corporation, and

Whereas, Upward Bound, the original federally financed college incentive program for disadvantaged students, was established in 1965 under the auspices of the federal Office of Economic Opportunity, and, in coordination with the later-established Upward Bound Math Science, helps secondary school students from financially disadvantaged families prepare for college, and

Whereas, the Talent Search Program, initially authorized in the Higher Education Act of 1965, assists students early in the college admissions and financial aid process, and

Whereas, the federal Education Amendments of 1968 reauthorized these two original programs, established Special Services for Disadvantaged Students, and united all three under the umbrella of the federal Office (now Department) of Education, and

Whereas, this threesome of special programs for students from low income backgrounds became known informally as TRIO, and

Whereas, over the ensuing decades, additional programs such as Veterans Upward Bound, Student Support Services, Educational Opportunity Centers, and the Ronald E. McNair Post-Baccalaureate Achievement Program have all been added to the TRIO mix, and

Whereas, in 1992, Congress renamed and combined all of the programs as the federal TRIO programs, and

Whereas, in the state of Vermont, Project TRIO is now serving 12,531 students and \$8,401,715 in federal dollars supports this worthy education program, and

Whereas, the federal TRIO programs continue to be a special gateway for financially disadvantaged students to achieve their higher education hopes and dreams, and

Whereas, students and administrators representing the federal TRIO programs in Vermont are visiting the state house today, Friday, March 19, 2010, and their visit provides an opportunity to recognize the important educational and societal roles of the federal TRIO programs, now therefore be it

That the General Assembly is pleased to honor the outstanding work of the federal TRIO programs in Vermont, and be it further

<u>Whereas</u>, Williamstown High School won its prior boys' basketball championship in 1986, and

Whereas, 2009–2010 was an exceptional season for the Blue Devils as they advanced through the playoff competition and confronted the Proctor Phantoms, who were seeking to match the Vermont record, in any division, of five consecutive boys' basketball championships, and

Whereas, with the support of a large local crowd of fans watching at the Barre Auditorium, the Blue Devils took to the hardwood floor ready to demonstrate their basketball prowess, and

Whereas, the Blue Devils quickly assumed command with a 7–0 lead, but it soon vanished as the Phantoms pushed ahead 15–14 at the first quarter's conclusion, and

Whereas, in the second quarter, Proctor continued to surge ahead, building a 22–14 lead that also proved fleeting when the Blue Devils rebounded with an 11–2 run that enabled Williamstown to achieve a slight but emotionally satisfying 25–24 halftime lead, and

Whereas, in this game of continual role reversal, Proctor regained its confidence and ended the third quarter one precious point ahead at 35–34, and

Whereas, the last eight minutes would truly be the decisive quarter, and Williamstown played as a winner worthy of the championship designation, and

Whereas, early in the fourth quarter, a Blue Devil completed a three-pointer to place Williamstown on top, and the Blue Devils would not be toppled again from this preferred place on the scoring hierarchy, and

Whereas, although Proctor made one last attempt to reclaim the lead, narrowing the Williamstown margin to 45–41, a Blue Devil stole the ball, and with only 45 seconds remaining, he scored a pivotal layup to give his team a grand 47–41 win and the 2010 Division IV boys' basketball championship, and

Whereas, Blue Devils Ramon Burgos, Johnny Earls, Troy Laughlin, Nick Gagnon, Steven Manwaring, Logan Clark, Mitchell St. Onge, Kyle Benway, Justin Beaudet, and John Scholtz and their great team manager, Chelsea Brennan, were thrilled, as were the Williamstown fans, and

Whereas, U-32's scoring success started when one team-member took a breakout pass in the neutral zone and maintained control of the puck until she slid it as a backhanded shot into the net, and

Whereas, almost miraculously, just 19 seconds after the post-goal faceoff, a U-32 team player circled in a full 360-degree turn and executed a forehand shot that sent the puck back into the net, and

Whereas, after two periods of play, this all-Raider Division II girls' ice hockey championship contest's score was 2–0 in favor of U-32, and

Whereas, U-32 scored one last goal at 11:27 of the third period, providing the final assurance it would skate away as the game's 3-0 winner, and

Whereas, in the state of Vermont, before-school, afterschool, and summer programs keep more than 20,000 children engaged in the hours outside the school day with innovative learning experiences and positive youth development opportunities, and

Whereas, studies have found that children who attend high-quality afterschool programs report good relations with friends, healthy emotional adjustment, stronger conflict resolution skills, and better grades and behavior in school, and

Whereas, Vermont's afterschool programs keep children safe and in structured, stimulating, and productive programs during the time of day that juvenile crime hits its peak and when youths are at greater risk of being involved in crime and substance abuse, and

Whereas, afterschool programs build stronger communities by involving our students, parents, business leaders, and adult volunteers in the lives of our young people, and

Whereas, the Afterschool Alliance reports that for most families there is an "after school gap" of 15–25 hours per week when parents are still at work, and quality afterschool programs help sustain Vermont's working parents' productivity, and

Whereas, according to the JC Penney Afterschool Fund, 92 percent of Vermont parents are satisfied with their children's afterschool program, and the America After 3pm survey found high support among Vermont adults for post-school day organized youth programs, and

Whereas, among the Vermont Afterschool programs are: Healthy Choices and Math can be Fun (Newark Street School); Pillows for Haiti and Community Questing Adventures (Putney Central School); Journaling and

Reading Club (Enosburg); Tech Club and Self Defense Class (Vergennes); Slimy and Scaly Class and Dance Troupe (East Haven); World Drumming (Alburgh Community Educational Center); Core Support classes in science, math, and Spanish (Winooski High School); math and reading tutoring (South Royalton School); swimming lessons (Rutland); fencing, rowing, and homework help (Burlington High School); and other options include: 4H programs, the Iron Chef competition, school garden projects, skiing and snowshoeing, music programs, theatre projects, community service, painting and pottery, math clubs, chess clubs, literacy programs, and book clubs, and

Whereas, 21st Century Community Learning Center afterschool programs in Vermont employ over 1,700 paid staff and create over 290 school-community partnerships, and they provide programming for students in schools and communities where at least 40 percent of the student population qualifies for free or reduced-price meals, and

Whereas, afterschool directors, advocates, partners, and students are gathered today, March 25, 2010, in Montpelier to celebrate these programs' success and promote the importance of their continuance, now therefore be it

That the General Assembly designates March 25, 2010, as Afterschool Program Day at the state house, and be it further

Whereas, the No. 2-seeded Missisquoi Valley Union High School Thunderbirds boys' ice hockey team, including a dozen seniors, faced the No. 1-seeded Stowe High School Raiders in the 2010 Division II (Lake Division) boys' ice hockey championship game at the University of Vermont's Gutterson Fieldhouse, and

Whereas, the first period ended in a scoreless tie, and

Whereas, 14 seconds into the second period, a Missisquoi player skated past a Raider to recover the puck that the Raider goalie had just shot back into play,

and the Thunderbird immediately sent it into the net for the game's first goal, and

Whereas, two assisting Thunderbirds created the setup that enabled a third teammate to score the game's second goal at 10:54 of the second period, and

Whereas, at the net, the Thunderbird goalie boldly defended his territory, deflecting five Raider shots on goal in under a minute while Stowe had a power play advantage late in the second period, and

Whereas, not content with a 2–0 lead, the Thunderbirds scored their third goal at 3:47 of the final period when, in a play involving three Thunderbirds, Missisquoi took the puck from the right point, then slid it along the blue line and ultimately into the near side of the net, and

Whereas, Brian Gawlik, a successful young CNN television news producer who worked in the fast-paced world of 24-hour television journalism and who had no teaching experience was at first not the obvious choice for this newly established instructorship, and

Whereas, this enthusiastic media wizard presented his candidacy so persuasively that in 1999, Burr & Burton Headmaster Charles Scranton took a risk and hired this aspiring and untested teacher to assume this new faculty post, and

Whereas, any doubt that Brian Gawlik belonged in the education fraternity was quickly dissipated as he proved a gifted and natural teacher who inspired his students to master the skills and techniques required to produce video journalism and documentaries, and
