House concurrent resolution honoring Carl Johnson for his outstanding half-century of public service as a law enforcement officer and for his dedicated work as a Franklin County historian

Whereas, Carl Johnson was sworn in as a member of the St. Albans City police force in 1959, following his honorable discharge from the United States Marine Corps, and

Whereas, in the early 1960s, he received a commission as a Franklin County deputy sheriff, and

Whereas, during the next 50 years, Carl Johnson became a familiar presence in Franklin County courthouses, and

Whereas, his multiple roles for the Franklin County sheriff's department included service not only as a court officer, but also as a traffic control officer and transport officer, and

Whereas, Carl Johnson always performed his duties as a Franklin County deputy sheriff responsibly and with a strong commitment to providing the best possible law enforcement coverage in whatever role he was assigned, and

Whereas, working as a law enforcement officer was only one aspect of his career as a criminal justice professional, and

Whereas, for many years, Carl Johnson served with distinction as a probation officer with the Department of Corrections, stationed at St. Albans, and

Whereas, beyond his responsibilities in the criminal justice system, Carl Johnson is an avid Franklin County historian whose specialty is local Civil War events, such as the famous St. Albans Raid of October 19, 1864, and

Whereas, he is a veteran caretaker at the Greenwood Cemetery in St. Albans, and

Whereas, although in 2009, illness required Carl Johnson to retire early, in his opinion, from the Franklin County sheriff's department at the young age of 75, he achieved his dream of serving as a law enforcement officer for 50 years which is a rare and special accomplishment few individuals are able to achieve, now therefore be it

Whereas, starting in 2007, the Division III girls' basketball championship game has featured the Lake Region Rangers, who the Windsor Yellow Jackets defeated in 2007, with Lake Region defeating Windsor in a 2009 rematch, and

Whereas, this past season, Lake Region dominated Division III play, and the Rangers (21–2) appeared at the Barre Auditorium to once again test their skill against an unanticipated opponent, the Windsor Yellow Jackets (16–7), and

Whereas, at the start of the 2010 Division III girls' basketball playoffs, the Yellow Jackets were assigned an unimpressive seventh-seed ranking, and knowledgeable observers did not consider Windsor a likely finalist, and

Whereas, the Yellow Jackets knew they were a far superior team than this ranking might indicate, and in the elimination rounds, they played to win and earned a berth in the championship game, and

Whereas, the young ladies from Vermont's birthplace were on top, 12–7, after the first eight minutes of the decisive game, and

Whereas, in the second quarter, Windsor opened with a strong offense and built a 21–12 lead before Lake Region gained its scoring bearings, but Windsor retired to the locker room at halftime still comfortably ahead, 31–23, and

Whereas, during the action-filled third quarter, the Rangers executed two consecutive three-point plays, narrowing their deficit to 35–31 before Windsor widened its margin to 39–31, and a Yellow Jacket's three-pointer shortly before the third quarter's conclusion enabled Windsor to head into the last eight minutes of play, ahead 42–34, and

Whereas, although the Rangers were soon only trailing 46-44, Windsor rebounded and clinched a 50-45 game win and the 2010 Division III crown, and

Whereas, as a clever wordsmith, she can apply her flair for the English language to the technical requirements of drafting laws, and

Whereas, more recent arrivals on the council staff have benefited from Meredith Sumner's drafting guidance and knowledge of the legislative process, and

Whereas, she has proven to be an excellent drafter and has perceptively translated legislators' broadly stated public policy wishes into well-crafted bill drafts that are comprehensible to individuals who are not experts on the topic being addressed, and

Whereas, while working with the committees on education, Anne Winchester was a primary drafter of education finance bills that included Act 60 in 1997, Act 71 in 1998, and Act 68 in 2003, and

Whereas, a Vermont legislative response to the impact of the federal No Child Left Behind law was a topic to which she applied her drafting skills, and

Whereas, as a change of pace, Anne Winchester more recently assumed a new portfolio and mastered the topics of bonding, the state's capital construction program, and Vermont's corrections policy as the drafter for the house and senate committees on institutions, and

Whereas, when the general assembly adjourns sine die in 2010, Anne Winchester will bid farewell to the legislative council and journey abroad with her husband who is an international energy policy consultant, now therefore be it

Whereas, in the semifinal frozen four game at Lake Placid, Norwich topped Plattsburgh State University 3–2, advancing the Cadets into the championship game against St. Norbert College, and

Whereas, in the decisive game, Norwich scored first with a power play goal at 11:30 in the first period, and

Whereas, St. Norbert evened the score at 9:36 in the second period which was how the game stood at the end of regulation play, and

Whereas, 75 percent of the Vermont fourth graders, compared to 67 percent nationally, scored at or above the basic level, and this is the second highest in the nation with only Massachusetts' fourth graders surpassing their more northerly New England neighbors, and

Whereas, 84 percent of Vermont eighth graders were reading at or above the basic level, which is the highest in the country, while the national percentage stood at 75 percent, now therefore be it

Whereas, under these circumstances, it is not surprising that a town manager's remaining in one municipality for an extended period of time is unusual, and

Whereas, a happy exception to the typical town manager's tenure scenario is Phil Swanson, who, in 2010, is celebrating his 25th anniversary of municipal public service as Woodstock's town and village manager, and

Whereas, this quarter-century longevity makes Phil Swanson the longest currently serving town manager in Vermont, and

Whereas, unlike most municipal managers, Phil Swanson must report to two panels of employers, the town selectboard and the village trustees, and

<u>Whereas</u>, a northern New England town manager must take command during middle-of-the-night snowfalls, mud season disasters, and in communities with waterways, such as Woodstock, times of rising waters and flooding, and

Whereas, Phil Swanson has been an effective administrator who has an excellent working rapport with his fellow Woodstock residents, and

Whereas, the town's and village's residents respect Phil Swanson's record of accomplishment and ability to organize, coordinate, and direct municipal government, and

House concurrent resolution commemorating the World War II friendship and military service of Raymond Sanville and Bill Spriggs

<u>Whereas</u>, Ray Sanville of Irasburg and Bill Spriggs of Massena, New York entered the U.S. Army in 1943 and met while in military training at Fort Mead, Maryland, and

Whereas, an immediate and warm friendship developed between the two men, and Bill Spriggs commented decades later that Ray Sanville was probably his only friend at the time, and

Whereas, they landed together at Omaha Beach on the French coast slightly over two weeks after the D-Day Invasion of June 6, 1944, and

Whereas, shortly after landing in France, they were separated in the course of military operations, and

Whereas, after an especially bloody encounter with German forces, Bill Spriggs was assigned the job of collecting dog tags from dead American soldiers in order that the soldiers' next of kin could be notified, and

Whereas, while conducting this sad personal reconnaissance, he located his special friend, Ray Sanville, and removed his tag, and

Whereas, Bill Spriggs' military service in Europe continued and included combat duty during the Battle of the Bulge, and

Whereas, during the ensuing decades, Bill Spriggs always wondered if Ray Sanville's family knew of his death in battle and whether his remains were returned home to Vermont, and he even traveled to Montpelier in a futile and disappointing search for information, and

Whereas, recently, two World War II enthusiasts, one in Minnesota, and the other in Belgium, agreed to assist Bill Spriggs in his search, and through their efforts, he viewed a photo of Ray Sanville posted on the website of the *Northland Journal* and read that Ray had been buried in St. Mary's Cemetery in Newport, and

Whereas, as a result of this discovery, Bill Spriggs has been in contact with Ray Sanville's cousin, Julie Mossa, of Derby, and, in May, will visit Ray's grave and meet his only surviving son, Doug Sanville, now therefore be it

Whereas, Vermont's first modern-era brewpub, the Vermont Pub and Brewery, which was opened in Burlington on November 11, 1988, was only the third modern brewpub established along the East Coast, and this VT LEG 257229.1

award-winning enterprise, under the leadership of its founder, Greg Noonan, who died in 2009, has set the standard for brewpubs in Vermont and nationally, and

Whereas, Vermont's craft brewing industry contributes to our state's tourism, education, agricultural, and manufacturing sectors with ever increasing importance, and

<u>Whereas</u>, from a tourism perspective, over half of the state's craft breweries are brewpubs that have become tourist attractions for visitors, and 40,000 copies of the Vermont Brewers Association's (VBA) *Breweries and Wineries* brochure have been distributed, and,

Whereas, the VBA has created the Vermont Brewery Challenge, featuring a passport that participants can have marked as they visit a brewery and then turn in for prizes, and

Whereas, educationally, the American Brewers Guild of Salisbury is considered a premier brewing school and attracts domestic and international students who study with its famed expert brewer Steve Parkes, and

<u>Whereas</u>, Vermont breweries are working with agricultural specialists at the University of Vermont and area farmers to restore the state's historic hops and barley crops, and the VBA has embarked on a project to encourage the maximum use of local products in Vermont-produced beers, and

Whereas, as for beer brewing's role in the state's manufacturing economy, in 2008, 293,000 barrels of beer were brewed, and the industry employed approximately 350 persons whose average wage was \$13.00 per hour plus benefits, and

Whereas, Vermont's craft breweries, including the Alchemist Pub & Brewery (Waterbury), Bobcat Café & Brewery (Bristol), Harpoon Brewery (Windsor), Jasper Murdock's Alehouse (Norwich), Lawson's Finest Liquids (Warren), Long Trail Brewing Company (Bridgewater Corners), Madison Brewing Company (Bennington), Magic Hat Brewing Company (South Burlington), McNeill's Brewery (Brattleboro), Otter Creek Brewing Inc.
