Whereas, the Vermont Youth Conservation Corps (VYCC) was founded in 1985 with an appropriation of one dollar as an experimental public-private venture, and

Whereas, the mission of the VYCC is "to teach individuals to take personal responsibility for all their actions," and uses "conservation projects as the vehicle for learning in an intense environment," and

<u>Whereas</u>, VYCC has leveraged millions of private and philanthropic dollars and has completed over \$40 million worth of improvements to public lands in Vermont, and

Whereas, over 500 young adults aged 16 to 24 are annually selected to serve as part of the VYCC, and, since 1985, 5,000 young Vermonters have been selected to participate in this innovative organization, and

Whereas, the VYCC reaches out to disadvantaged and low-income youth, many from families with incomes below the federal poverty level, providing important job skills training and educational opportunities, and

Whereas, the programs the VYCC administers contribute to improvements to Vermont's waters (including work related to the clean and clear program), forests, parks, historic buildings, agricultural lands, fire prevention efforts, trails, and disaster preparedness and relief activities, and

Whereas, as a national leader in programs related to youth, environmental protection, and education and job training, the VYCC has been honored frequently and on five occasions has been presented the Vermont State Park of the Year Award, and

Whereas, the VYCC has been a national leader in developing programs for youth with disabilities, including LEAP, a work-based leadership and training program for blind and visually impaired youth, and

<u>Whereas</u>, dozens of Vermont's nonprofit and for-profit sector leaders received leadership training in VYCC programs, and

Whereas, the VYCC's new year-round school program has produced dramatic results in preventing students from dropping out of school, and it teaches the students important agriculture-, conservation-, energy-, and natural resources-related skills that have career applications, and

Whereas, mobilizing young Vermonters to promote the green revolution, to help to alleviate climate change, and to conserve energy are missions the VYCC conducts with great pride, and

Whereas, in 2005, the VYCC moved to its magnificent new home at the beautifully restored 1903 West Monitor Barn in Richmond, where it now operates its Youth Leadership, Education and Training Center, and

Whereas, 2010 marks the 25th anniversary of this unique Vermont organization that has served our young people and state with great success, now therefore be it

Whereas, in 1975, the Washington County Youth Service Bureau hired Tom Howard as director of the Montpelier Youth Center, named him the bureau's clinical supervisor in 1977, and finally appointed him as the organization's executive director in 1979, and

Whereas, Tom Howard's dynamic leadership has positively and dramatically transformed the youth services landscape in Vermont, and

Whereas, he arranged the bureau's affiliation with the Boys & Girls Clubs of America, which improved the bureau's program offerings and attractiveness for financial donations, and

Whereas, Tom Howard established the Vermont Coalition of Runaway and Homeless Youth Programs, the Vermont Coalition of Teen Centers, the Vermont Youth Tomorrow Program (A*VISTA), and the Vermont Youth Development Corps (AmeriCorps), and

<u>Whereas</u>, two bureau programs received simultaneous recognition from the United States Center for Substance Abuse Prevention as exemplary programs, making it the only organization in the country at the time to have two such programs honored, and

Whereas, Tom Howard served on one of the state's court diversion boards and represented Vermont's 21st Century Community Learning Center Programs at a White House conference, and

Whereas, this week he was presented with the "Outstanding Johnson State College Alumni" award, and

Whereas, in June, Tom Howard will end his illustrious 35-year association with the Washington County Youth Service Bureau/Boys & Girls Club, now therefore be it

Whereas, academia and politics are not always compatible realms of endeavor, but they matched beautifully in the illustrious dual careers of University of Vermont history professor emeritus and former Chittenden County state senator and Democratic Party activist Robert (Bill) Daniels, and

Whereas, Bill Daniels' extraordinary life began in his native Boston, although both his parents were Burlingtonians and he would ultimately settle in their hometown, and

Whereas, he earned an undergraduate degree in economics, magna cum laude, from Harvard University interspersed with a hiatus for World War II service as a U.S. Naval officer, and

Whereas, a love of Russian history motivated him to complete both master's and doctoral degrees in this field at his undergraduate alma mater, and

Whereas, his professional life started at Bennington College, continued at the University of Indiana, and found a true home at the University of Vermont (UVM) for over three decades, and

Whereas, Professor Bill Daniels was the first director of UVM's Area and International Studies Program, led the university's Experimental Program of the College of Arts and Sciences, cofounded the Center for Research on Vermont, served as chair of the history department, and was among the select group of faculty members chosen as a University Scholar, and

Whereas, the author of numerous respected books and articles on Russian history, he served as President of the American Association for the Advancement of Slavic Studies which also honored him for his academic contributions, and

Whereas, in 2004, the University of Vermont conferred on Professor Bill Daniels an honorary doctor of law degree and created an international studies award in his honor, and

Whereas, he bridged the classic town-gown divide with aplomb, winning, in 1972, one of Chittenden County's seat in the Vermont Senate, demonstrating a mastery of the rough and tumble world of electoral politics and not surprisingly was a legislative leader during his five terms, including

serving as Senate assistant minority and minority leader, and chairing the Committee on General Affairs, and

Whereas, his political endeavors were not limited to the senate as Senator Bill Daniels was active in the Democratic Party on the local, county, and national levels, and

Whereas, Professor Bill Daniels was also a leader in many civic and educational organizations and was appointed to serve on the U.S. Air Force Academy Board of Visitors, and

Whereas, his multifaceted life filled with many achievements ended on March 28 at the age of 84, and his family survivors include his wife, Alice, children, Robert, Thomas, Helen, and Katelyn, and four grandchildren, now therefore be it

Whereas, on September 6, 1980, Richard Gauthier was hired as a Bennington Police Department patrolman, and

Whereas, he was appointed a detective in 1986, and

Whereas, as a detective, Richard Gauthier performed all of his law enforcement duties in a laudable manner, and

Whereas, in recognition of his accomplishments as a patrolman and detective, in 1998, Richard Gauthier was appointed Bennington Police Chief, and
