Whereas, in 1934, European-trained conductor Alan Carter of Woodstock organized a group of musicians from throughout Vermont as the Vermont Symphony Orchestra (VSO), and

Whereas, the stature of the orchestra rose quickly, and in 1939, the General Assembly adopted a joint resolution "officially naming 'Vermont State Symphony Orchestra' and appropriating funds to assist in defraying expenses

of its concert at New York World's Fair", making the VSO the nation's first official state symphony orchestra, and

Whereas, during the VSO's 50th anniversary celebration from 1984 to 1986, and under the leadership of its second conductor, Efrain Guigui, an ensemble of VSO musicians visited each Vermont city and town as part of "The 251 Project," and

Whereas, in 1991, the VSO turned to Kate Tamarkin as its third conductor, marking a major milestone for women in the conducting profession and the presentation of wonderful renditions of the orchestral repertoire under her skillfully directed baton, and

Whereas, in 1999, the VSO appointed internationally famous violin virtuoso Jaime Laredo as its fourth conductor, and his leadership has featured stunning interpretations of classic and new works for orchestra, famous soloists and appreciative audiences, and

Whereas, each autumn, the VSO's "Made in Vermont Music Festival" brings chamber music and compositions by Vermont composers to venues across the state, and a rousing summer "pops" program featuring the full orchestra is heard annually at outdoor sites such as Shelburne Farms, and

Whereas, the SymphonyKids' series introduces thousands of youngsters to the wonders of classical music in programs that are entertaining, and

Whereas, the VSO has performed new American music as a participant in the joint League of American Orchestras and Meet the Composer's Ford Made in America commissioning project, featuring an orchestra from every state, and

Whereas, VSO Farmers' Nights' performances have brought free orchestral concerts to state house audiences, and

Whereas, in celebration of the VSO's 75th anniversary, the orchestra's Masterworks series is featuring "Music of Our Times" concerts with music composed since the orchestra's establishment in 1934, now therefore be it

Offered by: Representatives Obuchowski of Rockingham, Partridge of Windham, Deen of Westminster and Mrowicki of Putney

Whereas, for over two centuries, the citizens of Rockingham have recognized the central role a library can play in a community, and

Whereas, in 1799, the Rockingham Library Society, the first of two library societies established in the town, was established, and local residents could purchase a share at the rate of \$1.00 per person, and

Whereas, on September 6, 1887, Rockingham's two library societies merged to become the Rockingham Free Public Library, assuring library services would be available to all of the town's inhabitants, and

Whereas, in 1888, after a successful fundraising drive, the newly established public library opened on the first floor of the new Rockingham Opera House, and

Whereas, within a few years of the 20th century's opening, the Rockingham Public Library had expanded beyond the Opera House facility's capacity, and the town's voters approved the purchase of a plot of land on Westminster Street and the acceptance of a generous \$15,000.00 from the steel magnate and famed library philanthropist, Andrew Carnegie, and

<u>Whereas</u>, on October 8, 1908, the cornerstone was laid for the new Rockingham Free Public Library, and then, on November 23, 1909, the building, one of four Carnegie-financed libraries that was constructed in Vermont, was dedicated, and

Whereas, two decades later, in 1929, the Rockingham Free Public Library opened a new children's room wing, and a further addition opened in 1950 that provided both an expanded children's room and a community meeting room, and

Whereas, 2009 marks the centennial of the still-much-appreciated and -cherished Rockingham Free Public Library's Carnegie edifice, and the community will celebrate this special anniversary at a townwide birthday party in November of this year, now therefore be it

Whereas, the Muzzy-Allen-Monroe family's civic and commercial leadership in the town of Jamaica began in 1789 when Benjamin Muzzy settled in this Windham County municipality, and

Whereas, he represented Jamaica in the House of Representatives for the 1797 session and later for four one-year terms from 1810 through 1813, and

Whereas, in the decades that followed, the descendants of Benjamin Muzzy continued to reside in Jamaica, and in 1848, his grandson, Abijah Muzzy, purchased a local retail establishment that specialized in the sale of tools and related supplies, and

Whereas, although formally named the J.A. Muzzy Company, after Abijah Muzzy's son, James, who assumed control of the store later in the 19th century, it was known to everyone in Jamaica as Muzzy's, and

Whereas, James Muzzy followed in the footsteps of his great-grandfather, Benjamin, and during 1897-1898, he represented Jamaica in the House of Representatives, and

Whereas, upon retiring from his role at Muzzy's, James Muzzy passed ownership of the store to his son-in-law, Ernest O. Allen, who operated this venerable mercantile establishment into the 1970s when he transferred its ownership to his grandson, Allen Monroe, and

<u>Whereas</u>, this represents a remarkable 160-year longevity of the Muzzy-Allen-Monroe family owning Muzzy's, and

Whereas, family members were among the local bank's incorporators, they established an endowment to help families in the area during times of need, and they donated the land on which the town's offices and elementary school are located, and

Whereas, Allen Monroe's father served as headmaster at Leland & Gray High School and was a renowned artist, and

Whereas, the closure of Muzzy's store in 2008 marked a true milestone in the history of the town of Jamaica and that of the Muzzy-Allen-Monroe family with which it has been so closely associated, now therefore be it

Whereas, according to ancient legend, 4707 years ago, Nian (meaning year in Chinese), the evil dragon, ravaged the countryside, spreading war and famine and consuming human beings for substance, until the emperor vanquished him, and Nian has never returned, and

<u>Whereas</u>, in celebration of this great triumph of good over evil, each year, the Chinese people, and others across east Asia and the world, sound gongs and beat drums to keep Nian away and assure that the new year will be one of peace, prosperity, and good fortune, and

Whereas, an essential aspect of the lunar year festivities is the commemoration of the Zodiac of 12 animals called by the Buddha, in which a rat, ox, tiger, rabbit, dragon, snake, horse, ram, monkey, rooster, dog, and pig raced to his presence with the rat jumping off its perch on the ox to finish first, and

Whereas, each of these animals rotates annually as the new year's designated animal, and

Whereas, 2009 marks the 4707th commemoration of the emperor's triumph over Nian and is the year of the ox, and

Whereas, in order to create and promote a more culturally and socially diverse America and Vermont, an Asian American Lunar New Year celebration will take place at the Rochester Public Library on Saturday, January 24 that will include story telling, an introduction to the Ox and what it means in this lunar year, and readings exploring the Asian American culture that has added its enthusiasm and contribution to American culture, and

Whereas, on Sunday, January 25, there will be an Asian food festival in Rochester where participants will be able to taste the cuisines of Asia, and

Whereas, the festivities in Rochester will encourage multicultural aspects of our society and create an atmosphere that encourages diversity and inclusiveness in Vermont and America, and

Whereas, these celebratory events will be a wonderful combination of cultural sharing and great fun, now therefore be it

Whereas, the department entered the motorized era when it acquired its first truck in the early 1900s, and

Whereas, pumper service first arrived on the scene in 1957 with a maxim pumper of that year's manufacture, and

Whereas, for over a century, the coverage area of the Proctorsville Volunteer Fire Department included the entire town of Cavendish, but in the 1950s, the increasingly large workload placed on its hard-working volunteers prompted the department to limit its regular service to the village's boundaries, and today it is formally known as Cavendish Fire District #1, and

Whereas, the 1950s was also the decade when the department departed from its historic, original Main Street fire station which remains standing, and opted for a more modern building, and

Whereas, the department's second home was expanded in 1989 to accommodate the larger trucks that were being built for firefighting and to provide much needed additional space for equipment and personnel, and

Whereas, the department now boasts three trucks, a 1986 kme pumper, a 1989 firefighting utility vehicle, and, its most recent addition, a 2006 smeal pumper that stores both class a and b foam and includes a five-person cab with four air pack seats, and

Whereas, the 18 adult members and five junior firefighters now attached to the Proctorsville Volunteer Fire Department provide the village with reliable and high quality emergency support when their services are called upon, now therefore be it

House concurrent resolution recognizing the importance of nurse anesthetists in Vermont's health care system

Whereas, nurse anesthetists were the first professional group to provide anesthesia in the United States and are the oldest recognized group of advanced practice registered nurse specialists, and

Whereas, nurse anesthetists have completed a graduate-level educational program in a nationally accredited program of nurse anesthesia and after graduation are qualified to take the national certifying examination to become a certified registered nurse anesthetist (CRNA), and

Whereas, CRNAs are required to take and pass the national certification examination administered by the National Board on Certification and Recertification of Nurse Anesthetists, and

Whereas, CRNAs must recertify every two years in order to continue to practice the specialty of anesthesia, and

Whereas, CRNAs provide anesthesia services in all settings in which anesthesia is delivered, and

Whereas, according to the American Association of Nurse Anesthetists, more than 65 percent of all rural hospitals rely on CRNAs to provide anesthesia care, and without these advanced practice nurses, some 1,500 facilities would be unable to maintain trauma stabilization and surgical and obstetrical capabilities, forcing many rural Americans to travel long distances for such services, and

Whereas, each year, CRNAs working in hospitals, ambulatory surgical centers, physicians' offices, the medical facilities of the U.S. Military, the Department of Veterans' Affairs, and the U.S. Public Health Service are the hands-on providers of approximately 65 percent of all anesthetics given to patients in the United States, and in rural communities the percentage is even higher, and

Whereas, CRNAs serve Vermonters by providing needed anesthesia care in hospitals, medical facilities including the White River Junction VA Medical Center, and physicians' offices, and

Whereas, in Vermont, CRNAs work with all levels of patients in 10 of the 13 hospitals in Vermont in which surgical services are provided, and

Whereas, the week of January 25, 2009 has been designated as Nurse Anesthetists Week, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the importance of nurse anesthetists in Vermont's health care system as the profession celebrates Nurse Anesthetists Week beginning January 25, and be it further
