## **Senate Concurrent Resolutions**

## S.C.R. 22.

Senate concurrent resolution congratulating the Agency of Agriculture, Food and Markets' "Agriview" newspaper on its 70th anniversary.

Whereas, the Department of Agriculture was established pursuant to Act 7 of 1923, and it has over the decades evolved into the Agency of Agriculture, Food and Markets, and

Whereas, by 1937, according to that year's legislative directory, the Department's duties had been expanded to encompass "General administration of laws relating to agriculture, livestock and laws relating to marketing and grading of farm products and the certification of seed potatoes," and

*Whereas*, a significant role for the Department was, and to this day remains, to promote agricultural interests in a variety of forums, and

Whereas, in the depression year of 1937, many farmers were unable to afford the price of a newspaper, and the Department of Agriculture was concerned that information regarding the services it offered farmers, including the role of its laboratories, was not widely known, and

Whereas, as a way to alleviate this informational deficiency, the Department took advantage of new technological publication advances and established a quarterly newspaper entitled "Agriview" with free distribution to the state's farmers, and

Whereas, as explained in an article published in Agriview's first edition, the paper's purpose was "to bring the department into closer relationship with those whom it is designed to serve" by offering "first-hand information as to its organization, its functions, progress of its various activities and to supply worth-while advice and recommendations resulting from them," and

Whereas, for the past 70 years, "Agriview" has fulfilled this mission with great success, and in 2009, now as both a print copy and online publication, it

continues to serve as a vital information conduit between the agency of agriculture, food and markets and the farming community, now therefore be it

## S.C.R. 23.

Senate concurrent resolution in memory of Andrea Mead Lawrence.

Whereas, the role of American women in international competitive alpine skiing owes much to the pioneering accomplishments of Rutland native and Olympic gold medalist Andrea Mead Lawrence, and

Whereas, her bonding with the mountainous terrain started at an early age when she skied on her many snow days at Pico Peak, the ski area that her parents established, and

Whereas, she was the youngest qualifier for the 1948 United States Olympic ski team and traveled to St. Moritz, Switzerland, and

Whereas, over the next four years, she won many competitions, including the 1951 Arlberg-Kandahar race then considered the unofficial downhill world championship, and

Whereas, at the 1952 Winter Olympics in Oslo, Norway, the United States women's ski team captain Andrea Mead Lawrence was expected to impress everyone in attendance and had already been featured on the cover of Time Magazine, and

Whereas, Andrea Mead Lawrence did not disappoint anyone as she collected her first gold medal skiing down the icy 1,640-yard precipice that served as the giant slalom course at a pace faster than 44 other skiers from 15 nations, and

Whereas, her feats of skiing magic in Norway were hardly over as she returned to the slopes to win the slalom, combining fourth- and first-place finishes in the two-round event, becoming the first and, 57 years later, still the only American skier to win two gold medals at an Olympics, and

Whereas, she returned home to Rutland where an adoring crowd of 5,000 cheering fans greeted her with the utmost admiration and enthusiasm, and

Whereas, her final Olympic appearance in 1956 in Cortina d'Ampezzo, Italy, featured her nearly winning a bronze medal in the slalom competition only four months after the birth of her third child, and

Whereas, Andrea Mead Lawrence had a second and equally fulfilling life as a civic activist and conservationist first in Colorado, where she served on the Aspen planning board, and later in California, where she was elected to and served for 17 years on the Mono County Board of Supervisors, and

Whereas, her concern for the environmental sanctity of the Sierra Nevada Mountains motivated her to help organize the Sierra Nevada Alliance, and she later established the Andrea Lawrence Institute for Mountains and Rivers which works to integrate "economic and ecological integrity" in the Sierra Nevada Mountains, and

Whereas, the many honors and accolades she received included documentary filmmaker Bud Greenspan's naming her as the "Greatest Winter Olympian of All Times" and being the first person inducted into the Vermont Ski Museum Hall of Fame, and

Whereas, following her courageous battle against cancer, Andrea Mead Lawrence, whose heart was in California but whose soul was in Vermont, died at her Mammoth Lake, California, home on Tuesday, March 31, 2009, and her survivors include her children, Cortlandt, Matthew, Deirdre, Leslie and Quentin, and four grandchildren, now therefore be it

Senate concurrent resolution in memory of University of Vermont Professor Emeritus Everett W. Harris of Charlotte.

Whereas, Everett Harris's scholarly life began in a one-room Wolcott schoolhouse and eventually led to a professorship at the University of Vermont's College of Agriculture, and

Whereas, interwoven with his role as an educator was a life-long passion for farming, of which he was an ardent proponent for young Vermonters pursuing agriculturally related careers, and

Whereas, after graduating from People's Academy and the University of Vermont with a degree in agricultural education, Everett Harris devoted the next decade to his twin interests of teaching and farming, and

Whereas, after his father's death, Everett Harris left his teaching job in Chelsea to work on the family farm and assist his mother in the raising of his younger brothers, and

Whereas, he decided to tackle new challenges, earning a doctorate in vocational-technical education at the University of Illinois and then accepting an assistant professorship at Marshall University in West Virginia, and

Whereas, in 1978, Everett Harris returned home to raise his family and join the faculty of his alma mater, the University of Vermont's College of Agriculture, and

Whereas, after a distinguished career in academia, Edward Harris retired from the University of Vermont in 2000 as a Professor Emeritus in Community Development and Applied Economics, and

Whereas, his retirement was in name only as he embarked on new and personally fulfilling roles at the Department of Education where his expertise in technical and agricultural education proved an invaluable resource, and

Whereas, Everett Harris was also a conscientious citizen, chairing the Wolcott school board, serving on the Lamoille County planning commission, and playing primary roles in the establishment of Lamoille County Field Days and the preservation of the Fisher Covered Railroad Bridge, and

Whereas, Everett Harris served as a state and national leader for the Future Farmers of America which, in appreciation for his service to the organization and aspiring farmers, awarded him its Honorary American Farmer Degree, and

Whereas, he was the recipient of many accolades and, perhaps most noteworthy, in 2007, the University of Vermont College of Agriculture and

Life Sciences and its Extension School bestowed on him the Sinclair Cup for distinguished service and exemplary leadership, and

Whereas, this Vermont teacher and farmer, whose Yankee sense of humor was legendary among his colleagues and friends, died on March 3, 2009, leaving his wife, Kathleen, daughters, Susannah and Elizabeth, and three grandchildren, now therefore be it

Whereas, Tuttle student colleagues Samantha Barrett, Hunter Riehle, and Meghan Drouin won honorable mention in the same competition for their video documentary *Money Matters*, and

Whereas, Jay Hoffman recently received personal recognition when he was named one of 47 finalists in the 2009 Cable's Leaders in Learning Awards that the Cable in the Classroom organization administers, and

Whereas, a high school debate consists of teams engaging in several different rounds or stages, including speeches, rebuttals, and one-on-one crossfires, and

<u>Whereas</u>, perhaps the most distinctive element of a debate is the grand crossfire in which all the members of two participating teams sit across from each other and speak at will in a forum that at times is reminiscent of a screaming match, although team participants would object vociferously to such a negative description of their verbal confrontations, and

Whereas, the popularity of debate is increasing at Hartford High School under the tutelage of teacher James Dixon who has encouraged students to participate in this linguistically centered academic activity, and

Whereas, the National Forensic League annually sponsors high school debate competitions that are held at the state, district, and national levels, and

Whereas, the Hartford High School teams were excellent representatives of their school at the Vermont state competition in February, and

Whereas, at this year's district competition held in the middle of March, seniors Manuel Grajeda and Paul Seaver became the first Hartford High School debate team to win first-place honors in a district competition in which they tested their debating skills against other teams from Vermont, New York, and Pennsylvania, and

Whereas, Manuel Grajeda specializes in catching his opponents' gaffes and describes himself as his team "good cop," carefully determining when to interject into the fray while Paul Seaver, the team's reputed "bad cop," will jump in at any moment, and

Whereas, when Rose Fowler arrived in Bellows Falls, she accepted employment as an administrative aide in the office of Dr. David Stewart, and

<u>Whereas</u>, after several years working for Dr. Stewart, Rose Fowler joined the staff of the Rockingham Memorial Hospital in the accounting department, and

Whereas, when Rockingham Hospital incurred financial difficulties requiring its closure, she played a leading role in the hospital corporation's decision to retain its real estate in order to establish new health care related services at the site, and

<u>Whereas</u>, the general assembly adopted legislation designating the building as the Health Center at Bellows Falls, and a new nonprofit corporation, Greater Rockingham Area Services Inc., was created to manage all of the real estate operations, and

Whereas, state financial assistance was obtained in the form of a community development block grant for the purpose of converting the building into the new Health Center at Bellows Falls, and

Whereas, Rose Fowler took a direct role in the building's conversion process, even assuming personal responsibility for some of the wallpapering and painting that was required, and

Whereas, once the remodeling and renovation work was completed, the Springfield Hospital opened a branch outpatient clinic, bringing an important new primary health care resource to the community, and

<u>Whereas</u>, to complement the services that Springfield Hospital provided, Health Care and Rehabilitation Services became a tenant, and

Whereas, Rose Fowler urged the board of directors of the Greater Rockingham Area Services Inc. to purchase additional nearby real property in order to attract related and much needed health and community service providers to Bellows Falls, and

Whereas, this decision proved a wise one with a day care center being established, and

<u>Whereas</u>, the success of Greater Rockingham Area Services Inc., including the establishment of the dental clinic, is attributed in large measure to Rose Fowler's effective administrative skills, foresight, and perseverance, for which she deserves special recognition, now therefore be it

Whereas, each year, under Susan Mach's guidance, the Dover School has met the AYP criteria, and

Whereas, Dover School students have consistently received the school district's top scores on various multi-school tests, and

Whereas, she created the M and M (Mrs. Mach) walk protocol for students in the hallways, ensuring a sense of order and decorum when the children move about the building, and

Whereas, Susan Mach's students are familiar with her favorite things, including the 50-plus beanie babies in her office, her preference for birthday cakes that are white with raspberry filling and white frosting and, perhaps best known of all, is their principal's partiality for the flavored coffee she brews in the morning and its aroma that permeates the school building, and

Whereas, Susan Mach is a superb educator and team player who always has her student's best interest uppermost in her mind, and

Whereas, after 39 years in public education, Susan Mach will retire this June and then relocate to Colorado where her daughter resides, now therefore be it

House concurrent resolution in memory of Margaret Jean George of Montpelier

Offered by: Representatives Kitzmiller of Montpelier and Hooper of Montpelier

Offered by: Senators Doyle, Cummings and Scott

Whereas, Margaret (Margot) George of Montpelier lived her life almost exclusively in her cherished native city, and she described herself as "all about local," and

Whereas, she attended Boston College and graduated from Vermont College, and

Whereas, as assistant to the director of the Vermont Historical Society, she helped guide preparation and implementation of the 1976 U.S. Bicentennial celebration in Montpelier, and

Whereas, she was a cofounder of the Montpelier Heritage Group, a nonprofit group whose mission is to "prevent and educate against demolition

of historic properties and 'modernizing' their exteriors," and, under its rubric, she created an incredibly successful preservation effort to revive the historic Montpelier cityscape, and

Whereas, as part of Montpelier's celebration in 1992 of its own centennial, Margot George and the Montpelier Heritage Group created a parade float titled "Cleaning the Windows of the City" that was placed on the back of a 1926 restored Model T pickup, to announce that the Heritage Group was cleaning windows and installing curtains in vacant rooms on the upper floors of buildings in the city's downtown, and

Whereas, Margot George was an early member of Montpelier on the Move, with a mission to improve the capital city's business climate, and

Whereas, for many years, Margot George led history walking tours of the city on Saturdays, and she was instrumental in the Montpelier Heritage Group's publication of two walking tour books and a series of walking tour pamphlets which remain in print for distribution, and

Whereas, a local radio talk show host referred to Margot George as the "Czarina of Downtown" in recognition of her efforts to save Montpelier's historic character, and

Whereas, she applied her knowledge and skills to her service on the Montpelier Design Review Committee, of which she was chair at the time of her death, and as a member of the Montpelier Historic Preservation Commission, and

Whereas, Margot George developed a successful career as a respected realtor, and most recently was the principal of Coldwell Banker Classic Properties, and

Whereas, she and her partner, John Russell, were the owners of the Thrush Tavern Building, and they were immersed in a project to bring back its interior so well-known to Montpelier residents and the political establishment, and

Whereas, on December 17, 2008, Margot George died, leaving many friends and admirers in her hometown, and the local newspaper, the Montpelier Bridge, eulogized her in an affectionate tribute as "an example to us all" and remarked on "her tenacity that gave no ground to anyone or any proposal that would chip away at the city's historic integrity," now therefore be it

That the General Assembly honors the life and considerable accomplishments of Margaret Jean George for her work and dedication to improve the quality of the historic cityscape of the capital city and the capital complex district, for its residents, workforce and visitors, and be it further

Whereas, although James Burlingame coached baseball, basketball, and track during his years at SJA, his historic legacy to the school's sports annals was as a football coach who won 90 games, lost 66, and tied 6, and

Whereas, his football coaching career featured many memorable achievements, including three state championships, first in Division II in 1961, and twice in Division I in 1966 and again in 1968 when the Hilltoppers were undefeated, and for a period of time in the 1960s, the academy compiled a football record of 29–2–1, and

Whereas, the Division I championships were especially impressive because SJA was a smaller school than most of its Division I rivals, and

Whereas, his Hilltopper squads defeated arch rival Lyndon Institute four consecutive years, from 1973 to 1976, a feat that had not been previously accomplished sine the 1930s, and

Whereas, James Burlingame's coaching talents were on display before a broad audience when he coached the Vermont team at the 1964 all-star Shrine football game when Vermont defeated New Hampshire in an unexpected 27–13 victory, and he also coached the Vermont all-stars in 1965 and again in 1972 when Vermont won 6–0, and

Whereas, sadly, his 1977 retirement at age 52 proved brief as he died while jogging near his Cape Cod home in 1979, and the baseball field at SJA was named in his honor in 1980, and
