Joint Resolution Referred to Committee

J.R.H. 2

Joint resolution relating to federal funding of No Child Left Behind

Offered by: Representatives Rodgers of Glover and Myers of Essex

Whereas, in fiscal year 2002, under the federal "Elementary and Secondary Education Act of 1965" (ESEA), Vermont received approximately \$44.3 million and used the funds to run many programs that accrued great benefits to low-income children and to develop and implement statewide testing in grades 4, 8, and 10 in language arts and mathematics, and

Whereas, in January 2002, the federal government enacted a comprehensive revision to the ESEA known as the "No Child Left Behind Act" (NCLB), which expanded federal requirements for primary and secondary school education, and

Whereas, the act increased every state's timetable of setting standards and testing students for achievement of the standards to once in each of grades 3–8 in language arts and mathematics and once in each of three grades in science, causing a major disruption of administrative and curriculum planning as well as a major expense to Vermont's education system, and

Whereas, the act imposed statutory requirements on local school districts, with respect to specific grades and categories of students, that if not met can result in the loss of federal funds, or in extreme instances the closure of a school, and

Whereas, the act included numerous other provisions which do not fit the Vermont situation, such as the provision that a school must pay to transport a homeless child back to the school of origin, and

Whereas, this is contrary to Vermont law, which requires that a homeless child be educated in the district nearest to where the child is located, and could cost a Vermont school district thousands of dollars in transportation costs, and

Whereas, while the expanded provisions of NCLB directed many meritorious improvements in the public education system, they have interfered severely with state and local legislative and educational administration prerogatives and have cost the state of Vermont considerably more than previously to implement, and

Whereas, Public Law 104-4 of 1995 was intended to curb the practice of imposing unfunded federal mandates on states and local government, and

Whereas, many states, including Vermont, are facing the potentially most difficult economic crisis since the Great Depression, and

Whereas, the current economic crisis is forcing states to make severe budgetary cutbacks that are impacting the essential mission of core state government services, and the implementation of unfunded federal mandates only worsens an already difficult fiscal situation, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly expresses its concern over the continuing unfunded mandates of the No Child Left Behind Act, and be it further

Resolved: That the General Assembly urges Congress, as part of its forthcoming economic stimulus package, to either include sufficient funds for the states to administer all federally required programs and policies under the No Child Left Behind Act or repeal the mandatory requirements, and be it further

<u>Resolved</u>: That the secretary of state be directed to send a copy of this resolution to the President of the United States, the U.S. secretary of education, the Vermont commissioner of education, and the Vermont Congressional Delegation.

Which was read and, in the Speaker's discretion, treated as a bill and referred to the committee on Education.
