Joint resolution urging Congress to authorize the charging of tolls for travel on and the conducting of commercial sales at rest areas adjacent to interstate highways in the state of Vermont

<u>Whereas</u>, within the state of Vermont, there are four segments of the Eisenhower Interstate Highway System (the interstate system): I-89 (White River Junction to Highgate); I-91 (Guilford to Derby Line); I-93 (Lower Waterford to St. Johnsbury) and I-189 (in South Burlington), and

Whereas, the interstate system is part of the federal-aid highway program, which at its inception in 1916 was toll-free, and this general policy is now codified at 23 U.S.C. § 301, and

Whereas, exceptions to the general policy are codified at 23 U.S.C. § 129 and include: initial construction of new toll roads; building new highways and bridges (except on the interstate system); reconstructing any existing toll facility; reconstructing or replacing existing free bridges or tunnels and converting them to toll facilities; and reconstructing an existing free federal-aid highway (that is not part of the interstate system) for conversion to a toll road, and

Whereas, although the federal Interstate System Construction Toll Pilot Program was developed to permit the construction of three toll roads for inclusion in the interstate system, no provision has been made for permitting the conversion of an existing interstate highway from free to toll status, and

Whereas, the upkeep and repair of Vermont's interstate highways has proven financially burdensome for the agency of transportation, and there are many other demands on the state's overextended transportation budget, and

<u>Whereas</u>, establishing tolls on Vermont's interstate highways, as is permitted in New Hampshire and Maine (those states' interstate highways were toll roads from their inception and are exempt from the toll prohibition on interstate highways), would provide a long-term dedicated revenue source for their upkeep and repair, and

Whereas, because some of New Hampshire's interstate highways are toll roads and not originally funded with any federal support, the commercial sale of food, fuel, and other items is permitted at these highways' rest areas, a revenue option denied to Vermont, and

Whereas, the availability of commercial sale of food, fuel, and other items at Vermont's interstate highway rest areas would be beneficial to the motoring public, and it could provide the agency of transportation with a new revenue source for maintaining these vital roads, now therefore be it

#### Resolved by the Senate and House of Representatives:

That the General Assembly urges Congress to authorize the state of Vermont to charge tolls for travel on interstate highways within its boundaries and to conduct commercial sales at rest areas adjacent to those interstate highways, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to U.S. Secretary of Transportation Ray LaHood, Vermont Secretary of Transportation David Dill, and the Vermont Congressional Delegation.

Which was read and, in the Speaker's discretion, treated as a bill and referred to the committee on Transportation.
