19	(a)(1) The secretary, in accordance with 3 V.S.A. chapter 25 of Title 3,
20	shall promulgate, and may amend and rescind, dairy sanitation regulations

1 relating to dairy products to enforce this chapter, including but not limited to: 2 labeling, weighing, measuring, and testing facilities, buildings, equipment, 3 methods, procedures, health of animals, health and capability of personnel, and 4 quality standards. 5 (2) In addition, the uniform regulation for sanitation requirements, as 6 adopted by the National Conference on Interstate Milk Shippers, and published 7 by the U.S. Department of Health and Human Services, Public Health Service, 8 Food and Drug Administration, Grade A Pasteurized Milk Ordinance (PMO), 9 together with amendments, supplements, and revisions thereto, are adopted as 10 part of this chapter, except as modified or rejected by regulation. (3) When adherence to the PMO is deemed unreasonable by the agency 11 12 for non-Grade "A" products, the most current version of the Recommended 13 Requirements of the United States Department of Agriculture, Agricultural 14 Marketing Service, Milk for Manufacturing Purposes and its Production and 15 Processing may be used. 16 (b) The secretary shall promulgate and from time to time amend or 17 terminate regulations concerning but not limited to the taking and storing of 18 samples, sampling equipment, approved tests, testing equipment, methods and 19 procedures for performing tests, and related trade practices which are used as a 20 basis for payment or acceptance for dairy products. 1	amend, or terminate regulations concerning examination for and the granting
2	and terminating of dairy technician's licenses.
3	(c) Notwithstanding any other provision of law to the contrary, the
4	regulations and requirements adopted pursuant to subdivisions (a)(2) and (3) of
5	this section shall not apply to the production, operations, or sales of milk or
6	dairy products produced by a micro-dairy that are produced, sold, and
7	consumed exclusively within the state of Vermont.
8	Sec. 3. REGULATIONS FOR SMALL- AND MEDIUM-SIZED MILK
9	PRODUCERS
10	(a) On or before September 1, 2012, the secretary shall initiate a
11	rulemaking procedure to adopt regulations applicable to small milk producers
12	that regularly milk between seven and 25, and to medium-sized milk producers
13	that regularly milk between 25 and 50 cows, goats, sheep, or water buffalo, or
14	any combination thereof.
15	(b) The purpose of the regulations adopted pursuant to subsection (a) of
16	this section shall be to lessen the financial, technical, and administrative
17	burden of complying with the sanitation regulations adopted under 9 V.S.A.
18	§ 2701 and to expand the market opportunities for small- and medium-sized
19	milk producers for direct sales to consumers, as well as sales to commercial
20	and institutional customers.
