4 Subject: Motor vehicles; inspection stickers; electronic registration

5 transactions; overpayments; truck length; titling of vessels,

6 snowmobiles, and all-terrain vehicles; new motor vehicle arbitration;

7 snowmobile registration; VAST

8 Statement of purpose: This bill proposes to:

9 (1) prohibit the misuse of inspection stickers or the display or possession
10 of fictitious or fraudulently altered inspection stickers;

11 (2) expand the scope of electronic registration transactions for which a
12 printed receipt of a transaction serves as a temporary registration;

13 (3) authorize the department of motor vehicles to retain overpayments of
14 \$1.00 or less;

15 (4) make a conforming change regarding permitting of trucks for
16 operation on Route 4;

17 (5) eliminate the requirement that applications for titles for vessels,
18 snowmobiles, and all-terrain vehicles be accompanied by an application for
19 registration;

20 (6) correct the definition of motor vehicle in the new motor vehicle
21 arbitration act;

1 (7) specify that any dealer registered in Vermont is subject to disclosure
2 requirements regarding vehicles returned under the new motor vehicle
3 arbitration act (or similar act in another state), and is prohibited from reselling
4 a motor vehicle determined or adjudicated as having a serious safety defect;

5 (8) reorganize and clarify provisions relating to snowmobile
6 registrations and trails maintenance assessment decals, and authorize
7 snowmobiles properly registered in another state or province to be operated in
8 Vermont without a trails maintenance assessment decal on designated trails
9 from the New Hampshire border to the village of Beecher Falls, Vermont; and

10 (9) provide for administrative penalties if VAST or its agent violates the
11 laws or regulations governing snowmobile registrations.

14 It is hereby enacted by the General Assembly of the State of Vermont:

18 FRAUD, AND MISUSE; PENALTY

19 (a) A person shall not:

1 (1) Counterfeit or cause to be counterfeited or have in his or her
2 possession any counterfeit number plate, validating sticker, marker, inspection
3 sticker, registration certificate, learner's permit, nondriver identification card,
4 insurance identification card, or operator license, or alter or have in his or her
5 possession any altered number plate or marker; or

6 (2) Display or cause or permit to be displayed, or have in his or her
7 possession, any fictitious or fraudulently altered operator license, learner's
8 permit, nondriver identification card, inspection sticker, or registration
9 certificate, or display for any fraudulent purpose; an expired or counterfeit
10 insurance identification card or similar document; or

11 (3) Lend his or her operator license to any other person or knowingly
12 permit the use thereof by another; or

13 (4) Display or represent as his or her own any operator license, permit,
14 inspection sticker, or nondriver identification card not issued to him or her, or,
15 in the case of inspection stickers, not issued to him or her for the vehicle on
16 which the sticker is displayed; or

17 (5) Permit any unlawful use of an operator license, permit, or nondriver
18 identification card issued to him or her by the commissioner; or

19 (6) Obtain or attempt to obtain a registration plate, validation sticker,
20 registration certificate, operator's license, learner's permit, nondriver
21 identification card, or duplicate copy of any of such documents by the use of

1 fraudulently obtained, fictitious, or altered identity documents or by the use of
2 identity documents not his or her own; or

3 (7) Obtain or attempt to obtain a registration plate, validation sticker,
4 registration certificate, certificate of title, operator's license, learner's permit,
5 nondriver identification card, duplicate copy of any of these documents, or
6 obtain or attempt to obtain any other permit, license, or special privilege from
7 the department of motor vehicles through the submission of an application
8 containing false or fictitious information; or

9 (8) Lend his or her identity documents to aid an applicant in his or her
10 attempt to fraudulently obtain or actually obtain a registration plate, validation
11 sticker, registration certificate, operator's license, learner's permit, nondriver
12 identification card, or duplicate copy of such documents.

13 (b) A violation of subsection (a) of this section shall be a traffic violation
14 for which there shall be a penalty of not more than \$1,000.00. If a person is
15 found to have committed the violation, the person's privilege to operate motor
16 vehicles shall be suspended for 60 days.

1 To be valid, the temporary registration shall be in the possession of the
2 operator at all times, and it shall expire ten days after the date of the
3 transaction.

6 (a) Except as otherwise provided, all fees for registering motor vehicles,
7 licensing operators, and all other motor vehicle fees shall be collected by the

9 bank to the credit of the state treasurer as he or she may direct.

10 (b)-(d) [Repealed.]

11 (e) Whenever a ~~transaction is received by mail accompanied by a payment~~
12 is received that is less than, but within \$0.99 of, the required fee, the
13 transaction shall be processed. The commissioner may determine that action
14 will not be taken to collect the missing portion of the fee. When a payment up
15 to \$1.00 greater than the required fee is received, the excess shall not be
16 refunded.

(a) Any manufacturer, ~~or its agent or authorized~~ any dealer registered in this state who attempts to resell a motor vehicle after a final determination,

1 adjudication, or settlement; resulting in the vehicle being returned pursuant to
2 the provisions of this chapter or ~~after final determination, adjudication or~~
3 ~~settlement~~ under similar laws of any other state, shall apprise prospective
4 buyers in Vermont of such return by means of a clearly visible window sticker
5 ~~and such manufacturers.~~ Manufacturers, agents, and dealers are prohibited
6 from reselling in Vermont any vehicle determined or adjudicated as having a
7 serious safety defect. Notice that a vehicle has been returned pursuant to such
8 law shall also be conspicuously printed on the motor vehicle certificate of title.

9 (b) Affirmative defense. A person who demonstrates both of the following
10 shall not be subject to liability or a penalty for a violation of this section:

11 (1) the person acquired a motor vehicle without actual knowledge that it
12 was returned pursuant to the provisions of this chapter or under similar laws of
13 another state, and

14 (2) at the time of acquisition, the title of the motor vehicle did not bear
15 notice of such return.

20 (a) Registration and decal required. A person shall not operate a

3 the left side of the snowmobile in accordance with this chapter, except when

19 ~~the Governors Snowmobile Council and the Vermont Association of Snow~~
20 ~~Travelers, Inc.; or its successor. The granting of reciprocal areas of use as~~

1 ~~provided in this act is not contingent upon reciprocity being granted to~~

3 (g) ~~Essex County; operation into Canada and New Hampshire from~~

19 (i) Authority of natural resources board. Nothing in this section relating to
20 operation on frozen bodies of water shall be construed to affect the authority of
21 the natural resources board to regulate uses of public bodies of water.

2 § 3204. REGISTRATION FEES AND DEALER PLATES

3 (a) Fees. ~~Registration~~ Annual registration fees for snowmobiles other than
4 as provided for in subsection (b) of this section are \$25.00 for residents and
5 \$32.00 for nonresidents. Duplicate registration certificates may be obtained
6 upon payment of \$5.00.

7 (b)(1) Dealer; manufacturer and repair plates; fees. Unless exempted
8 pursuant to subsection 3205(d) of this title, any person engaged in the
9 manufacture or sale of snowmobiles shall obtain registration certificates and
10 identifying number plates subject to such rules as may be adopted by the
11 commissioner which shall be valid for the following purposes only: testing;
12 adjusting; demonstrating; temporary use of customers for a period not to
13 exceed 14 days; private business or pleasure use of such person or members of
14 his or her immediate family; and use at fairs, shows or races when no charge is

16 (2) Fees. Fees for dealer registration certificates shall be \$40.00 for the
17 first certificate issued to any person and \$5.00 for any additional certificate

19 temporary number plates shall be \$1.00 for each plate issued.

20 (c) Temporary registration pending issuance of permanent registration.
21 The commissioner, by rules adopted pursuant to 3 V.S.A. chapter 25, shall

1 provide for the issuance of temporary registrations of snowmobiles pending
2 issuance of the permanent registration. VAST shall be an agent of the
3 commissioner for the issuance of such temporary registrations. The fees for
4 the temporary registrations shall be \$25.00 for residents and \$32.00 for
5 nonresidents and shall also constitute payment of the registration fee required
6 by subsection (a) of this section. VAST shall promptly remit any fees
7 collected to the commissioner in accordance with rules adopted under this
8 subsection. Temporary registrations shall be kept with the snowmobile while
9 being operated and shall authorize operation without the registration decal
10 being affixed for a period not to exceed 60 days from the date of issue.

20 (a) The amount of \$5.00 from the sale of every resident and nonresident

6 respective employees and agents to provide for trails' liability coverage for
7 development and maintenance of the statewide snowmobile trails program
8 including groomer use and operation. The department of buildings and general
9 services shall assist VAST with the procurement of trails liability and other
10 related insurance.

11 (c) Nothing contained in this section shall authorize or create any cause of
12 action to accrue or to be maintained against the state of Vermont.

13 (d) Any fees and penalties allocated pursuant to subsection (a) of this
14 section shall not revert but shall be available until spent. Any accrued interest
15 shall be deposited in the transportation fund.

17 § 3219. ADMINISTRATIVE PENALTIES

18 (a) The commissioner may impose an administrative penalty of not more
19 than \$250.00 against VAST or its agent for each violation of this subchapter or
20 the rules adopted thereunder. A penalty arising from a single violation may be

1 assessed against VAST or its agent, as may be appropriate, but not against
2 both.

3 (b) Each violation is a separate and distinct offense and, in the case of a
4 continuing violation, each day's continuance may be deemed a separate and
5 distinct offense. In no event shall the maximum penalty imposed for a
6 continuing offense exceed \$500.00.

7 (c) The commissioner shall adopt rules establishing a schedule of
8 administrative penalties to be imposed under this section. Penalties shall be
9 based on the severity and frequency of the violation.

10 (d) VAST or its agent shall be given notice and opportunity for a hearing
11 on any alleged violation. Service of the notice shall be sent by first class mail.
12 The notice shall include the following:

13 (1) A factual description of the alleged violation.

14 (2) A reference to the particular statute or rule allegedly violated.

15 (3) The amount of the proposed administrative penalty.

16 (4) A warning that the right to a hearing will be deemed waived and a
17 penalty will be imposed if no hearing is requested within 15 days from the date
18 of the notice, and that failure to pay a penalty may result in suspension or
19 cancellation of the privilege of issuing registrations pursuant to the provisions
20 of section 3204 of this title by VAST or its agent.

1 (e) When VAST or its agent receives notice under subsection (d) of this
2 section, it shall be deemed to have waived the right to a hearing unless, within
3 15 days from the date of the notice, a hearing is requested in writing. If the
4 right to a hearing is waived, the commissioner shall issue a final order finding
5 VAST or its agent in default and imposing the penalty.

6 (f) The provisions of sections 105, 106, and 107 of this title shall apply to
7 hearings conducted under this section.

8 (g) The commissioner may collect an unpaid administrative penalty by
9 filing a civil action in superior court, or through any other means available to
10 state agencies.

11 (h) If a penalty is not paid within 60 days after it is imposed, the
12 commissioner may suspend or cancel the privilege of issuing registrations
13 granted to VAST or its agent under the provisions of section 3204 of this title.

14 (i) The remedies authorized by this section shall be in addition to any other
15 civil or criminal remedies provided by law for a violation of this subchapter.

16 (j) All penalties collected under this section shall be deposited in the
17 transportation fund.

19 This act shall take effect on July 1, 2012.
