S. 1

An act relating to technical amendments to the judicial restructuring act of 2010

Rep. French of Shrewsbury, for the Committee on Judiciary, recommends that the House propose to the Senate that the bill be amended as follows:

<u>First</u>: In Sec. 6, by striking "\$45,701.00" where it twice appears and inserting in lieu thereof "50 percent of the salary of the most highly paid probate judge"

Second: In Sec. 9, 4 V.S.A. § 691, by striking subsection (c) in its entirety and inserting in lieu thereof a new subsection (c) to read as follows:

(c) With respect to counties where the assistant judges have elected to offer passport processing services, the court administrator and the assistant judges shall enter into a memorandum of understanding providing for the acceptance and processing of United States passport applications. The memorandum may provide for performance of passport acceptance and processing duties by the court clerk, county clerk, a superior court staff person serving as county clerk pursuant to subsection (b) of this section, or any other court or county employee.

<u>Third</u>: In Sec. 10, 24 V.S.A. § 131, after the word "property," by striking the word "<u>shall</u>" and inserting in lieu thereof the word "<u>may</u>"

<u>Fourth</u>: In Sec. 11, 24 V.S.A. § 184, after the word "<u>shall</u>" by inserting "<u>, if</u> so directed by the assistant judges,"

HOUSE BILL INTRODUCTION DEADLINES

To All House Members:

Request Deadline - All requests for introduction of bills drafted in *standard* form must be submitted to the Legislative Council by Monday, January 31, 2011.

During the first year of the biennium, a member may request introduction of a bill drafted in *short* form and submitted to the Legislative Council anytime during the session.

Introduction Deadline - Except with prior consent of the Committee on Rules, all bills drafted in standard form, shall be introduced by February 28,2011.

During the first year of the biennium Committee bills may be introduced at anytime.

JOINT ASSEMBLY

Thursday, February 17, 2011 – 10:30 A.M. – House Chamber –Election of a Sergeant at Arms, of an Adjutant and Inspector General, and of three (3) trustees for the University of Vermont, and Vermont and State Agricultural College.

Candidates for the positions of Sergeant at Arms and of Adjutant and Inspector General, and legislative candidates for UVM trustees must notify the Secretary of State **in writing** of their candidacies not later than Thursday, February 10, 2011, by 4:30 P.M., pursuant to the provisions of 2 V.S.A. §12(b). Otherwise their names will not appear on the ballots for these positions.

Do not use pink mail for the delivery of notifications to the Secretary of State. Hand delivery is the best method to insure receipt of the notification.

The following rules shall apply to the conduct of these elections:

<u>First</u>: All nominations for these offices will be presented in alphabetical order prior to voting.

<u>Second</u>: There will be only one nominating speech of not more than three (3) minutes and not more than two seconding speeches of not more than one (1) minute each for each nominee.
