Whereas, after traveling to Thailand and witnessing the desperation and misery of Southeast Asian refugees permanently displaced after the Vietnam War, Governor Richard Snelling became a strong advocate on their behalf, and

Whereas, in order to develop standardized federal policies on refugee admission and resettlement, Congress enacted the Refugee Act (the Act) of 1980, which President Jimmy Carter signed on March 7 of that year, and

Whereas, the Act directed that a state office and plan be established in every state to assist in the resettlement of refugees in that jurisdiction, and

Whereas, in the months following President Carter's signing the Act into law, Governor Snelling designated the Agency of Human Services to oversee the provision of refugee services in Vermont, effectively creating what is now the Vermont Refugee Resettlement Program, and

Whereas, in order to serve refugees most efficiently and expertly, the state of Vermont drew on the volunteer services of individuals associated with national refugee support organizations, and in 1990 the American Council for Nationalities Service (ACNS), an organization dedicated to assisting involuntary and voluntary migrants worldwide, established an affiliation agreement with the state of Vermont, and

Whereas, in 1993, the Council, by then renamed Immigration and Refugee Services of America (IRSA), opened a Vermont field office designated as the Vermont Refugee Resettlement Program and became the primary and direct provider of comprehensive refugee assistance and support services in Vermont, and by 2011 over 5,400 refugees from 40 countries had been welcomed in Vermont, and

Whereas, IRSA, now known as the U.S. Committee for Refugees and Immigrants (USCRI), was formed a century ago under the auspices of the YWCA, an association that continued until shortly before World War II, and in 2011 USCRI is commemorating 100 years of assisting and comforting refugees in many nations, now therefore be it

That the General Assembly congratulates the Vermont Refugee Resettlement Program on its 30th anniversary and the U.S. Committee for Refugees and Immigrants on its 100th anniversary, and be it further

Whereas, Mike Law devoted three decades to instructing young Vermont athletes in both the playing techniques of specific sports and, far more importantly, the ethics of good sportsmanship, and

Whereas, few individuals have the breadth of interscholastic coaching experience in multiple sports as does Mike Law, and

Whereas, as a football Solon and keen observer of other sports at Montpelier High School, Mike Law gained a student's perspective of interscholastic play that served him well during his multifaceted coaching career, and

Whereas, after graduating from the University of Vermont, Mike Law became the physical education instructor at Division IV Canaan High School where, by default, he coached every sport and also initiated a track and field program, and

Whereas, from the far north, Mike Law returned to Washington County to coach track and field at Spaulding Union High School and then added field hockey to his coaching portfolio, and

Whereas, at U-32 High School, still another sport—gymnastics—came under his guidance, as did baseball and softball at various times, and

Whereas, despite the diversity of Mike Law's coaching career, he is best known as the U-32 football coach who transformed a minimally successful program into a respected four-time state championship team that had a first-time championship victory 48–12 over his alma mater, Montpelier High School, and

Whereas, from 2000 to 2004, the U-32 football Raiders tallied an incredible 37 consecutive game victories, and perhaps most memorable was a championship 62–0 win over Mount Mansfield Union High School, and

Whereas, although the 2010 football season marked Mike Law's finale as head coach of a high school sport, he will maintain a part-time association with U-32 High School, where his decades of coaching experience will serve as an invaluable resource, now therefore be it

Whereas, nurse anesthetists were the first professional group to provide anesthesia in the United States and are the oldest recognized group of advanced practice registered nurse specialists, and

<u>Whereas</u>, a nurse anesthetist has completed a graduate-level educational program in a nationally accredited program of nurse anesthesia and after graduation is qualified to take the national certifying examination to become a Certified Registered Nurse Anesthetist (CRNA), and

Whereas, CRNAs are required to take and pass the national certification examination administered that the National Board on Certification and Recertification of Nurse Anesthetists administers, and

Whereas, CRNAs must recertify every two years in order to continue to practice the specialty of anesthesia, and

Whereas, CRNAs practice in every setting in which anesthesia is delivered: traditional hospital surgical suites; obstetrical delivery rooms; critical access hospitals; ambulatory surgical centers; the offices of dentists, podiatrists, ophthalmologists, plastic surgeons, and pain management specialists; and United States Public Health Service, United States Department of Veterans' Affairs, and military health care facilities, and

Whereas, nurses first provided anesthesia to wounded soldiers during the Civil War, and since World War II, nurse anesthetists have been the main providers of anesthesia care to United States military combat personnel, and

Whereas, CRNAs are the primary providers of anesthesia care in rural America, enabling health care facilities in these medically underserved areas to offer obstetrical, surgical, and trauma stabilization services, and, in some states, CRNAs are the sole providers in nearly all rural hospitals, and

Whereas, CRNAs serve Vermonters by providing needed anesthesia care in 10 hospitals, medical facilities, including the Vermont Veterans' Affairs Medical Center, and physician's offices, and

Whereas, 40,000 CRNAs across the United States, including 49 active CRNAs in Vermont, are part of the solution to health care reform, now therefore be it

That the General Assembly recognizes the week of January 23, 2011 as Nurse Anesthetist Week in Vermont, and be it further

Whereas, U-32, located in East Montpelier, serves students from the Washington Central Supervisory District communities of Berlin, Calais, East Montpelier, Middlesex, and Worcester, and

Whereas, prior to arriving at U-32, Keith Gerritt had served as principal at schools in Massachusetts and Connecticut, and

<u>Whereas</u>, VPA Executive Director Ken Page especially noted that under Keith Gerritt's leadership, U-32 scored the greatest improvement at a Vermont school on tests the New England Common Assessment Program administered in the fall of 2009, and

Whereas, at the start of his tenure at U-32, Keith Gerritt established a committee whose broad purpose was to raise U-32 to a new plateau of education excellence, and

Whereas, in 1909, the Hebrew Congregation of Bennington was created to facilitate Jewish religious worship and observance and social association opportunities for the growing local Jewish community, and

<u>Whereas</u>, the new congregation enthusiastically conducted religious services and other events at temporary locations in Bennington but optimistically looked forward to the construction of a synagogue to serve as its permanent home, and

Whereas, patience was required in achieving this dream, but the Jewish community's aspirations were realized when, on July 29, 1923, the eagerly awaited synagogue, located at the corner of Adams and North Streets, was dedicated at a festive ceremony at which clergy of other faiths and Lt. Governor Franklin Billings were in attendance, and

Whereas, the Hebrew Congregation of Bennington prospered for much of the 20th century, but by the 1980s, the synagogue was minimally used and in need of major building repairs, and

Whereas, a small but devoted group of Jewish community members decided to revive the synagogue as the Jewish population of the greater Bennington area, including nearby Massachusetts and New York, was on the rise, and

Whereas, to best serve the theological outlook of the community, the decision was made to affiliate with the Jewish Reconstructionist Movement, and

Whereas, the structurally and spiritually revived synagogue was renamed Congregation Beth El, meaning house of God, and

Whereas, under the leadership of Rabbi Howard Cohen, Congregation Beth El inaugurated a variety of Sabbath and Jewish holiday worship services, educational programs, and social events, and

Whereas, Congregation Beth El takes great pride in its role as an active member of the Bennington Interfaith Council, including participation in the Bennington Food and Fuel Fund and the Bennington Retreat, and the congregation hosts a monthly meal for those in need of nourishment, and

Whereas, today, with its new spiritual leader, Rabbi Joshua Boettiger, whose commitment to a rabbinic life was crystallized when, as a Jew studying in Syria, he was required to hide his faith, Congregation Beth El is a proud and thriving Jewish synagogue, now therefore be it
