Whereas, on Friday, January 21, 2011, Tim and Corey Smith of Castleton, believing that sufficient time was available to drive from their Rutland County home to their child's intended birth site at Porter Hospital in Middlebury, began the exciting journey with no scheduled intermediate stops on the itinerary, and

Whereas, when the Smiths arrived in Whiting, the mother-to-be realized that the time needed to complete the trip to Middlebury was longer than her baby was prepared to wait for that first memorable voicing of arrival, and

<u>Whereas</u>, the couple decided their default destination was the immediately proximate Whiting Elementary School, and

<u>Whereas</u>, once inside, the couple was quickly directed to the second-grade classroom of Tim Smith's cousin Lacey Smith, and although no doubt extremely surprised, she happily welcomed her relatives as the students were quickly ushered out the door, and

Whereas, as a second-grade teacher at the Fair Haven Grade School, Corey Smith must have felt comforted to be in a location with which she could personally identify, and

Whereas, water was boiled and towels were gathered, but the minimal time available meant that paramedics were still dashing to the school when Maxten Smith, weighing in at 8½ pounds, arrived on the scene, and

Whereas, the delighted students dutifully informed a newspaper reporter that Maxten was the first baby born at their school, and they have prepared a series of commemorative drawings that Lacey Smith is binding as a special memento for Maxten of his first day in the second grade, and

Whereas, the class has received a picture of baby Maxten and is looking forward to his planned return visit in the spring, now therefore be it

Whereas, the American Nurses Credentialing Center (ANCC), a subsidiary of the American Nursing Association, has developed a special recognition for hospitals offering especially commendable nursing services, and

Whereas, a health care facility that successfully completes the extremely rigorous evaluation process is designated as a Magnet Hospital for Nursing Excellence, a status for which each of its 377 recipient hospitals must reapply on a quadrennial basis, and

Whereas, the Southwestern Vermont Medical Center (SVMC) was proud in 2002 to be listed as the first Vermont hospital meeting this gold standard for nursing care, and in 2006, SVMC demonstrated renewal was merited, and

Whereas, despite the well-deserved reputation SVMC has earned for nursing proficiency, as 2010 approached, hospital management knew that as far as the ANCC was concerned, the potency of past glory would soon expire, and

Whereas, once again, SVMC was required to convince the ANCC that upon intense empirical review, involving a procedure necessitating over 14 pounds of paper, renewal of Magnet Hospital status was truly warranted, and

Whereas, after assessing SVMC on the determinative factors of quality, autonomy, innovative thinking and practices, and communications and collaboration, as practiced in the hospital's nursing services, the ANCC announced on October 29, 2010 that SVMC was being awarded Magnet Hospital for Nursing Excellence accreditation for a third consecutive four-year term, and

Whereas, since his birth on February 25, 1921, Coventry native Frederick Webster has lived a true Vermont life, and

Whereas, after graduating from Orleans High School as class valedictorian, Frederick Webster departed for the University of Vermont, establishing a school men's cross-country running record while earning his degree, and

Whereas, his pedagogic career started at Hinesburg High School, and with World War II raging, he soon enlisted in the United States Navy, and

Whereas, in 1945, Frederick Webster was deployed to China and in 1984, the Taiwanese government presented him the SACO (Sino-American Cooperative Organization) Medal, and

Whereas, back in Vermont, Frederick Webster resumed teaching, first at BFA-St. Albans and, after several intermediate stops, at his alma mater Orleans High School and ultimately at Lake Region Union High School, and he served a term as president of the Vermont Teachers' Association, and

Whereas, as a working farmer, he owned farms in Fairfield and Hinesburg, the town where he served as a tax collector and overseer of the poor and worked as a local sheriff, and

Whereas, in 1966, as a now-single father of eight, he returned to Coventry, moving into the renovated one-room schoolhouse which he had attended as a young child, and in 1972 he purchased his family's farm from his parents, a decision that would later prove decisive, and

Whereas, Frederick Webster served his faith as a church deacon, and

Whereas, beginning in 1985, Frederick Webster began devoting his time to gathering and preserving a huge collection of 1,500 pieces of antique farm equipment, now located in reconstructed barns that were moved to his family farm, and he oversees the collection from a specially built construction shop that his children refer to as the glass house, and

<u>Whereas</u>, Frederick Webster and his antiques have appeared in parades, he has welcomed many school groups to tour his Rural History site, and he has documented his collection on over 200 hours of videotape, and

Whereas, on Saturday, February 26, 2011, his family and friends will gather to celebrate the life of Frederick Webster, Coventry's own preservationist extraordinaire, now therefore be it

Whereas, in the late 18th and into the early 19th centuries, Poultney was a community of small family farms, and

Whereas, the tariff of 1824, of which Poultney resident and Congressman Rollin C. Mallery was a strong advocate, transformed Vermont into a major sheep-raising and wool production center, and

Whereas, later in the 19th century, dairy cattle had replaced sheep as the farming animal of choice, and

Whereas, many distilleries, producing corn and rye whiskey and cider brandy in particular, were prevalent in the 1820s, but a temperance movement swept the town, and, within a decade, the distilleries had vanished, and

Whereas, melodeon production was active in the 1850s and 1860s, but this musical aspect of Poultney's economy also proved of limited duration, and

Whereas, the Eureka Quarry, established in 1852, began the slate industry in Poultney, attracting immigrants from Ireland, Wales, Italy, and eastern Europe, and creating an industrial foundation that remains central to Poultney's economic vitality to this day, and

Whereas, in 2011, Poultney is a thriving community in Rutland County, looking forward to an optimistic future while pausing to commemorate and celebrate 250 years since its incorporation, now therefore be it

Whereas, over the past century, this local firefighting service, located in the heart of the Mad River Valley and staffed with a well-trained supply of always-available volunteers, has evolved into the modern-day Waitsfield-Fayston Volunteer Fire Department that provides reliable and timely fire protection to each of these towns, and, on a more limited basis, to other nearby communities through the mutual aid system, and

Whereas, on July 31, 2010, the Waitsfield-Fayston Volunteer Fire Department commemorated its centennial anniversary with celebratory activities held in the town of its birth, and

Whereas, the Waitsfield-Fayston Volunteer Fire Department, under the expert leadership of Chief Delbert Palmer, is a community resource that has enormously benefited the Mad River Valley and provided the public with the highest quality fire protection coverage, now therefore be it

Whereas, Congress addressed this fundamental inequity when it enacted the Americans with Disabilities Act (ADA) that President George H.W. Bush signed into law on July 26, 1990, and which became Public Law 101-336, and

Whereas, this historic federal legislation prompted the states to enact their own complementary laws, and Vermont's ADA was enacted as Act 243 of 1992, and

Whereas, in commemoration of the 20th anniversary of enactment of the federal ADA, on Thursday, July 22, the Vermont Center for Independent Living in Montpelier held a special celebratory event under a big tent located on the State House lawn, and a community dance followed later that afternoon, and

Whereas, the enactment of the federal ADA marked an historic occasion in the long effort and struggle of disabled Americans to be treated as truly first-class citizens, now therefore be it

Whereas, in addition to the city of Montpelier, ORCA Media Inc. now serves as the PEG provider for cable viewers in Berlin, Bethel, Braintree, Calais, Duxbury, East Montpelier, Middlesex, Moretown, Randolph, Rochester, Waterbury, and Worcester, and

Whereas, ORCA Media Inc.'s three channels, 15, 16, and 17, provide multiple types of programs, including in-studio productions, live coverage of Montpelier City Council and other capital city governance panels, artistic, athletic, and governmental (including state legislative) programs, as well as externally created videos and program services, and

Whereas, through the Vermont Media Exchange, ORCA Media Inc. can transmit programs to other Vermont PEGS, and the Internet is becoming an

increasingly important technical tool for receiving and transmitting programs to viewers, and

Whereas, the great work of Executive Director Kenric Kite, Technical Director Madhavan S. Nair, Office Manager Joanne Crowley-Watkins, and Outreach Coordinator Tim Tavcar, and the supportive guidance of board chair John Bloch and his colleagues, Mike Abadi, Senator Bill Doyle, Mike Doyle, Esther Farnsworth, and Frederick Weston, have enabled ORCA Media Inc. to become one of Vermont's premier PEG systems, and

Whereas, originally headquartered on State Street, in 1962, the same year Mr. B's son, Don, became a full-time employee, Capitol Stationers moved to Main Street into a building next to the fire station, and later that same year, Mr. B expanded his business, opening a second location back on State Street that sold office furniture and equipment, and

Whereas, he subsequently opened a gift shop on State Street in 1964, and, in 1967, consolidated the three locations into a new home on Main Street next to City Hall, where the store remained until 1996 when the family moved it across Main Street to its current location, and

Whereas, responsibility for managing this still family-operated enterprise passed from Mr. B to his son, Don, in 1982, and more recently, the leadership of the store has been transferred to Mr. B's grandsons, Eric, who came on board in 1991, and Kent, whose tenure started in 1993, and

Whereas, the CVTA has, throughout its existence, sponsored a summer of community tennis competition that opens with a series of matches organized in the format of a ladder, and

Whereas, in late August, a committee reviews the ladder standings which serve as the basis for a tournament played from late August through Labor Day weekend and that was originally held at the Montpelier High School tennis courts, and

Whereas, the tournament features singles and doubles competition for junior players and these categories plus a mixed players category for adults, and

Whereas, by the middle 1970s, this annual summertime tennis competition had grown to include nearly 100 participants, each of whom was considered a CVTA member, and

Whereas, for several years, the CVTA also hosted the Cho Lee Tournament in Barre as part of that community's Heritage Days in honor of a respected Barre tennis player and court caretaker, and

Whereas, the Barre tournament, and much of the administrative work associated with the CVTA in the 1970s and 1980s, was conducted under the expert auspices of Maria Broggini, the CVTA's first treasurer and a perennial champion in multiple events at the Montpelier tournament, and

Whereas, Maria Broggini's solo efforts kept the tournament alive during its lower participation years during the 1980s, and by the end of that decade, Dana McCarthy had added her invaluable administrative support, and

Whereas, in memory of Maria Broggini, who died from colon cancer in 1999, the CVTA named the Montpelier tournament for her, and the association annually contributes a donation to the People's Health and Wellness Clinic in Barre with the request that the funds help finance colon cancer screenings, and

Whereas, the CVTA has decided not to associate with the United States Tennis Association in order to retain the community-based ambiance of the Montpelier tournament, and

Whereas, 2010 marks the 40th anniversary of the CVTA, and the recently completed refurbishment of the Montpelier High School tennis courts will enable some of the matches to be played at that location, as well as the Montpelier Recreation Field and U-32 High School in East Montpelier, and

Whereas, in commemoration of this special anniversary in the history of this outstanding athletic organization, the CVTA celebrated in grand style on Saturday, September 18, 2010, with a festive event at the Montpelier Recreation Field that included participants from the 1970 tournament, several generations of players using wooden rackets and old style draw sheets, and a display of newspaper articles from throughout the four decades, now therefore be it

Whereas, the National Grange of the Order of Patrons of Husbandry, best known as the Grange, was established on December 4, 1867 in Washington, D.C., as a national agricultural advocacy organization, and

Whereas, a stellar example of a local Grange unit is the Riverside Grange #455 which was organized on December 29, 1910 under the leadership of A.E. Whitcomb with the participation of 41 charter members, and

Whereas, its meetings were held at the Waits River School, and the first Master of Riverside Grange was E.S. Locke, and

Whereas, in 1918, the Riverside Grange voted to send a delegate, Robert Hodge, to the State Grange Conference in Burlington, connecting Riverside Grange members with colleagues from across Vermont, and

Whereas, in 1934, local evening meetings became more readily viable with the installation of electric lights in the Riverside Grange hall, and

Whereas, 1937 was the year Riverside Grange members took to the airwaves, broadcasting a Grange Lecturer's presentation on the radio, and

Whereas, the Riverside Grange conducted neighboring activities in the community and during World War II sent packages to local men stationed overseas, and

Whereas, after many years, in 1952, the East Orange Church became the Riverside Grange's new home and soon thereafter, in 1953, George Richardson led the effort to purchase the "White Rabbit" building as a new grange hall, and

Whereas, the Riverside Grange has won state and national Grange awards and has conducted many charitable fundraising appeals and community service activities, and

Whereas, a new home for the Riverside Grange became a reality with the purchase of the West Topsham School in 1977, and

Whereas, Riverside Grange member and former Representative Kermit Richardson has been honored with election to three National Grange offices, and

Whereas, after a century of fraternal and community service activities, the Riverside Grange looks back on its first 100 years with pride as it anticipates a bright future, now therefore be it
