House concurrent resolution congratulating Michael Smith on his winning the 2011 CVPS-Zetterstrom Environmental Award

Offered by: Representatives Andrews of Rutland City, Courcelle of Rutland City, Fagan of Rutland City, Font-Russell of Rutland City and McNeil of Rutland Town

Whereas, Michael Smith's love affair with Pine Hill Park, and role as a tireless conservationist and motivator of the city's youth, came to pass because of a long neglected gift to the city, and

Whereas, former Rutland City Mayor Henry Carpenter (1908–1910) bequeathed to his hometown a mountain (Pine Hill) "for the recreation and enjoyment of the citizens of Rutland," and

Whereas, as a youngster, Michael Smith, accompanied by his golden retriever, Rembrandt, began a clandestine trail construction project on this largely neglected 300-acre tract, and

Whereas, in 2001, the tract's future and the life of its special guardian were dramatically altered for the better when he successfully organized local recreational enthusiasts in opposition to a proposed road easement intended as the prelude to a housing subdivision on Pine Hill, and

Whereas, with the road and housing proposal scuttled, Michael Smith, with the support of Shelley Lutz; Cindi Wright, Recreation Director of the Rutland City Recreation & Parks Department; Keith Wright; and Tom Vile, initiated an effort to transform the dream of Pine Hill Park into a reality, and in 2008, they formed a nonprofit friends' group, the Pine Hill Partnership, and selected Michael Smith as its president, and

Whereas, Michael Smith recruited a group of eager fifth graders who, with a little help from a GPS unit, found all but one of the tract's survey markers, enabling the first Pine Hill Park map to be published in 2002, and

Whereas, in the following years, Michael Smith has recruited many young persons from school and community organizations to construct trails, including one named in Rembrandt's memory, and he has taught and inspired them, and adult volunteers as well, to appreciate parks and despite his countless hours in the park, he has found time to be an effective grant writer on its behalf, and

Whereas, his leadership of youth in trail development activities is as truly remarkable as his lasting impact on Rutland's landscape, and

Whereas, Michael Smith has been selected, from among 18 nominees, as the recipient of the 2011 CVPS-Zetterstrom Environmental Award which honors an individual who exemplifies the environmental legacy of conservation activist and osprey restorer Meeri Zetterstrom, now therefore be it

Whereas, on September 16, 1761, New Hampshire Governor Benning Wentworth granted a charter for the town of Ludlow in the Black River valley beside the Green Mountains, and

Whereas, not until 1784 when James Whitney arrived from Massachusetts did anyone attempt to establish a permanent settlement in Ludlow, and

Whereas, on March 31, 1792, the first town meeting was held and Jesse Fletcher was elected town clerk, and that same year, the General Assembly transferred 11,739 acres of the original tract to form part of the new town of Mount Holly, and

Whereas, in the early decades of the 19th century, Ludlow was a community of farms and small mills, and

Whereas, on December 21, 1832, a village, similarly named, was incorporated in the central part of the town, and it became a bustling commercial and mercantile center, and

Whereas, a momentous event in the town's academic life occurred on October 23, 1834 when Act 45 incorporating the Black River Academy became law, and among its notable alumni were President Calvin Coolidge; John Garabaldi Sargent, United States Attorney General in the Coolidge administration; Ida Fuller, the first recipient of Social Security; the Vermont historian Abby Hemmenway; and Governor W.W. Stickney who also served as Speaker of the Vermont House of Representatives, and

Whereas, in the 1970s, the Black River Academy building from 1889 to 1939 became the home of the Black River Academy Museum, and

<u>Whereas</u>, by the middle of the 19th century, Ludlow was becoming a major manufacturing center, home to woolen mills, the Ludlow Toy Manufactory, and, for much of the 20th century, General Electric, and

Whereas, Okemo Mountain Resort opened in 1955, eventually spawning vacation residences and many visitor amenities, and

Whereas, 2011 marks the 250th anniversary of the granting of the Ludlow charter, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors the town of Ludlow on its 250th anniversary, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Ludlow town clerk and the Black River Academy Museum and Historical Society.

House concurrent resolution honoring the town of Plymouth on its 250th anniversary

Whereas, on July 6, 1761, New Hampshire Governor Benning Wentworth issued a charter for a new town of "Six and one third Miles square, . . . Beginning at the South West Corner of Reading from thence North Sixty five Degrees," and continuing on as described in the document back to the starting point, and it was named Salt Ash (Saltash), the same as a market town situated near the English town of Plymouth, and

Whereas, on February 22, 1797, the general assembly enacted "An act altering the name of the township of Saltash to that of Plymouth," and

Whereas, the first known settler in Plymouth was John Mudge, and the deed conveying land to him is the oldest document in the land records of the town, and

Whereas, two primary settlements emerged in Plymouth, one being Plymouth Kingdom, whose leadership included Congregational Church Deacon Daniel Clark, who lived to the age of 101, and

Whereas, for much of the 19th century, Plymouth Kingdom was a predominately farming community and included the church, a brick parsonage, a schoolhouse, two blacksmith shops, an inn, and a number of residences, and

Whereas, in the 1830s, an iron ore mine was operated near Plymouth Kingdom on Weaver Hill, and nearby along Buffalo Brook, gold was discovered in the early 1850s, and

Whereas, the other settlement was Plymouth Notch, the birthplace in 1872 of President Calvin Coolidge, and in his home at 2:47 a.m. on August 3, 1923, following news of the death of President Warren Harding, Colonel John Coolidge, administered the presidential oath of office to his son, and

Whereas, the Plymouth Cheese Factory, which Colonel John Coolidge, along with others, established in 1890, continues to operate, and

Whereas, the village of Plymouth Notch is listed on the National Register of Historic Places, has been designated as a National Historic Landmark and as Plymouth Notch Historic District, and is a Vermont state historic site, and

Whereas, in 2011, the idyllic town of Plymouth, home to Camp Plymouth and Coolidge state parks, is observing its 250th anniversary, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors the town of Plymouth on its 250th anniversary, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Plymouth town clerk and the Plymouth Historical Society.

Whereas, the state of Vermont declared its legal existence and independence from Great Britain in January 1777, but many towns in the newly formed state had already been incorporated, and

Whereas, prior to January 1777 and for a number of years thereafter, both New Hampshire and New York claimed political jurisdiction over the territory now consisting of the state of Vermont, resulting in violent disputes over the validity of municipal incorporation charters that New Hampshire's Royal Governor Benning Wentworth was liberally issuing for large fees, and

Whereas, defense of the New Hampshire grants was the catalyst for the formation of Ethan Allen's Green Mountain Boys, and

Whereas, Governor Wentworth granted his first municipal charter on January 3, 1749 for the establishment of the town of Bennington, and

Whereas, aside from the reservation of a large parcel for his personal use, these charters, typically six miles square in size, required that five acres of each grantee's land be cultivated within five years, a directive that not infrequently was ignored, and

Whereas, it was not unusual for many years to pass before a town saw its first settler, who often was not one of the proprietors, and

Whereas, in 2011 the municipalities of Addison, Andover, Arlington, Barnard, Brandon, Bridgewater, Bridport, Brunswick, Castleton, Cavendish,

Clarendon, Cornwall, Danby, Dorset, Fairlee, Ferdinand, Glastenbury, Granby, Guildhall, Guilford, Hartford, Hartland, Killington, Leicester, Ludlow, Maidstone, Manchester, Middlebury, Mount Tabor, New Haven, Norwich, Panton, Pawlet, Peru, Pittsford, Plymouth, Pomfret, Poultney, Reading, Rupert, Rutland (the original encompassing both the current city and the town), Salisbury, Sandgate, Shaftsbury, Sharon, Shoreham, Shrewsbury, Somerset, Springfield, Stockbridge, Strafford, Stratton, Sunderland, Thetford, Tinmouth, Tunbridge, Wallingford, Weathersfield, Wells, Weybridge, Windsor, Winhall, and Woodstock are observing their 250th anniversary of their legal establishment, and

<u>Whereas</u>, many of these communities will hold festive celebrations throughout 2011, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the incorporation of Vermont municipalities marking their 250th anniversary in 2011, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the town clerk of each municipality honored in this resolution.

House concurrent resolution in memory of Karen Ann Quill of Burlington

Whereas, Karen Quill was dedicated to improving the lives of others, both as a registered nurse and as a labor advocate and union official, and

Whereas, she grew up in western Massachusetts and graduated from Westfield High School, and

<u>Whereas</u>, interested in a career as a health care professional, Karen Quill enrolled in the University of Vermont College of Nursing and Health Sciences, and

<u>Whereas</u>, a deep concern for the livelihood and organizational rights of working persons was an intensive focus of Karen Quill's college life, and in 2006, she was among the founders of the University of Vermont chapter of Student Labor Action, and

Whereas, upon graduating from the University of Vermont, she became a surgical intensive care nurse at Fletcher Allen Hospital, and

Whereas, within the organized Vermont health care community, Karen Quill served on the United Professions AFT Vermont board and as Vice

President of the Vermont Federation of Nurses and Health Professionals (VFNHP) as well as the union's grievance chair and chief steward, and

Whereas, she was an active member of the Vermont Workers' Center and an early participant in the Healthcare is a Human Right Campaign as a moving testifier at the 2009 Burlington People's Forum of Healthcare and many other events, and

Whereas, Karen Quill led the VFNHP through the model union process, was actively involved in its committee on political education, and worked tirelessly as an organizer, and

Whereas, her health professional peers recognized Karen Quill as a dedicated advocate for high-quality patient care and safety, and

Whereas, in April 2011, Karen Quill tragically died at age 26, and survivors include her sister, Cathryn, also an intensive care nurse at Fletcher Allen Hospital; her parents, John and Alberta Quill; and a far larger family of nursing colleagues and advocates for working Vermonters and their right to organize, now therefore be it

Whereas, the Rutland Area Visiting Nurse Association & Hospice (RAVNAH) was established in Rutland City in 1946 "to enhance the quality of life of all we serve through comprehensive home and community health services," and

Whereas, in 1967, RAVNAH became Medicare-certified, enabling it to offer much-needed medical support programs not only in Rutland City but throughout Rutland County, and

Whereas, Executive Director Ronald Cioffi and the RAVNAH management team have extensively expanded the menu of medical services offered, and

Whereas, additional specialty services instituted include: Kids on the Move, the only pediatric rehabilitation program within a 60-mile radius; a merger with the Rutland Area Hospice to provide comprehensive hospice and palliative care for terminally ill patients and their families; pediatric hi-tech care; CAIRR, the Coalition for Adult Immunization in the Rutland Region to provide flu and pneumonia vaccines at public clinics; Care Plus, private in-home care to offer support for seniors to continue living independently; long-term care through the Choices for Care program; supportive housing services; community and workplace wellness; telehealth (noninvasive daily health care monitoring via telecommunications technologies); and the maternal child health program, and

Whereas, in 2007, RAVNAH merged with Dorset Nursing Association to expand its services to the Dorset, Rupert, and Pawlet areas, and

Whereas, in 2010, RAVNAH made over 87,000 home visits as it cared for 2,680 patients, and

Whereas, Home Care Elite is the home health industry standard for measuring organizational performance through a detailed performance analysis, and

Whereas, the 2010 Home Care Elite assessment, which evaluated 9,300 similar agencies nationwide, designated RAVNAH as one of the top 500 home health agencies in the United States, the only Vermont agency ranked in the upper five percent, now therefore be it

Whereas, after graduating from high school, he was employed at a hardware store until the economic impact of the Great Depression forced the store's owner to terminate his employment, and

Whereas, enlisting in the federal Civilian Conservation Corps, Warren Patrick assisted in the construction of state parks until a new job opportunity arose at Firestone Tire and Rubber in Hartford, Connecticut, and

Whereas, during World War II, he was employed at Pratt & Whitney, which was manufacturing military aircraft engines, and

Whereas, following the war, Warren Patrick and his wife, who died in 1994, moved to Jamaica where he has resided for over 60 years, and

Whereas, for many years, he constructed seasonal and year-round homes in the Jamaica area, including one he resided in for decades, and

Whereas, by 1957, Warren Patrick was a well respected member of the community who agreed to serve as town clerk and treasurer on an interim basis when a vacancy occurred, and

Whereas, instead of the originally planned few months, he ably served in these dual posts for 11 years, and

Whereas, he has worked locally in the insurance and real estate industry, and

Whereas, at age 97, Warren Patrick remained a man of enormous vigor and posed standing on top of a car for the front page of the Jamaica annual town report issued in 2009, and

Whereas, he has been active in local religious and civic organizations, served as treasurer of the Jamaica Historical Foundation, and is an avid photographer whose photos have been locally displayed, and

Whereas, on June 13, Warren Patrick will joyously celebrate his 100th birthday as will his children, grandchildren, and great-grandchildren, now therefore be it

Whereas, the entire breadth of selectboard minutes and adopted ordinances, and even those proposed that never gained the board's assent, extending back to the 18th century are documents he knows well, and

Whereas, the research methodology Frank Thornton prefers is premised on firsthand observations and not only archival and library-centered investigations, and

Whereas, he has often walked through Charlotte, both alone and as the leader of organized community outings, many under the auspices of the Charlotte Historical Society, identifying older homes, the location of farms, and learning about the individuals associated with these sites, and

Whereas, Frank Thornton researched the history of Charlotte's roads, and his comprehensive findings are compiled in a book which is now kept in the town vault, and

Whereas, on a continuing basis, he has written a series of articles entitled "Looking Back" which have been published in the *Charlotte News*, and

Whereas, among the topics covered in his historical vignettes are shifty brides, discussing the correlation of a woman's marital status and right to own property; poverty in Charlotte, discussing the pauper laws and their impact on Charlotte; and an analysis of 19th-century town warnings ordering the departure from the town of specified individuals, and

Whereas, a desire to serve Charlotte's citizenry in a more contemporary context prompted Frank Thornton to stand for election to the Charlotte selectboard, on which he served with great distinction for many years and was a much-respected member, and

Whereas, in 2010, Frank Thornton concluded his tenure on the selectboard, and on February 23, 2011, a grateful town honored him for his roles as community servant and town historian, and paid tribute to his wife, Mary, who is so much a part of his life, now therefore be it

Whereas, on October 12, 1761, New Hampshire's Governor Benning Wentworth granted a charter to a group of proprietors for the town of Pitt's Ford (later changed to Pittsford), in honor of British Prime Minister William Pitt and in recognition of a ford on Otter Creek, which crosses the granted tract, and the new town's boundaries were described as "Beginning at the northwesterly corner of Rutland,..." and

<u>Whereas</u>, among the earliest, if not the first, settlers were half brothers Gideon and Benjamin Cooley who arrived in 1767 to farm, and

Whereas, the first existing record of a proprietors' meeting dates from 1771 and was held in Pittsford at the home of Ebenezer Hopkins who was elected moderator for the meeting, and

Whereas, in 1780, Fort Vengeance was constructed to protect local residents against British soldiers and in response to recent Indian attacks, and

Whereas, the first successful effort to organize a religious congregation occurred in April 1784 when the Congregationalist Church was established, and a Baptist Church followed soon thereafter; and the first structure to serve as a religious (for the Baptist Church) and secular gathering place was a log meeting house built in 1786, and

Whereas, a few acres that form a triangle in Sugar Hollow are known among native fern enthusiasts as the fern capital east of the Mississippi, and Pittsford summer resident, fern authority, and author, Margaret Slosson, has identified a new variety of beech fern that is named for her, and

Whereas, the marble quarries of Pittsford have long been known near and far as a major resource for a much-sought-after construction material, and the railroad provided a means to transport this natural resource, and

Whereas, Pittsford has been home to iron blast furnaces and the Granger Company's handsomely molded cast iron stoves, abundant sheep farms, and the Vermont State Sanatorium for tuberculosis patients, and it is the location of the ice cave located between Bald and East peaks, and

Whereas, the town of Pittsford will celebrate its 250th anniversary at the annual Pittsford Day festivities on Saturday, June 25, and the Pittsford Historical Society, the Lothrop School, and the Maclure Library, which will host a series of programs highlighting the town's history, will also mark the occasion, now therefore be it

Whereas, with respect to brick and mortar projects, Revitalizing Waterbury is especially proud of its contribution to the beautiful historic restoration of the Stimson & Graves Block in 1992 and the Waterbury railroad station in 2006, and

Whereas, for generations, millions of Americans were denied the housing of their choice because of one of these factors, and

Whereas, despite the United States Supreme Court's prohibition in 1948 of judicial enforcement of restrictive covenants in the case of Shelley v Kraemer, discriminatory housing policies in neighborhoods and even entire communities continued to be legal if privately enforced, and

Whereas, by the middle 1960s, following Congress's passage of both the Civil Rights Act of 1964 and the Voting Rights Act of 1965, housing discrimination remained a barrier in both the rental and sales markets, and

Whereas, the open housing marches that the Rev. Dr. Martin Luther King Jr. led in Chicago in 1966, his assassination on April 4, 1968, and the riots that followed in its wake proved the catalyst that finally persuaded Congress of the necessity to enact federal fair housing legislation, and

Whereas, Congress responded with unusual haste to President Johnson's urgent appeal, and, within days, on April 11, 1968, he signed the Civil Rights Act of 1968, Title VIII of which is known as the Fair Housing Act, and

Whereas, the legislative breakthrough achieved in this act began a process of guaranteeing that individuals could rent or purchase a home without regard to their race, religion, national origin, age, or gender, and, as the act was later amended, disability, and

Whereas, in observance of the signing of the Fair Housing Act of 1968, many jurisdictions are designating April as Fair Housing Month in order both to remember the passage of this historic legislation and to renew the commitment to fair and open housing for all Americans, now therefore be it
